The Town and Country Planning (Local Development) (England) Regulations 2004**

In accordance with Regulation 19 of the Town and Country Planning (Local Development) (England) Regulations 2004, notice is hereby given that the London Borough of Lambeth adopted its Safer Built Environments Supplementary Planning Document (SPD) on the 17<sup>th</sup> of March 2008.

The Safer Built Environments SPD makes available detailed guidance in order to create and maintain safer communities. The SPD sets out the principles of achieving new developments that improve community safety and reduce both the incidence and fear of crime, based upon well established government and other guidance as well as practical experience.

Any person aggrieved by the SPD may apply to the High Court for permission to apply for Judicial Review of the decision to adopt the SPD. Any such application must be made promptly and no later than three months after the date on which the SPD was adopted as stated above.
