- 21 Putting that to one side for the moment, it is for
- you, members of the jury, to make your findings of fact,
- and to choose the words that you use in your verdicts,
- subject only to the points which we set out in the
- 25 written guidance which I gave you yesterday. It's not

- 1 for me to express any preference; it is entirely
- 2 a matter for you. So that, I hope, answers your
- 3 question.
- 4 THE FOREMAN OF THE JURY: Thank you.
- 5 THE CORONER: Anything else that you want me to deal with
- 6 before I ask you to go back this afternoon? Thank you
- 7 very much. Then please if you could return to your jury
