

#### Foreword by the Loughborough Junction Action Group (LJAG)

The Loughborough Junction Action Group, or LJAG, is an independent group of people who live or work in Loughborough Junction in south-east London. We share the common aim of regenerating and improving the area and the lives of the people who live there.

We are embedded in our diverse and vibrant neighbourhood and hold festivals, street parties and monthly gatherings, literary and film events and organise arts activities in local schools. Our members work with many local organisations, such as tenants' and residents' associations, community initiatives such as Building Communities in Coldharbour and the Big Local, which are working on projects designed to empower local people, improve community cohesion and enhance neighbourhood facilities.

#### **Executive Summary**

Loughborough Junction is a vibrant and important place. To continue improving its physical environment, Loughborough Junction needs ideas that can stimulate and guide its development.

This report was commissioned by the Loughborough Junction Action Group (LJAG) and the London Borough of Lambeth to define a **Public Realm Plan** for the future identity of Loughborough Junction, developed in close dialogue with the local community.

The Plan has sought to define the unique existing qualities of the area that should be protected and enhanced in any future development, consolidating previous community investment. The report has also set out to identify opportunities for the locally-determined future prosperity of the neighbourhood, which prioritises people over traffic, and places over roads. The Plan seeks to enhance connectivity for pedestrians and cyclists; provides high-quality community spaces distributed around the Junction, and sets out ambitions for the emerging identities of a series of 'yards', which can help to build a sense of local place and opportunity. This has been achieved by working at three scales:

- 1. To consolidate the shared **CENTRE** of Loughborough Junction to provide a catalyst for the whole community.
- 2. To establish priorities for improvements to **CONNECT** the individual neighbourhoods to the centre of Loughborough Junction with enhanced lighting, paving and greening strategies.
- 3. To identify a series of **GATEWAY PROJECTS**, which are embedded in the heart of smaller neighbourhoods, to help build local pride and ownership.

The process for developing the Plan began with the following questions:

#### What are Loughborough Junction's best qualities?

What physical challenges does the area need to address? Which areas represent opportunities for improvement? How can these improvements take place?

The following pages address these issues and demonstrate a way in which they may be answered.

#### What is the Loughborough Junction Plan?

The Loughborough Junction Plan has been developed to:

- Provide a record of the views of those who live, work and play in the area
- Identify the main challenges and opportunities for Loughborough Junction
- Create a vision for Loughborough Junction that will regenerate the area without diluting the existing characteristics that define it as a 'place' with a distinct community.
- Propose a plan that will allow LJAG and Lambeth Council to bring forward improvements as and when funding is available and to allow private investment to be targeted.
- Provide suggestions for specific public realm enhancements that can be realised as 'quick wins' with funding that is available immediately.

#### How can real improvement take place?

The Loughborough Junction Plan provides suggestions for improvements to the physical environment. None of the projects have been developed in detail. Each project identified in the Plan will require detailed consultation, design development and funding. Most importantly each project will require the support of the community to define its successful outcome.

#### How have the ideas been informed by people in Loughborough Junction?

The final proposals for the Loughborough Junction Plan have been informed by a series of public consultations over an eight month period from October 2012 to May 2013. The schedule of consultation events is included in section 1.9 of this document and analysis of the feedback is recorded in section 6.0.

#### What was the process for developing the Loughborough Junction Plan?

#### Step 1 - Analysis

A significant amount of consultation has taken place in Loughborough Junction in recent years. The first task was to assimilate this information and carry out objective analysis of the current condition of Loughborough Junction's public realm.

#### Step 2 - Listen

Consultation as noted above was carried out and people's concerns and desires were recorded and analysed.

#### Step 3 - Identify key issues

Using the analysis and what people wanted 7 key areas for improvement were identified as follows:

#### IDENTITY • SAFETY • QUALITY • GREEN SPACE • CONNECTIONS • EMPLOYMENT • COMMUNITY

#### Step 4 - Develop a Plan to tackle the issues

A set of principles to tackle each of the key issues in the short-term, mid-term and long-term was developed as a guide to assist the overall improvement of Loughborough Junction.

#### Step 5 - Offer a 'Project Bank'

Opportunity areas in Loughborough Junction were identified and added to a Project Bank to provide a list of future work that could be carried out to improve the immediate and wider area.

#### Step 6 - Demonstrate how development could take place

Section 5.0 of this document offers a way forward for the implementation of the Plan. This includes the development of a strategy for engaging local businesses and stakeholders in order to attract private funding.

#### Step 7 - Prove that the Plan can work

Even before the completion of the Plan, a public realm improvement scheme for Cambria Road was identified as a pilot project. Work has begun on site and will include enhanced paving, lighting, tree planting and works beneath the Cambria Road railway bridge.

It is anticipated that this will be the first of many projects to be implemented with the aim of enhancing the whole Loughborough Junction Area.





## 1.0 Introduction





#### 1.1 Introduction

DSDHA were commissioned by the London Borough of Lambeth in September 2012 to develop a Public Realm Plan in collaboration with the Loughborough Junction Action Group (LJAG) and local residents.

Lambeth Council have acted as the fund holders of the project but are essentially acting on behalf of the local community in the role of facilitator.

The Plan will herald significant change for Loughborough Junction and is intended to be a comprehensive, long-range plan to guide the regeneration of the area, capturing the aspirations and intentions that people have to the future of Loughborough Junction.

The Loughborough Junction Plan is a community-led project and in keeping with this, has sought to preserve community character at its core.

#### 1.2 Background

The Loughborough Junction area in south east London sits between the better-known neighbourhoods of Brixton, Camberwell and Herne Hill. It is named after a railway station on First Capital Connect's Wimbledon and Sutton loop line which runs across central London to Bedford via Farringdon and St Pancras. The station is accessed over a million times each year.

The area is defined by its high level railway lines, railway arches and the many railway bridges which intersect it.

The potential of the area was noted by the architectural writer Ian Nairn in his 1966 book Nairn's London:

"No performance so far but tremendous promise. The place is a busy road junction in the centre of a triangle of high level railway lines. Each road has a bridge a few yards along it. This unique signature could so easily be an enrichment instead of an embarrassment, the bridges accentuated and dramatised instead of disregarded. It is a natural centre, so that there would be no fear of tickling up an artificial relationship".

#### 1.3 The Opportunity

The development of this Plan has provided an exciting opportunity to identify options for improving Loughborough Junction's public spaces.

A new area-specific policy for Loughborough Junction is needed for the emerging Lambeth Local Plan. This Local Plan will be the first time that Loughborough Junction is identified as a location in its own right and has allowed the development of strategies that are specific to the unique characteristics of the area.

This Plan provides informal planning guidance for the Loughborough Junction area. It has not been through the statutory planning process, but is the result of extensive local consultation and is generally consistent with the Lambeth Core Strategy and the emerging Lambeth Local Plan, and as such may be a material planning consideration in the assessment of planning applications in the area.

#### 1.4 Purpose of the Plan

This Plan has been co-produced with LJAG for Lambeth Council and is intended to be a living document that identifies a bank of projects and partners for delivery over a sustained timescale.

The Plan considers the community as a key delivery agent, assisted by partner organisations.

It is intended that the document is owned by the local community and ensures that the delivery aspect is not wholly dependent upon the Council for funding, i.e. provides an opportunity for the local community to engage other organisations outside of the Council for funding.

#### 1.5 Our Objectives

At the project's outset, the Steering Group, comprised of representatives of Lambeth Council, the Loughborough Junction Action Group (LJAG), other local community groups, tenants, residents associations and representatives of the business community established a set of objectives for the project:

- Reflect the vibrant community in Loughborough Junction.
- Engagement of the widest possible section of the community in the development of the masterplan.
- Build Identity 'Loughborough Junction' should be clear when you arrive. You should know that you are in Loughborough Junction.
- Get rid of association of Loughborough Junction as a 'second-class' neighbourhood to Brixton.
- Draw the wider population of Loughborough Junction into the centre.
- Prioritise business and employment opportunities.
- Push the boundaries ideologically.
- Realise potential value of the railway network.
   Future development to allow extension of London Overground.
- Success of schemes detailed in the masterplan should be measureable.

#### 1.6 Partners

The resources for implementing the Plan will come from a variety of sources and will involve working in partnership with local and regional government, housing providers, Network Rail and private developers.

The Plan will initially guide public realm improvements, which Lambeth Council has undertaken to provide. Some £800,000 of funding has been allocated for the 2014-15 financial year.

The Plan also seeks to unlock development opportunities from private developers who will be expected to work with the community and the Plan proposals in submitting any planning application.



#### 1.7 Related projects

This Plan has been developed in the context of a number of previous and ongoing local projects that have been established by LJAG and other local organisations, which aim to enhance the experience for people living and working in Loughborough Junction. The Plan builds on these existing projects which have been extensively consulted upon and are widely supported by the local community.

#### Seven Bridges Project

Loughborough Junction's railway bridges are a historic reminder of the changes which the arrival of the railways brought to London's inner suburbs. With six railways bridges visible from the junction of Coldharbour Lane and Loughborough Road, Loughborough Junction has a unique townscape and it is this townscape which the 7 Bridges project seeks to build upon. The aim of the project is to enhance the bridges with colour, light and art so that they become the area's defining feature.

#### Greening/Gardening

LJAG are improving the way Loughborough Junction looks while also giving local people and shopkeepers a sense of ownership. LJAG have held greening days and are supported by Lambeth Community Freshview. The aim is to significantly increase the amount of greenery – ie plants and trees – in Loughborough Junction.

#### The Loughborough Farm

The Loughborough Farm is a new community initiative led by LJAG and actively supported by Councillor Matt Parr and with invaluable advice from the Myatts Field Park Project. The project seeks to find spare pieces of land within the Loughborough Junction area to grow food for local consumption and sale; the project to provide volunteering, training and eventually employment opportunities. The first growing space is a spare piece of land belonging to Lambeth Living on Minet Road and access to the site is currently being negotiated.

#### Transport Campaign

LJAG is actively involved in campaigning for improved transport services for Loughborough Junction.

The opening of the franchise negotiations for the Thameslink route, which runs through Loughborough

Junction, provided an opportunity to lobby the Department for Transport on Network's Rail's proposal to terminate all trains on the Wimbledon/Sutton loop line at Blackfriars. A successful leafleting campaign was launched and over 1,500 signatures were collected. Other ongoing campaigns include highlighting the need for a lift at Loughborough Junction station, which is currently inaccessible to many, and for a stop at Loughborough Junction on the new Overground service. There is currently no stop between Denmark Hill and Clapham High Street.

#### We are Loughborough Junction

We are Loughborough Junction was an innovative outdoor photographic project, organised by local people and sponsored by LJAG and the SE5 Forum with local photographer Conor Masterson, which was held in February 2010. The previous summer Conor held photographic sessions in Ruskin Park when local people, from all walks of life, were invited to have their photographs taken.

The portraits were posted on walls, buildings and estate agents-type boards during the weekend of the exhibition with the intention to build a sense of identity for Loughborough Junction and its diverse community.

#### **Building Communities in Coldharbour**

Building Communities in Coldharbour is a project of The London Community Foundation, which has a particular focus on the Loughborough Junction area in Coldharbour. The aim of the project is to support residents to find solutions to local issues and to bring investment to the area for the benefit of the whole community.

Following consultation, the "Loughborough Speaks" report was published in 2011 containing information to help develop an accurate picture of the people and families living in the area, to learn more about what they think of their neighbourhood and their quality of life, and help attract further investment and funding.



#### 1.8 Improvements To Date

#### Cambria Bridge

With funding from Awards for All, LJAG embarked on a pilot project on the bridge over the Cambria Road. This is still a work in progress but in July 2012 six beautiful mosaics were mounted on the bridge. The mosaic artist Tamara Froud worked with students from three local schools: Jessop, St Saviour's and Michael Tippett, who were inspired by the fossils laid down in the Cambrian explosion, an era when there was an explosion of life forms. Further artworks have been commissioned and others are in the pipeline to be commissioned. A disappointment has been the inability to engage profitably with Network Rail to get this very small bridge painted, to date.

LJAG was thrilled that as a result of their work on the Cambria bridge, Lambeth Council chose the Cambria Road as a site for major road and pavement improvements. The road is part of one of Lambeth's proposed Green Routes; cycling and walking routes which link green spaces throughout the borough. In this case, a route is planned from Ruskin Park, through Elam Gardens Open Space, Myatts Fields Park, Kennington Park and finally Archbishop's Park.

The plans for the Cambria Road include new tree planting, raised tables at junctions, and new bollards at the entrance to the bridge and new paving and lighting under the bridge. Part of the project is being implemented in May 2013 but some works have to be phased as a result of UK Power Networks' plan to demolish a number of buildings on its Cambria Road site. No other access could be secured and with demolition lorries using the road there is the risk of damage to the new road and pavement surfaces.

#### Mural

At the junction of Coldharbour Lane and Loughborough Road, LJAG commissioned, with funding from Lambeth Council, a mural from Polish artist Jola Kudela. Her photomontage murals involve taking an old master painting and superimposing local people onto the painting to bring it up to date.

For Loughborough Junction she chose Ford Madox Brown's painting 'Work', a painting of a road being

dug up that is a social satire on the Victorian class structure. Kudela's up-dated version included a wide selection of well-known Loughborough Junction inhabitants including our councillor Rachel Heywood. Unfortunately the site chosen for the mural turned out to be much more exposed to the weather than expected and a heavy rain storm soon after it was erected, and before the glue had had time to properly dry, destroyed this beautiful and imposing work within days. LJAG is currently working with the artist on an alternative method of mounting the mural and hope to find a way of bringing it safely back to the junction soon.

#### **Community Greening**

LJAG voluntarily maintains the green space by the bill boards at the junction of Coldharbour Lane and Loughborough Road and the planters along Coldharbour Lane and by the Cambria bridge. A number of the shop keepers are now watering the planters during the summer. LJAG has worked with Lambeth Freshview and Lambeth Streetcare to improve the small pedestrian street Station Avenue. Beds have been built around the tree bases and these have now been planted with evergreen shrubs and Lambeth Streetcare has changed the dustbins. This has made a significant difference to the street and the fly-tipping problem, which regularly turned the street into an eyesore, has improved.

#### The Neighbourhood Enhancement Programme (NEP)

Lambeth Council's Neighbourhood Enhancement
Programme will bring major public realm investment
to a large area of north and central Lambeth including
parts of Loughborough Junction. LJAG participated in
a wide-ranging consultation event in Millbrook Road,
on the edge of the Loughborough Estate at the end of
April

- Eliminate the association of Loughborough Junction as a 'second-class' neighbourhood to Brixton and Camberwell.


#### **Local Opportunities**

- Prioritise business and employment opportunities.
- Create affordable workspaces.
- Support local businesses.
- Enhance green space and leisure amenities.
- Realise potential value of the railway network.
- Revitalise the high street through improved lighting, paving and greening.

#### **Local Community**

- Engage the widest possible section of the community.
- Draw the wider population of Loughborough Junction into the centre.
- Create new public spaces for community enjoyment that feel safe and that are not dominated by traffic.
- Build on the existing 'community infrastructure' with improved community centres and hub.
- Improve accessibility, especially for old people large areas of pavement are currently inaccessible, there are no benches and the station does not have a lift to the platform.





## 2.0 Site Context



#### 2.1 Site Area

Loughborough Junction is in the London Borough of Lambeth but sits close to the boundary with Southwark. As an outlying area without a well-defined centre, it has historically suffered from a lack of investment from local, regional and national government and private investors.

The study area for the Loughborough Junction Plan is bounded by Lilford Road to the north; Max Roach Park and Wiltshire Road to the west; Lowden Road to the south, and Ruskin Park to the east.

In reality, the area is experienced mostly by passing through between the more legible neighbouring destinations of Camberwell, Herne Hill and Brixton.







2.0 Site Context



The area is dominated by a number of large estates of social housing: the Loughborough Estate, a late 1950s estate of medium and low rise blocks and Old Loughborough, an inter-war former LCC deck access estate, containing over 1,200 units; the Hertford Estate, a 1980s low-rise central access estate; the Thorlands estate, a 1950s and 1980's low rise estate; the Lilford Estate, another inter-war former LCC deck access estate; and the Milkwood Estate, containing a renovated estate of small Victorian terrace houses.

Off Coldharbour Lane, east of the station there are streets of mainly privately-owned Victorian and Edwardian terrace houses, many of which are now divided into flats and both owner-occupied and privately rented.

The oldest houses dating from the 1840s are in the Loughborough Park Conservation area where there is a mix of social and owner-occupied houses and converted flats.

There has been significant infill development in the last 10 years including new social housing on former railway sidings off Shakespeare and Milkwood Roads, and Styles Gardens as well as backland development at Redwing Mews and a significant new development at 120 Coldharbour Lane, which consists of 108 dwellings.


The process of converting single family dwellings into a number of flats has recently been halted with a new planning constraint "streets under conversion stress" applied to much of the area.

As a result of the large estates, there are a number of residents' and tenants' groups and well as friends' groups in Loughborough Junction, all of which share the aspiration to see improvements in the local area.

The Plan seeks to build on the existing initiatives that have been developed by these groups in order to ensure local ownership of the proposals.

All groups should be consulted in the development of subsequent proposals for the Loughborough Junction area.



#### 2.3 The Wider Area

Loughborough Junction is surrounded by areas of major strategic public and private investment, namely Vauxhall and Nine Elms, Elephant and Castle, and London Bridge. Loughborough Junction is also surrounded by areas of significant and recent GLA investment, including via the Mayor's Regeneration Fund and Outer London Fund (see map below).

In terms of Transport Infrastructure Investment, the East London Line Extension has stops at Denmark Hill and Clapham but not at Loughborough Junction. The Loughborough Junction area has therefore been overlooked until now.




Fig. 6. The LCDE and SEE approaches to City and West End: ownership of lines through Brixton and Denmark Hill shown as built. On completion the northern pair were taken over by the LCDE and the southern by the LESCE. 1, Blackfriam Goods. 2, Southwark continental depot. 3, Ever Street locomotive depot. 4, Cannon Street locomotive depot. 5, West Street junction. 6, ONE coal depot. 7, Midland coal depot.

#### 2.4 Historic Context

The historic development of Loughborough Junction has been unquestionably defined by the construction of the railways.

In the 1860s the London, Chatham and Dover Railway (LCDR) opened its City Branch to central London. The line remains in use and since 1990 has been part of the Thameslink route. A second east-west line was also built from Peckham Rye towards Victoria and Clapham Junction. The two were connected by north-to-east and north-to-west curves which gave Loughborough Junction its name.

In October 1864 the LCDR opened Loughborough Road station on the north-to-west Brixton spur which connects the City Branch to the Inner South London Line near Brixton station. On 1 December 1872 platforms were opened on the City branch and on the north-to-east spur (called the Cambria Road platforms and spur after nearby Cambria Road). The enlarged station was renamed Loughborough Junction. The Loughborough Road platforms closed permanently on 14 March 1916 as a wartime economy measure, and by 1916 all LCDR City branch stations south of the Thames had been closed except Loughborough Junction. Rationalisation of services in the Southern Railway's suburban electrification led to the closure of the Cambria platforms on 12 July 1925.

Since their construction, the layout of the railways have been the defining characteristic of Loughborough Junction's morphology.

#### 2.5 The Railways - Ownership & Operation

The centre of Loughborough Junction is defined by 6 bridges, visible at the junction of Coldharbour Lane and Loughborough Road and a further three bridges (identified in section 3.2) lie in close proximity to Loughborough Junction Station.

The regeneration of the railway arches is of fundamental importance to the Plan, meaning that Network Rail are a key partner in its delivery.

The extent of Network Rail's ownership is shown on the adjacent plan, highlighting the importance of a collaborative approach to the regeneration of the area.


The station at Loughborough Junction is managed by First Capital Connect, who are responsible for the staffing and operation of the station building.

The extension of the London Overground Network to include stations at Denmark Hill and Clapham High Street has bought additional trains through the Loughborough Junction area, however, the station in Clapham is the only place on the Overground network in Lambeth where trains stop. The East Brixton station, near Coldharbour Lane, closed in 1976.



#### 2.6 Ward Boundaries

The boundary between the wards of Coldharbour and Herne Hill runs along the north-south branch of the railway network, through the centre of the Junction.

Both wards also share a boundary with the London Borough of Southwark.

The ward boundaries, together with the areas location on the edge of Lambeth have historically led to a lack of investment in Loughborough Junction at a local level and also the sense that it is a place between other more established places.

#### 2.7 Conservation Areas

Within the Loughborough Junction area there are two designated conservation areas - the Loughborough Park Conservation Area, near the heart of the Junction, and the Minet Estate Conservation Area, to the north of the Junction.

#### Loughborough Park Conservation Area

The Loughborough Park conservation area includes Shakespeare Road, the east side of Moorland Road as well as Loughborough Park itself, and also the associated area fronting on to Coldharbour Lane.

#### Minet Estate Conservation Area

The Minet Estate is a successful example of a number of private housing estates which were built in the second half of the nineteenth century. Following the expansion of the railway services in South London, large numbers of people with modest incomes were attracted to live south of the river and work in Central London. This particular estate is historically connected with the Metropolitan extension of the London, Chatham and Dover Railway Company which was opened in 1863. The Estate is a very good example of "self sufficient" suburban developments of that period. Apart from a wide variety of house-types, it also provided schools, a community hall; a library which has been rebuilt after destruction during world war 2; a park with sports facilities; a number of churches, three of which still survive; shops and other amenities.

#### 2.8 Planning Policies

Lambeth's development plan comprises the Lambeth Core Strategy 2011, Saved UDP Policies 2007 and the Mayor's London Plan.

Lambeth is currently reviewing the Core Strategy and development management policies to provide a new, up-to-date Lambeth Local Plan. The Draft Lambeth Local Plan was approved for consultation in February 2013 and includes an area-specific policy to support regeneration in Loughborough Junction (Policy PN10). Lambeth aims to adopt the Local Plan in early 2015, with the Plan supporting growth and improvements to quality of life across the borough.

Key Lambeth planning policies include:

- strong support for new housing and affordable housing across the borough;
- designation of Loughborough Junction as a Local Town Centre where a mix of retail uses will be protected and encouraged;
- supporting Lambeth's economy through the protection of employment uses in Key Industrial and Business Areas (KIBA) of which there are several in the Loughborough Junction area;
- safeguarding waste management and transfer sites as required by the London Plan .







Pride in Loughhorough Junction

Through significant consultation with the community, a list of 7 priorities for the Plan has been established. These priorities have been used to establish the Vision for Loughborough Junction.

In order to realise this vision, the Plan seeks to enhance connectivity for pedestrians and cyclists; provide high-quality community spaces distributed around the Junction, and sets out ambitions for the emerging identities of a series of 'yards', which can help to build a sense of local place and opportunity. The Plan has been developed by working at three scales illustrated on the following pages:

- 1. LOUGHBOROUGH YARDS: To consolidate the shared centre of Loughborough Junction to provide a catalyst for the whole community.
- 2. CONNECTIONS: To establish priorities for improvements to connect the individual neighbourhoods to the centre of Loughborough Junction with enhanced lighting, paving and greening strategies.
- 3. GATEWAY PROJECTS: To identify a series of opportunities which are embedded in the heart of smaller neighbourhoods, to help build local pride and ownership.

The individual projects within these categories are expanded upon in the 'Project Bank' (section 4.0).

The adjacent page provides an overview of the Vision for Loughborough Junction, comprised of:

- Seven proposed 'Yards' located in the centre of the Junction to consolidate two existing yards.
- Nine 'Gateway Projects' located within residential areas throughout the Junction.
- Seven enhanced routes or new connections. These are intended to promote links between schools, cultural facilities, community facilities and green spaces.
- Four green space projects to enhance and promote greater use of existing green space.
- Opportunities for development or refurbishment of existing sites.





## 3.2 Loughborough Yards

#### Loughborough Yards

Loughborough Junction's railway network has given the area a unique urban grain, comprised of yards, bridges and passageways. The Plan proposes to consolidate and expand upon this character to create a strong identity in the centre of the Junction, which can become a catalyst for the regeneration of the wider area.

Seven core projects - the 'Loughborough Yards' - are outlined, each containing a run of railway arches and at least one development opportunity.

These core projects consolidate the two existing yards in the area to target improved public realm, lighting, accessibility, greening, safety and local prosperity through the promotion of work and community spaces in the heart of the area.

The grouping of the improvement works into seven core projects is intended to offer multiple ways in which redevelopment can be bought forward by Lambeth Council or by private funding. For example, the yard can be developed as whole project, or the lighting across all yards can be prioritised.

The designation of yards is also intended to provide a mechanism for Network Rail to bring forward the refurbishment of sections of arches in conjunction with Lambeth Council, who might carry out surrounding public realm improvements concurrently.




Within each yard project, consideration has been given to the following:

- Community opportunities for community uses and access to community services for all







The development of the yard projects is intended to build upon the existing character of Loughborough Junction's central area.

A number of existing local businesses already promote a yard culture, including Sunshine International Arts, accessed from Coldharbour Lane, and the Whirled Arts building and Miguel's Boxing Gym, accessed from Hardess Street.

Through the creation of seven additional yards, a business culture is allowed to develop, promoting local prosperity and local management of assets.

## 3.3 Gateway Projects

#### **Gateway Projects**

The Loughborough Yards in the centre of Loughborough Junction are complemented by a series of 'Gateway Projects', which are embedded in the residential areas on the fringes of Loughborough Junction.

These will act to build identity within the community, activate the key routes into Loughborough Junction and to tie the different neighbourhoods together through shared community facilities.

These projects will specifically target the creation, refurbishment and enhancement of community facilities and public realm. Opportunities for training and education will also be created through these projects.

The sites of the Gateway Projects range from existing public amenities and spaces that provide an opportunity for improvement, to buildings sites that are likely to be available for development in the future, such as the Lambeth-owned property on Wanless Street and the Herne Hill petrol station.

These sites have been identified so that future development can be geared towards the benefit of the community.

#### **Routes & Connections**

The railway network in Loughborough Junction has contributed to the severance of communities. Due to known criminal and licentious activities, routes through the arches have been boarded up, further reducing permeability throughout the Junction.

To target this issue, key routes and connections have been identified to connect the local schools, cultural facilities and community amenities, as well as connecting Loughborough Junction to the surrounding areas of Brixton, Camberwell and Herne Hill.

These routes will be improved through greening, lighting, paving and general enhancements to the public realm.

It is proposed that these designated routes form the basis for a Loughborough Junction-wide cycle network.



The adjacent photos show some of the problems currently experienced along Loughborough Junction's key routes, as well as providing suggestions for how improvements could be made.

The railway arches and associated yard spaces have the potential to connect different areas of the junction, often close to parks and green spaces.

Along with the many railway bridges, the arches present an additional opportunities for improved safety, which must be addressed through better lighting.

The seven routes identified through Loughborough Junction will further provide the opportunity for improved lighting, along with the planting and paving design to promote safer and more enjoyable journeys for pedestrians and cyclist travelling from school to home or to the local community centre.

Additional new routes and connections will become possible through the development of the Yard projects.



## 3.5 Green Space Projects

#### **Green Space Projects**

Loughborough Junction has several key green spaces, but these are often under utilised, poorly maintained, locations of antisocial behaviour and places that are avoided by many members of the community, especially at night time. These green spaces are identified for improvement as part of the Plan.

The existing green spaces are key to the improvement of routes and connections throughout the junction. They also provide much-needed green space for residents who do not have access to private gardens.

Inevitable development within the Loughborough Junction area will place existing green spaces under additional pressure. Individual plans should be coproduced with the community to target the spending of future funding towards long-term objectives for these spaces.

The Plan provides outline objectives for these green spaces.

#### Wyck Gardens

Wyck Gardens is the closest public green space for wany residents of the Loughborough Estate. It hosts several community facilities such as a playground, sports pitch and the Ebony Horse Club.

The placement of these facilities within the park has not always considered the long-term use of the park. Wyck Gardens provide a key connection between Loughborough Junction and Brixton. Future spending should consider the following:

- Improvements to the boundary with Ridgway Road to promote this as a green route/cycling route.
- Lighting to paths to improve safety.
- Extended routes from the junction to Brixton Road.
- The future conversion of the Caribbean cafe into a community facility in the park.

Loughborough Park is designated as part of the Loughborough Park Conservation Area. It is bounded by houses, so offers no opportunity for connection. It features many mature trees and should be regarded as a high-quality green space, having recently received investment in the region of £75,000. However, it has suffered from poor maintenance and neglect in the past, which remains evident.

#### Elam Street Open Space (Elam Gardens)



Elam Gardens provides the key green space at the north of the Junction. It is bounded to the east by railway arches. The refurbishment of these could provide a positive elevation to the park, which is not currently well overlooked. Future investment should consider:

- Maintenance of existing facilities, such as the Fitness Trail
- Improvements to the boundary with the arches to make this a more positive relationship.
- Potential to create connections with the Minet Estate to the north and the community facilities (Michael Lipton Centre and Grove Adventure Playground) to the south.
- Potential for safe walking and cycling routes through the park.

#### Milkwood Community Park



Milkwood Community Park is one of Lambeth Council's nine Green Flag Award sites. As well as landscaped areas and new fencing, it contains a children's playground, ball games court, seating, shelters and areas for wildlife, play and social interaction. Milkwood Community Park provides local residents, schoolchildren, youth and visitors alike with a safe and welcoming place to escape the demands of urban life.

Since 2003 Milkwood Residents' Association, Lambeth Council, London & Quadrant Housing Association and community consultants have been working in close partnership to secure significant inward investment in order to regenerate the Park. Similar partnerships would benefit Loughborough Junctions other green spaces.











## Loughborough Yards



The Station Yard has the potential to become the key civic space in the centre of Loughborough Junction and, as such, should embody the area's identity.

#### **Existing Character**

Characterised by low-quality buildings, advertising signage and street clutter. The existing shops do not contribute positively to the street scape and are poorly maintained.

The pavement is wide enough to provide generous room for pedestrians, but is currently used for informal parking, which can not currently be prohibited due to the patchwork of land ownership.


The street scape features a number of different types of signage (including community notice boards, advertising boards, way finding), a variety of bollards and street furniture and a number of paving types. As such it does not provide a legible public realm for people arriving in the Junction by train.

#### Objectives


- Provide a high-quality public realm in the centre of the Junction that embodies the identity of Loughborough Junction.
- Provide a place for people to meet and congregate.
- Provide legible signage to the station and Loughborough Junction's surrounding amenities.
- Improve accessibility to the station building

- Improve safety for cyclists and to provide sufficient space for securing bicycles outside the station.



Wickwood Yard lies to the west of the station and is the largest of the proposed yards. The development of the yard would allow better connections between Loughborough Junction's green spaces.

#### **Existing Character**

The yard currently operates as a series of separate zones that have the potential to be connected through opening up the arches.

Rathgar Road, to the south of the yard, is occupied largely by car garages. It is regarded as a criminal hot spot and has been raided by police on a number of occasions. Station Avenue, which connects to Rathgar Road, provides a better quality street scape, but is under used because no through route is currently possible.

To the north, the existing arches on Wickwood Street are occupied by more industrial uses and car breakers. There is no pedestrian or vehicular route through the yard, making it intimidating.


The site is a designated KIBA and there is safeguarded waste management use in Arch 439.







Belinda Yard is sandwiched between two stretches of railway arches, accessed by either Belinda Road or Ridgway Road. It is the western most yard, and has the potential to promote stronger pedestrian and cycle routes to Brixton.

#### **Existing Character**

A large part of Belinda Road is currently a safeguarded Waste Site. Under Lambeth planning policy the waste management capacity must either be replaced on the site, or re-provided elsewhere in the borough if the site is redeveloped. As such, Belinda Road As such, Belinda Road has an industrial feel. It is regarded as a criminal hot spot and has been raided by police on a number of occasions.


To the north, the arches face onto Ridgway Road and Wyck Gardens. This relationship with the park is not currently celebrated, and the arches are seen as having a negative impact on safety in the park.





Green Man Yard occupies a key site in the centre of the Junction. It contains a small number of arches, which separate it from the neighbouring Shakespeare Business Centre.

The building is soon to be handed over to a private sector operator, who will maintain the building as a training centre.





Higgs Yard occupies a large central section of the junction. The yard is divided by both a north-south and east-west stretch of railway arches.

The yard currently operates as a series of smaller yards. The Sunshine International Arts cafe provides a model for the development of future yards, showing how these can be both a community amenity and successful independent business.


To the east of the railway arches, larger industrial spaces are occupied by a variety of tenants, including a church that fronts onto Coldharbour Lane. The buildings are window-less at ground floor level and do not contribute positively to the street. The site provides huge development potential, so it is essential to define the mix of uses that could occupy this site.



4.1.5 Higgs Yard





Padfield Yard is bounded to the north by Coldharbour Lane; to the west by Herne Hill Road, and to the east and south by Padfield Road. As such is has both residential, industrial and commercial characteristics.

#### **Existing Character**

The character of Padfield Road is defined by the colourful signage of the MOT garages on Herne Hill Road. A former pub on the corner of Padfield Road and Coldharbour Lane is soon to open as a supermarket.

Padfield Road is a well-used cut-through between Herne Hill Road and Coldharbour Lane, which is reported as having a detrimental impact on the residential amenities.


A industrial site occupies a large proportion of Padfield Road on the west of the arches, which is a prime site for future development.

- Improve highways around the yard to manage the use of Padfield Road as a cut-through.

Cambria Yard is a small yard, accessed predominantly from Cambria Road. It has the potential to be a positive presence on the street, adjacent to the Cambria Road bridge and opposite the UK Power Networks site, which is a designated KIBA and likely to be developed in the future.

#### **Existing Character**

The yard is small in scale and residential in character. The yard offers potential to provide a connection through to Padfield Road, where a low-quality taxi shelter occupies an infill site between two stretches of railway arches.


The yard connects at the south to Wanless Road, which provides access to a collection of Lambeth-owned buildings that accommodate the Council's Public Health & Pest Control and Stray Animals & Pests facilities. This site is a safeguarded waste site.



Consultation on the Cambria Road improvements, October 2012

Cambria Road has been identified as an ideal pilot project for the Plan. Of Loughborough Junction's nine bridges, it is the only one blocked off from traffic. As a pedestrian route it was regarded as a dark, forbidding and dismal tunnel, but a crucial link between the heart of the Junction and Ruskin Park.

As part of the 7 Bridges Project, the installation of artworks beneath the bridge has already commenced, with a series of fossil inspired mosaics by the artist Tamara Froud.

Cambria Road has now been designated as a green link - part of a wider network of connected routes in Lambeth.

The proposed improvements were consulted upon as part of the wider consultation for the Plan.

Work has now commenced to improve the public realm and highways, including raised tables at junctions; a cycle route; improved lighting; tree planting; SUDS, and feature lighting beneath the bridge.



Through consultation, two underused spaces adjacent to the Hero of Switzerland pub have been identified as important public spaces close to the Loughborough Estate.

The two spaces are separated by Loughborough Road, but have the potential to be enhanced through a scheme of hard and soft landscaping to create positive settings for community activities.

The space on Loughborough Road is already used by LJAG to host community events, such as the Big Lunch, but is also frequently used for parking. Recycling and refuse bins on the edge of the space reduce visual permeability and attract waste to collect on the corner of the site.

Through the relocation of parking and recycling facilities, the space could hold an expanded programme of community activities.

The existing housing block on the site has also been identified as a potential development opportunity.








#### 4.2.3 Marcus Lipton Centre

The Marcus Lipton Youth Centre and the Grove Adventure Playground are located on adjacent sites on Gordon Grove and Minet Road. Both are in need of refurbishment and improved management.

The Marcus Lipton Centre serves an important local need, but is under used by the wider community. Improvement to both its external sports pitch and internal facilities are required to realise the potential of this community building.

# Routes & Connections



#### 4.3 Routes & Connections

The Plan identifies seven key routes or connections for Loughborough Junction. These are intended to link schools, community facilities, green spaces and cultural amenities.

The routes are also intended to connect Loughborough Junction to its wider context - Brixton, Camberwell and Herne Hill.

Additional micro routes are also created or enhanced through the Yards, Gateway and green space projects.

Outline routes are proposed, which form the basis for a Loughborough Junction-wide walking and cycling network. Each of these routes should be developed individually to consider the following:

- Lighting
- Safety
- Surface treatment
- Signage & way finding
- Greening
- Bike storage & security
- Access to future Barclays Cycle Hire docking stations

There is an aspiration both within Lambeth Council and the local community to introduce **Barclays Cycle Hire** stations to Loughborough Junction. Potential locations that could be considered are included on the adjacent plan.












#### 5.0 The Way Forward

An inspirational project is borne out of creative working relationships and open communication between the stakeholders, the public, the Local Authority and the design team.

#### 5.1 Collaboration

A critical factor of this collective team approach is the need to work collaboratively, both with the client group and also with the wider stakeholders and members of the public. Bringing forward champions for the project is vital, as is the wholesale support of all members of the Loughborough Junction Action Group, and Lambeth Council and key landowners, such as Network Rail.

#### 5.2 Consultation

We believe that community participation and ownership of proposals is key to successful place making. From the earliest stage, continuous research and consultation are required to underscore and develop ideas.

Extensive community consultation has informed the development of this Plan. However, further consultation should be carried out with local businesses and landowners to ensure maximum support. It is suggested that a strategy be developed for consulting local businesses, specifically the tenants of the railway arches.

#### 5.3 Challenges

The regeneration of the railway arches is of fundamental importance to the Plan, meaning that Network Rail are a key partner in its delivery.

The extent of Network Rail's ownership is shown on the adjacent plan, highlighting the importance or a collaborative approach to the regeneration of the area. The Plan should act as a key document for Network Rail as they assess options and the viability of redeveloping their estate.

#### 5.4 Feasibility

The aim of this Plan is to provide a vision for Loughborough Junction that is deliverable. All aspects of the vision would need to be interrogated technically to provide enhanced confidence, and to underscore LJAG's determination to see quality design that is appropriate to Loughborough Junction's character. This ranges from planning and conservation issues, traffic management, cycling and pedestrian accessibility, to landscape specifications, water run-offs, street furniture and way finding and interpretation.

#### 5.5 Viability

It is in everyone's interests that the project is both culturally and commercially successful, so that the proposals can withstand changes in the financial climate and be future-proofed to provide a legacy befitting the location.

The Project Bank is intended to provide a means for the vision to be realised through incremental, phased development, as and when financing is available.

As a major landowner, the input of Network Rail is crucial. This document is intended to provide a starting point for the assessment of financial viability by stakeholders such as Network Rail, which may allow larger projects to come forward with private financing. A partnership agreement between Lambeth Council, LJAG and Network Rail is suggested to provide a mechanism for bringing forward improvements in a way that is mutually beneficial, locally championed and financially viable.

The Project Bank provides a breakdown of the priorities at each stage. It should be used to obtain more detailed cost advice and to establish an outline programme for improvements in conjunction with Lambeth Council's funding.

#### 5.6 Management

A commitment to urban regeneration has to be demonstrated at both a strategic design level and at

the level of ongoing management commitments and future planning. As such, in their capacity as a local action group and guardians of the vision, LJAG can spearhead the ambition to see Loughborough Junction achieving the same high quality environment as the other areas.

LJAG's stewardship is critical both in the immediate future and in the long-term development of the Plan. A steering group should be established to ensure that the Plan is promoted amongst local people and organisations; that the document is available to as wider an audience as possible, and to oversee the continued updating of the document so that it continues to meet the challenges of the area.

#### 5.7 Sustainability

Lambeth and LJAG should strive to should set a benchmark for sustainable design. Every effort needs to be made to lead by example and to use sustainable development as a vigorous process to empower people and improve quality of life while simultaneously protecting and maintaining the vital natural systems of our environment.

Brixton Energy has demonstrated the potential of locally generated, renewable energy that can provide financial benefits to local residents. The housing estates of Loughborough Junction offer opportunities for exploiting such benefits, as well as other forms of communal heating and power sources. Funding is also available through the Government's 'Green Deal', which allows improvements to be made to a home or business without having to pay all thew costs up front. The opportunities are enormous.

This Plan has established the need for improvement works and provides a framework for bringing these improvements forward. What is now needed is the adoption of this Vision by LJAG, Lambeth Council and key stakeholders, whose support and endorsement is required to ensure the successful regeneration of Loughborough Junction.





# Consultation & Evidence Base













The development of this Plan was informed by a regular series of briefing meetings with the LJAG Steering Group and LB Lambeth, and with focused consultation events held between November 2012 and March 2013.

The location of the consultation event at which the feedback was obtained is highlighted with a star on each of the maps.

















Consultees were asked to indicate on a map the areas of Loughborough Junction where they felt most happy or safe




#### Consultees were asked to indicate on a map the areas of Loughborough Junction where they feel afraid or vulnerable



Consultees were asked to indicate on a map the areas where they believe improved lighting is necessary




Consultees were asked to indicate on a map the areas where they would like to see additional planting or greenery








## Responses to the question: Tell me what you like about Loughborough Junction?

The feedback has been translated to the adjacent map as a record of the positive characteristics that were described during the event.





Responses have been translated into a 'word cloud'. The size of the words relates to the frequency that it featured in responses.

Despite preconceptions, three of the four more frequent responses can be seen as positive: 'Potential', 'Community' and 'Creative'.

'Neglected' was used frequently by respondents. Further consultation suggested that this was related to poor maintenance of paving, lighting and waste disposal.



## Responses to the question: What is the best thing about Loughborough Junction?

As with the previous feedback a 'word cloud' has been used to display the frequency of responses. A sense of community was by far the most frequent response to the question, 'What is the best thing about Loughborough Junction?'.




Consultees were asked to draw a line around the area that they would describe as 'Loughborough Junction'

The outlines provided by consultees have been translated to the adjacent map to give an overall impression what people feel is the extent of Loughborough Junction. The extent of the study area is shown with a red dotted line for comparison.

As shown, there is little consensus over where the boundary lies, with many people focusing on quite an immediate area around the train station. Others have focused on the area around Loughborough Road and the Loughborough Estate.

The map also indicates that many people feel that Ruskin Park is a part of the area, indicating that it is viewed as an important amenity space.






It was frequently noted that the places people indicated were schools, green spaces and their homes.

Conversely to the map on the previous page, there was greater agreement amongst respondents regarding places that are seen as unsafe.

Anecdotal evidence suggests that the centre of the junction is seen to be particularly unsafe at night with many choosing to travel relatively short distances by bus to avoid walking through the junction. Coldharbour Lane is identified as problematic for many, as well as Wyck Gardens and many areas around the Loughborough Estate.

Cars parked on pavements and advertising signs in the middle of the pavement were highlighted as features that provide a large number of hiding places for antisocial behaviour.




# Consultees were asked to draw their route on an average day





Loughborough Estate Area of the larger NORTH BRIXTON BIG LOCAL Area Background and consultation results

#### PRE-EVENT PUBLICITY

Much work was done by spreading the event by word of mouth but there were lessons to be learnt by combining the publicity on a leaflet given widespread distribution throughout the local area and paid for by Lambeth Council. The leaflet featured on one side information about the consultation on the MASTERPLAN for the area – this is for ideas about public realm improvements for the area – a wider area which includes the Loughborough Estate – for the area now identified as Loughborough Junction – "the area lying between Brixton and Camberwell and traditionally much neglected."The other side featured information about the BIG LOCAL – covering North Brixton and within it the much smaller sub area of the Loughborough Estate going towards Angell Town. Both events were held on the same day – the Masterplan outside on the square by the Hero of Switzerland and the Big Local inside the Loughborough centre. Both benefitted with additional numbers of people attending but for some the different ends may have been confusing. Also there were no additional flyers printed to give out on walkabouts, at events etc. However both results from the consultations are invaluable.

Lesson learnt: Future Big Local events will be advertised exclusively and clearly demonstrate where the Big Local area is and for whom it is relevant.

#### THE DAY ITSELF - Saturday 8th December - WHO CAME?

Over 100 people of all ages - from young people to senior citizens dropped in, not all signed in but everyone enjoyed the opportunity to find out more about Big Local as well as eat the delicious food and meet people. Some of the older people stayed all day and one said that the day "had been better than his birthday and Christmas put together" - indicating a need for more social occasions especially intergenerational, as he also said that it was "so nice to meet people of all ages and join in".

Of particular interest were teenagers, who although not signing in and looking as if the event was of little interest, did actually leave their views and concerns – safety, things to do, training, apprenticeships, jobs – a future. The mosaic workshop was especially enjoyed as some residents would like to see the extensive mosaic community project which took place on the Loughborough Estate some 20 years ago, and which has now fallen into disrepair, returned to its former glory. It was mentioned that by working together on the project it had brought the estate together as all ages had taken part and the way that it was managed had been so much fun.

Another element during the day was the impromptu music session that was led by a Big Local resident who would very much like to extend the work he already does with all ages across Lambeth more directly with his immediate local community.

A similar view was expressed by participants and the family film team documenting the events, who are also local residents in the Big Local area, who would also like to do more in their own local community, leading workshops and sharing their skills.

Along with other local skills that were apparent during the day – some examples - catering, gardening and food growing, social group organising for women, older people and crafts, the local voluntary football league (without a home), small business and shop skills, it was obvious that there was much local talent wanting to develop projects and ideas to benefit the community and improve their own employment opportunities.

#### ANALYSIS OF DATA

38 people signed in and indicated that they would like to hear more.

31 people returned anonymous monitoring background info forms.

- Location all were local and in the relevant postcodes but indicated differing ideas as to where they lived either Loughborough or Loughborough Junction. (Loughborough Junction is increasingly being given as the name of the area and described as being between Brixton and Camberwell.)
- Everyone gave English as first language except for 1 Yoruba first language speaker and 1 Krio first language speaker.
- 8 White British 1 Irish 4 white other.
- 2 white/black Caribbean
- 11 Black British/ Caribbean 3 Black African 2 other black
- 13 Female 11 male
- 3 people with disabilities
- Participants across all ages from small children to the elderly

#### How people see The Loughborough area of North Brixton:

The Coldharbour Ward and the Loughborough Estate area have one of the highest unemployment and lowest scores for wellbeing both in Lambeth and in the whole country. Coldharbour Ward is the poorest ward in Lambeth and 3 in 5 residents are in social housing. Residents are culturally diverse and often experiencing disadvantage – family members unemployed or on low income. There is a fairly stable population – some people who were moved here came from areas in Lambeth demolished some 50 years ago. Whole families have been raised on the estate. There are many senior residents, some in sheltered housing and there are also a large number of young children and teenagers. People feel that although they like the area it does have problems.

The area has both private and public green spaces between both high and mid rise 1950's blocks as well as lower rise sheltered housing. Part of the estate is older ex GLC 1930's blocks with less green space. Some public park areas at the edge of the estate are not felt to be safe. Others have unsupervised play facilities. Wyck Gardens that runs along the south of the Estate is not well lit and attracts drinkers even during the day. However it is also home to the Ebony Horse Club which provides riding for local school children and for those young people who would particularly benefit.

There are few large employers in the area - there are small businesses in the railway arches - mainly car repair and workshops. A large amount of employment opportunities are about to come on stream in the north of Lambeth as the Battersea Power station project and the US Embassy gets built and people are hoping that Lambeth residents will be able to take opportunity of these developments and get some of the jobs.

Local shopping parades are limited in what is supplied and increasing units are becoming empty. Both Tesco's and Sainsbury are about to open 'Locals' on Coldharbour Road – which will possibly lead to further small shop units becoming empty. Neither Tesco or Sainsbury's are at present planning to include free cash machines – local people feel this is a pity – as at present, the few cash machines there are in the area involve a fee. There is an abundance of chicken shops. The market and smaller shops in Brixton town centre can be reached on foot but for those with disabilities and shopping with children not all of the estate is near a bus stop.

There is one bus that goes through the estate and buses towards central London and into Brixton are not far away. There is the overground station at Loughborough Junction and Brixton is the nearest underground – walkable, if fit, from the estate. However transport is seen as expensive for many people. There is low car ownership. Many more people would like to cycle but there are few safe secure places to keep a bicycle, especially in the high rises and no cycle paths. People would like a more reliable and frequent bus service through the estate.

The only community facility, the Loughborough Centre, has never been finished. It needs sound insulation and upgrading of kitchens so as to provide proper extractor facilities in order to allow food cooking to take place - both necessary so as not to disturb the flat occupants above. There were also plans to build raised boxed beds in the courtyard so that seniors and people with disabilities could garden – this has not yet been put in place either. This is the main facility in the local area for community use, other that the run down Marcus Lipton Youth Club, which is also in need of extensive work. However groups do meet in the Centre, despite the lack of facilities and often no heating!

There are many small groups in the area, often unfunded and lacking a home. There are also many church and religious organisations in the area and some good projects on the periphery of the estate. Actually on the estate are both the newly formed Loughborough Estate Tenants and Residents Association (LETRA) and the Loughborough Women's Group (LWG) and an embryonic Community Hub network.

For additional information the Loughborough Speaks! Consultation held February/March 2011 that particularly highlights local issues, concerns and visions and involved key local stakeholders may be useful.

The following methods were used throughout the day to help people develop the vision for their part of the Big Local area as well as the area's profile:-

- 1. Two artists (one a local resident) were employed to capture individual ideas and visions pictorially
- 2. A family (local residents) were asked to capture views and an understanding of the Big Local on film (link to follow)
- 3. Questions were out on the wall and people were encouraged to use Post-its and write up their views and suggestions.
- 4. A map of the Big Local area was placed on the wall for comment and to aid discussion
- 5. A large scale map of the area. A number of previously raised local ideas and issues were available on small flags as well as blanks for people to fill in themselves. Drawing pins that were colour coded according to age group were provided and people were asked to pin the flags onto the map in appropriate places about issues they would like to raise, improve or change.
- 6. A signing in register and also for people who would like further information on the Big Local.
- 7. An anonymous questionnaire was available in order to gauge areas in which people thought they lived and where they lived, gender, ethnicity, age, disability and language.

#### An idea from two residents:-

- Have a community shop in one or all the blocks (maybe something different for each block (for example bee jay laundry). Could sell the produce made from roof allotments.

- Get someone to film it! Lots in interest in the Loughborough Estate, it's been on TV in Top Boy and other programmes. Programme could be about the transformation of an area, bringing people together, reducing crime etc.

#### SUMMARY - KEY THEMES and VISIONS emerging

- 2. Plan ways of dealing with open drinking, drug taking and drug dealing in order to make Loughborough feel safer.
- 3. Improve possibilities of local people running businesses, taking over local shops and generally making access to jobs, training and apprenticeships a real possibility
- 4. Create better social amenities and facilities for all ages
- 5. Green the area with more trees, allotments, plants including on the roof tops of the blocks and an urban orchard and forest.
- 6. Improve local public transport, a community minibus scheme, more cycle and safe walk areas together with improved lighting and traffic calming throughout the area.



#### PROPOSAL FOR A COMMUNITY GARDEN IN SOUTHWELL ROAD


Southwell Road lies to the south of Coldharbour lane to the east of Loughborough Junction station. The majority of the buildings at the eastern end of Southwell Road are 3 storey houses which were built for nurses in Kings Hospital around the turn of the 20° Century. All of these have been turned into flats which are both privately owned and council accommodation. A significant number are sheltered accommodation. The majority of these houses have been split into 3 flats but some have been split further into 4 units, so at least two thirds of the residents at this end of the street do not have access to a garden. As relatively small two bedroom flats they are not ideally suited for families, however there are a significant number of families with small children in the area.

Garden space is limited generally to the rear of ground floor flats. There are small gardens to the front which are communal and generally used to store wheelie bins leaving little usable garden space and no space to dwell for any length of time. The front garden spaces are often untended as there is no sense of ownership where the flats are rented.

Children are either kept indoors or play on the streets as there is no safe area for them to gather and play. Southwell Road is often used as a rat run for cars going between Coldharbour Lane and Herne Hill Road and traffic calming has done little to stop speeding traffic so children play on the street at considerable risk.




Destil of the North East and of Southwell Road

#### THE CONCEPT

This proposal is to seal off the cul-de-sac at the eastern end of Southwell Road in order to create a community garden where residents can have some outdoor space and to interact with their neighbours. If will also provide a space for children to play safety off the road.

A small food growning space aims to provide local children with a taste of horticulture and a community BSQ at the end of the space can be utilised by residents individually or for community parties during the summer. The culmination of the food growing project in late summer/early autumn could be a community BSQ where the food is cooked and shared by local residents.





#### SKETCH PROPOSAL

This proposal aims to create a single space with two different objectives.

 A Courtyard Garden would provide a space with could be used for children to play, adults to sit and enjoy the sun, a water feature, flower garden and flowering trees to provide an air of contemplation, and natural materials to soften the urban nature of the space.

A secure bicycle park constructed from steel and timber with a green sedum roof is also proposed as bicycle theft is endemic on the street.

Planters would be slightly raised but open to the earth below to help with water retention. They could be constructed from railway sleepers which would be economical, robust, easily kept and reflect the railway heristge in Loughborough Junction. Bench seating would be integral with the planters, also utilising railway sleepers.

The water feature would provide the main focus for the countyard garden. As a central feature it would also be raised using railway sleepers and would include bench seating around the feature. The water feature would be simple and minimal but would help to provide a small amount of animation to the space and could be powered from the Kitchen garden shed. Agreement would be needed with Lambeth council about the power provision.

Additional smaller reised flower beds would help to soften the space...

A Kitchen Garden to the rear of the cul-de-sac is proposed, to singage the local
children and adults in a food growing project. The space is too small to be of any
real practical purpose but growing food would be educational as well as social.
A community BBQ and pionic benches are also proposed in this part of the garden.

to encourage neighbours to use the space and to interact with each other. The food growing scheme could culminate in a harvest BBQ where food which has been grown can be cooked and shared by the community. A community BBQ would give people from different backgrounds the opportunity to share their culnary ideas. The practical requirement of keeping a garden going at this end of the street would be dealt with by the inclusion of a garden shed which can be used for storing equipment, providing power to the water feature and growing seedlings. It would also have a green sedum roof. A water tap could also be provided within the shed, however the proposal also includes two water butts at each side of the end of the garden, which would be connected to the rainwater down pipes from the adjacent properties to provide the majority of the water for the garden and to raise awareness of green issues. Agreement would be required with the freeholders to connect these to their rainwater down pipes.

A central store for the wheelie bins from the houses facing onto the gardens could be provided behind the garden shed and a shared composting bin could also be provided to minimise waste and to help maintain the garden.

The loss of parking in this area is minimised by creating 3 or 4 face in parking spaces. This area of the street is underused for parking and is rarely full. Car ownership on the street is generally quite low.

#### STRENGTHS

Provide garden space to those with no access at present. Provide space for children to play off the raod. Provide an outdoor space for contemplation and to enjoy the sun. Social space for eating and cooking. Central location for bin storage to the surrounding dwellings.

#### WEAKNESSES

Upkeep of the gardens.

Control of the BBQ and garden equipment.

Upkeep of the bin storage to ensure that it isnt likely to attract virmin.

Loss of car parking spaces.

#### **OPPORTUNITIES**

Improve the overall feel of the street and improve a neglected cul-de-sac. Provide outdoor space for community get to gethers. A meeting place for neighbours with small children. Education about growing and cooking food. Education about green issues. Reduce the threat of bicycle theft in the area.

#### THREAT

Possible location for anti-social behaviour.

Noise may be an issue with the immediate neighbours.

Council issues with transferring rubbish bins through the garden to the road.

Permission to access rain water from the private roofs.
