



# Proposed Controlled Parking Zone

## Zone 'H' – Croxted Road

### Dear Resident/Business

The purpose of this leaflet is to let you know the outcome of the statutory consultation carried out in October 2019, and to inform you of the Council's decision on proposals to amend the parking arrangements in the Tulse Hill Zone 'H' Controlled Parking Zone (CPZ).

All representations received along with officers' recommendations were presented in a report to be considered by the Council. After careful consideration a decision has been made to proceed with the shared approach by which Lambeth 'HR' CPZ parking permits and Southwark 'HH' CPZ parking permits would be valid in the existing parking bays on both sides of Croxted Road.

At the same time, it has also been decided to proceed with the extension of the Zone 'H' CPZ into Croxted Road south of the railway bridge, where this shared approach will also be introduced. ### What Happens Next?

The final Traffic Management Orders (TMOs), which allow the restrictions to be implemented and administered, will be published in the London Gazette and the local newspaper (South London Press) shortly. Notices will also be placed on lamp columns in the affected area.

Other than amendment to the parking bays signs, which will now show both the Lambeth 'HR' and Southwark 'HH' zone identifiers, no physical changes are being made to the existing bays in Croxted Road. If you are an existing Zone 'H' permit holder you do not need to do anything as your permit will continue to be valid until its current expiry date.

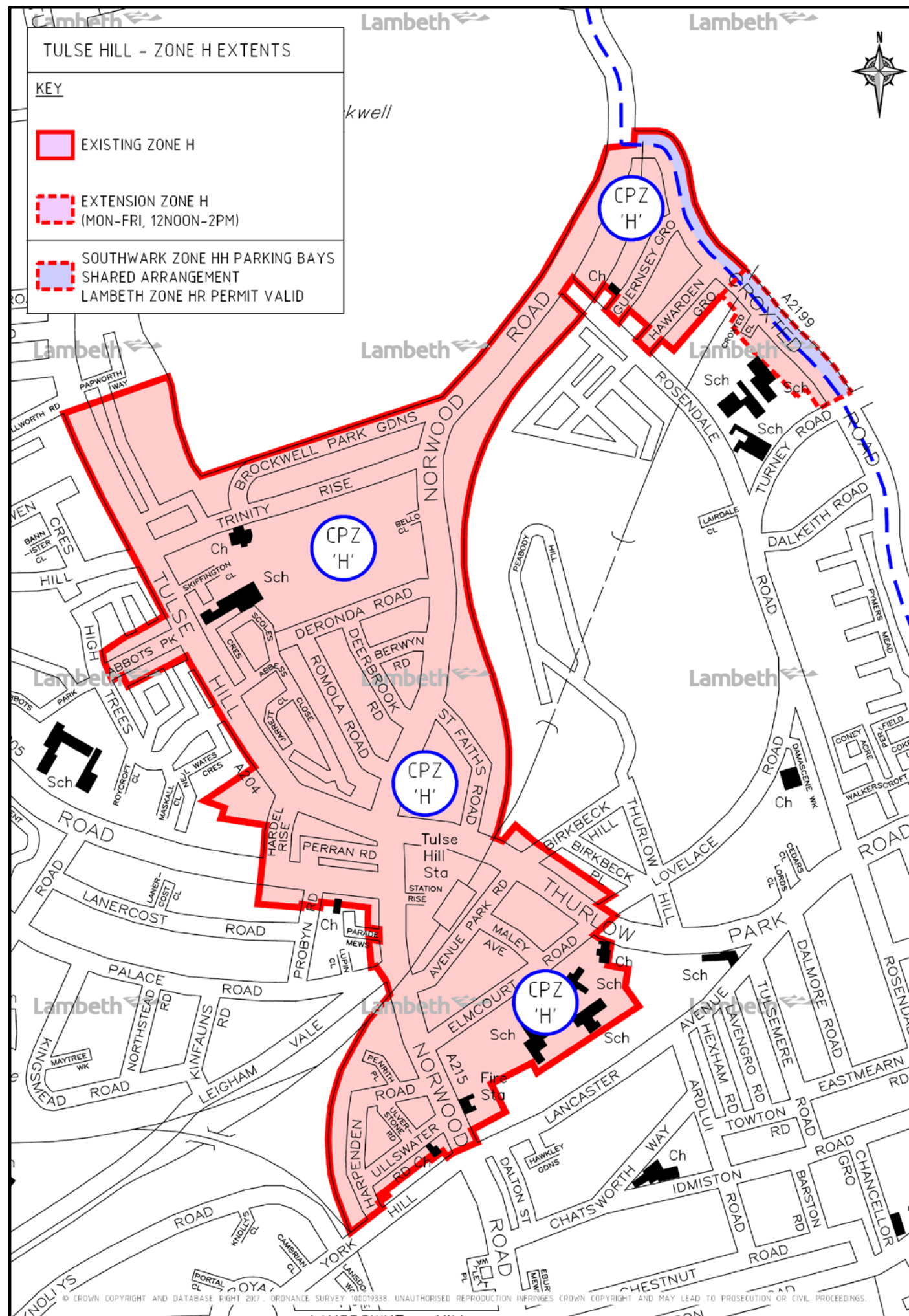
### Implementation Works

Works for changes to the parking bay signs and signing and lining works for the extension of the CPZ into the section of Croxted Road south of the railway bridge will be carried out by our contractor **CVU** (Colas Volker Highways Aecom) on behalf of the Council. It is anticipated that these works will start the week commencing **Monday 11 September 2020** for a maximum period of about 5 working days to complete, weather permitting.

We are conscious of the disruption that this work may cause and will endeavour to keep the impact to a minimum. We apologise in advance for any inconvenience that may be caused by these works.

Warning Notices will be put in place in the area to notify all road users to the zone becoming operational, which is anticipated to be **Monday 14 September 2020**, subject to change.
