

New Controlled Parking Zone

Zone F extension – Roupell Road

Implementation

Dear Resident/Business

The purpose of this leaflet is to let you know the outcome of the statutory consultation carried out in November 2019, and to inform you of the Council's decision on the proposed extension of Controlled Parking Zone (CPZ) 'F' into Roupell Road. All representations received along with officers' recommendations were presented in a report to be considered by the Council. After careful consideration a decision has been made to proceed with the implementation of the proposed 'F' CPZ. What Happens Next

The final Traffic Management Orders (TMOs), which allows the restrictions to be implemented and administered, will be published in the London Gazette and the local newspaper (South London Gazette) shortly. Notices will also be placed on lamp columns in the affected area.

Implementation Works

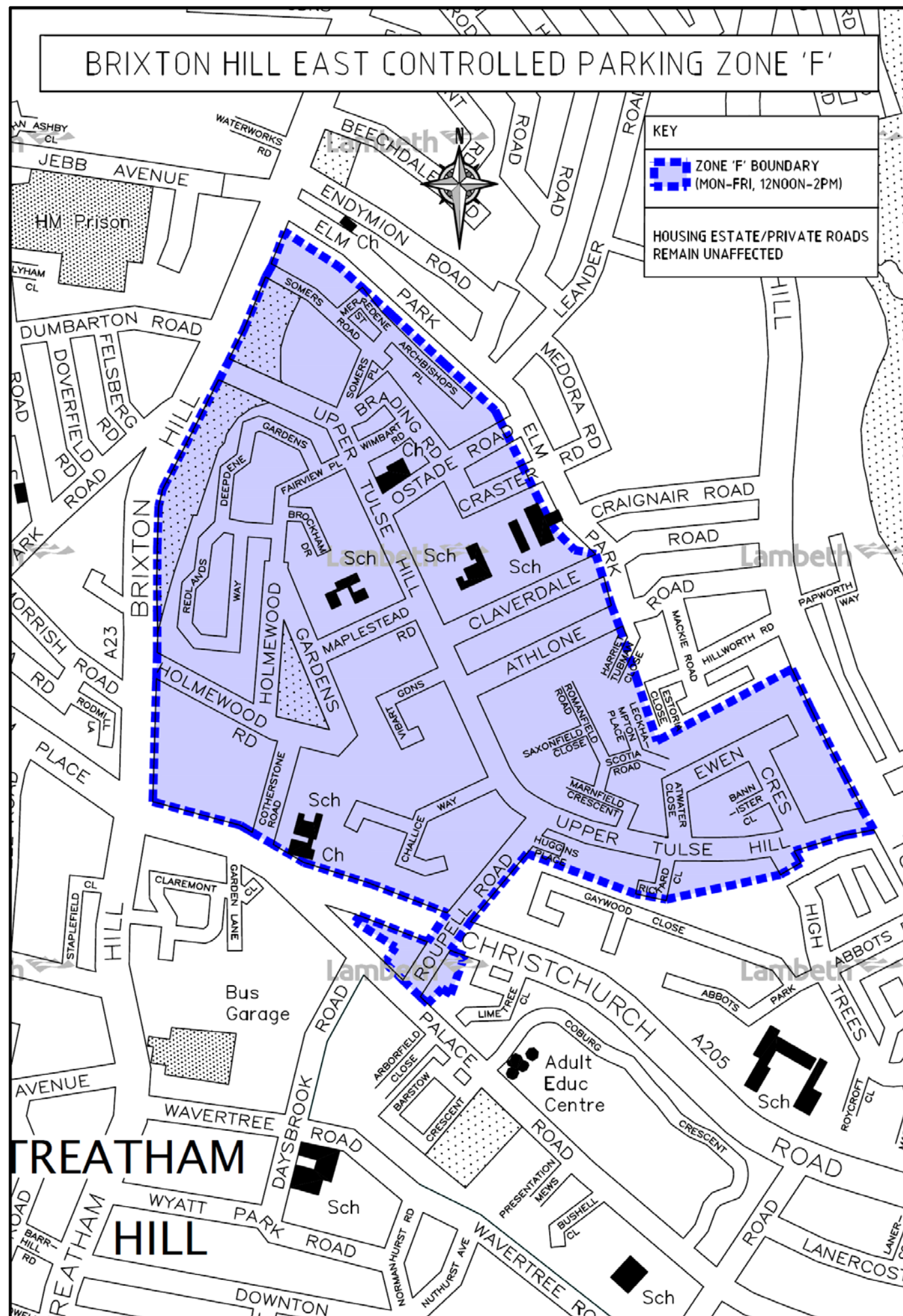
The lining and signing works will be carried out by our contractor **CVU** (Colas Volker Highways Aecom) on behalf of the Council.

It is anticipated that the works for the entire area which, in addition to the extension of Zone 'F' into Roupell Road, includes extending Zone 'H' into Probyn Road, the new Streatham Hill East Zone 'M', and introduction of 'at any time' waiting restrictions at key locations in Palace Road, Hillside Road, Kingsmead Road and Leigham Vale, will start the week **5 October 2020** for a period of 4-6 weeks. The works for your (Zone F) area should take a maximum of 5 – 10 working days to complete, weather permitting.

Works will be carried out Monday to Friday between 8am and 4.30pm. Notices and cones will be placed in your road 12 – 48hrs prior to work being undertaken. "No Parking" cones and signs will be in place to indicate the areas where parking will be prohibited. While work is being undertaken in your street, please avoid parking where the "No Parking" cones have been put in place and park your vehicle as close to the kerb as possible, this would allow for the lining works to proceed efficiently allowing a smooth transition of the works without delays. In order for the works to be carried out as quickly as possible, temporary parking restrictions will be introduced to prevent vehicles from obstructing the work. Offending vehicles run the risk of receiving a fine and possible relocation.

Vehicles are allowed back onto the road once the lining work is complete or after the working day. Warning Notices will be put in place in the area to notify all road users when the zone becomes operational, which is envisaged to be **16 November 2020**, subject to change.

The Council is conscious of the disruption that this work may cause and will endeavour to keep the impact to a minimum. We apologise in advance for any inconvenience that may be caused.



Do I have to pay to park in the CPZ?

Any resident living in or business located in the area shaded who owns a car and wants to park on the public highway Monday to Friday between 12 noon and 2pm, will need a parking permit.

Residents will also be able to buy visitor vouchers for their guests to be able to park in designated bays, or trader vouchers so that works (such as renovations or landscaping) can be done at their properties.

Any person visiting the neighbourhood to access shops or services can make use of short term parking provisions, which means they pay only for the time they're parked in the area.

If you park your vehicle off street on your driveway/private property you would not require a parking permit.

Where Can I park?

Vehicles displaying a valid Zone 'F' permit would be able to park in marked bays on the public highway within the entire Zone 'F' as shown in the plan opposite. Check signs before parking.

How do I apply for a parking permit/vouchers?

Parking permits/Vouchers are available on the Lambeth council website via the following link www.lambeth.gov.uk/parking-permit. You can also obtain all information including the pricing structure and the full application process.

The quickest and easiest method to apply for a permit is via the link above. However, if you are unable to access the internet you can call the Lambeth Contact Centre on 020 7926 9000 for assistance.

PLEASE NOTE: Permit applications can only be made from 1 month in advance of your zone being operational, the earliest you can apply is from 19 October 2020.

Pay by Phone

For short or unplanned visits, when you may not have any visitors voucher to hand, visitors can park for up to a maximum of one hour in shared-use bays by calling, texting or using the mobile phone Pay by Phone application.
