## PROPOSED AMENDMENT TO PARKING PLACES – MOUNT EPHRAIM ROAD

[NOTE: This Notice is about proposals to remove a section of permit holders parking place outside No. 30a Mount Ephraim Road and replace it with single yellow line no waiting restrictions that would operate at Controlled Parking Zone hours to allow for the installation of a dropped kerb. Objections or other comments may be made – see paragraph 6.]

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth proposes to make The Lambeth (St Leonards North "I") (Parking Places) (No. \*) Order 202\* under sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

2. The general effect of the Order would be to replace a section of permit holders parking place with single yellow line no waiting restrictions that would operate at Controlled Parking Zone hours (Monday to Friday, 12pm to 2pm) on Mount Ephraim Road, the north side, between a point 0.7 metres west of the common boundary of Nos. 30 and 30a Mount Ephraim Road to a point 1 metre west of the common boundary of Nos. 30a and 32 Mount Ephraim Road.

3. The proposed Order is necessary to accommodate a new vehicle crossover outside No. 30a Mount Ephraim Road and prevent obstruction of access.
