**SCHOOL STREETS SCHEME - VARIOUS ROADS
ROAD CLOSURES AND PEDESTRIAN AND CYCLE ZONES**

(NOTE: This notice is about continuing indefinitely the closure of the roads or parts of the roads specified in paragraph 3 and in the schedules to this notice to all motor vehicles at certain times of the day by making permanent the experimental pedestrian and cycle zones in those roads. The road closures and pedestrian and cycle zones will continue to operate in those roads at the times specified in this notice on Mondays to Fridays inclusive, although it is anticipated that they will only operate during those hours in school term-time.)

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth ('the Council'), with the agreement of Transport for London, on 7th December 2022 made the Lambeth (Prescribed Routes) (No. 11) Traffic Order 2022 under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. The Order will come into force on 10th December 2022.

2. The general effect of the Order will be to continue to ban motor vehicles, except for permit holders from entering the roads or lengths of road specified in this Notice during certain times of the day. This will be achieved by making the roads a pedestrian and cycle zone and by installing the appropriate traffic signs.

3. Permits allowing vehicles to enter each pedestrian and cycle zone will be available to residents and employees of businesses and organisations at premises located within or accessible only from that pedestrian and cycle zone, and to disabled person's badge holders who fall into the above criteria and have a bona fide reason to enter that pedestrian and cycle zone, by application to the Council

4. The pedestrian and cycle zone in the roads or lengths of road specified in **Schedule 1** to this Notice will operate between 8.15 am and 9.15 am and between 2.45 pm and 3.45 pm, the pedestrian and cycle zone in the roads or lengths of road specified in **Schedule 2** to this Notice will operate between 8.30 am and 9.30 am and between 2.45 pm and 3.45 pm, the pedestrian and cycle zone in the roads or lengths of road specified in **Schedule 3** to this Notice will operate between 8.15 am and 9.15 am and between 3 pm and 4 pm and the pedestrian and cycle zone in the roads or lengths roads or lengths of road specified in **Schedule 4** to this Notice will operate between 8.30 am and 9.30 am and between 3 pm and 4 pm, on Mondays to Fridays inclusive, although in practice it is anticipated that the zones will only operate during these hours in school term-time. Any vehicle that is already in the lengths of roads specified in the roads or lengths road of road specified above or Schedules 1, 2, 3 and 4 of this Notice before the pedestrian and cycle zone commences will be permitted to leave.

5. The Order is intended to continue to create a pleasant environment that feels safer in the immediate vicinity of a school or nursery, discourage travelling to school or nursery by car, and encourage walking, scooting and cycling to school, thereby achieving positive healthy outcomes for the school community.

8. If any person wishes to question the validity of the Order or of any of their provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Orders are made, apply for the purpose to the High Court.

Schedule 1

(between 8.15 am and 9.15 am and between 2.45 pm and 3.45pm on Mondays to Fridays)

Bonneville Gardens, the whole length; **B**urgoyne Road, the whole length; **F**itzalan Street, the whole length; **G**ilbert Road, between Wincott Street and a point 11 metres north-east of Wincott Street; **G**ranton Road, between Farmhouse Road and Meadfoot Road; **H**ydethorpe Road, between Cavendish Road and Pentney Road; **K**empsford Road, the whole length; **S**cholar's Road, the whole length; **S**tockport Road, between Churchmore Road and Greenock Road; **W**alnut Tree Walk, between Lambeth Walk and the south-eastern wall of Nos. 1 to 17 Minton House; **W**incott Street, the whole length; and **W**olfington Road, between Knight's Hill and a point 8 metres east of Casewick Road.

Schedule 2

(between 8.30 am and 9.30 am and between 2.45 pm and 3.45 pm on Mondays to Fridays)

Angell Road, between its north-western extremity and the north-western kerb-line of Angell Park Gardens; **C**ancell Road, between Cowley Road and a point 19 metres east of Cowley Road; **C**owley Road, between Crawshay Road and a point 10 metres north of Cancell Road; **H**ackford Road, **(i)** between its junction with Durand Gardens and Hillyard Street and Southey Road; and **(ii)** between Caldwell Street and South Island Place; **L**inton Grove, between Basil Gardens and Elder Road. and **M**owll Street, the whole length.

Schedule 3

(between 8.15 am and 9.15 am and between 3 pm and 4 pm on Mondays to Fridays)

Carnac Street, between Hamilton Road and Clive Road; **G**askell Street, between Union Road and the entrance to the Gaskell Street Estate car park (permit holders GHA); **S**medley Street, between Larkhall Lane and its south-eastern extremity; **T**elferscot Road, the whole length.

Schedule 4

(between 8.30 am and 9.30 am and between 3 pm and 4 pm on Mondays to Fridays),

Crescent Lane, between Worsopp Drive and Tableer Avenue; **H**itherfield Road, between Leigham Vale and Mount Nod Road.
