**ROAD TRAFFIC REGULATION ACT 1984 - SECTION 16A**

**TEMPORARY ROAD CLOSURES FOR STREET PARTIES AND OTHER SOCIAL EVENTS**

**IN THE YEAR OF KING CHARLES III CORONATION**

1. NOTICE IS HEREBY GIVEN that, to enable street parties and other social events to take place, the Council of the London Borough of Lambeth have made Orders the effect of which will be to ban vehicles from entering the following roads or lengths of road on the dates indicated:-

  - (a) **Courtenay Street**, between Kennington Lane and No. 12 Courtney Street;
  - (b) **Glencairn Road**, the whole length;
  - (c) **Handforth Road**, the whole length;
  - (d) **Heathdene Road**, between No. 24 Heathdene Road and Fontaine Road;
  - (e) **Penistone Road**, between No. 1 Penistone Road and No. 24 Penistone Road;
  - (f) **Woodfield Avenue**, between Dingley Lane and Drewstead Road,  
on Saturday 6<sup>th</sup> May 2023;
  
- (ii)
  - (a) **Abbotswood Road**, between Drewstead Road and Hoadly Road;
  - (b) **Argyll Close**, the whole length;
  - (c) **Arragon Gardens**, the whole length;
  - (d) **Beechdale Road**, between No 6 Beechdale Road and No. 22 Beechdale Road;
  - (e) **Carson Road**, the whole length;
  - (f) **Chancellor Grove**, the whole length;
  - (g) **Chatsworth Way**, between Ardlui Road and No. 17 Chatsworth Way;
  - (h) **Clive Road**, between No. 117 Clive Road and No. 149 Clive Road;
  - (i) **Dalmore Road**, the whole length;
  - (j) **Deepdene Road**, the whole length;
  - (k) **Donnybrook Road**, the whole length;
  - (l) **Ducie Street**, the whole length;
  - (m) **Eastmearn Road**, between Rosendale Road and Tulsemere Road;
  - (n) **Gleneagle Road**, between Conyers Road and Fairmile Avenue;
  - (o) **Guernsey Grove**, the whole length;
  - (p) **Highland Road**, between No. 4 Highland Road and Gipsy Hill;
  - (q) **Hydethorpe Road**, between Haverhill Road and Radbourne Road;
  - (r) **Killieser Avenue**, between Criffel Avenue and Sternhold Avenue;
  - (s) **Lewin Road**, between No. 21 Lewin Road and No. 71 Lewin Road;
  - (t) **Mandalay Road**, the whole length;
  - (u) **Meadow Road**, between Meadow Mews and Claylands Road;
  - (v) **Pearman Street**, between Emery Street and Frazier Street;
  - (w) **Rollscourt Avenue**, between Cosbycote Avenue and Kestrel Avenue;
  - (x) **The Chase**, between Hannington Road and Wilderness Mews,  
on Sunday 7<sup>th</sup> May 2023;
  
- (iii)
  - (a) **Birkbeck Place**, the whole length;
  - (b) **Clyston Street**, between Stewart's Road and the north-western wall of No. 1 Michael Manley Industrial Estate;
  - (c) **Cottage Grove**, the north-easternmost arm, between Willington Road and a point 36 metres south-west of Willington Road;
  - (d) **Fairmile Avenue**, the whole length;
  - (e) **Hexham Road**, between Lancaster Avenue and Towton Road;
  - (f) **Lexton Gardens**. Between No. 16 Lexton Gardens and No. 24 Lexton Gardens;
  - (g) **Lovelace Road**, between No. 14 Lovelace Road and No. 40 Lovelace Road;
  - (i) **Pendennis Road**, between Leithcote Gardens and Newcombe Gardens,
  - (j) **Towton Road**, between Ardlui Road and Lavengro Road;
  - (k) **Uffington Road**, between St Julian's Farm Road and Thurlby Road;
  - (l) **Willington Road**, the whole length;  
on Monday 8<sup>th</sup> May;

2. Alternative routes for affected vehicles will be available via adjacent roads as directed by traffic signs.

3. The bans will only apply on the above dates at such times and to such extent as shall be indicated by the placing of the appropriate traffic signs and barriers in the roads concerned.
