



LAMBETH BOROUGH COUNCIL TRAFFIC MANAGEMENT ORDER

LBC 2020 No. 43

The Lambeth (Prescribed Routes) (No. 3) Traffic Order 2020

Made 19th August 2020

Coming into force 24th August 2020

The Council of the London Borough of Lambeth, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a), and of all other enabling powers, hereby makes the following Order:-

1. This Order shall come into force on 24th August 2020 and may be cited as the Lambeth (Prescribed Routes) (No. 3) Traffic Order 2020.

2. (1) In this Order "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment.

(2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

3. No person shall cause or permit any vehicle to proceed in any length of road specified in an item in column (2) of the table in Schedule 1 to this Order in a direction other than that specified in column (3) of that item.

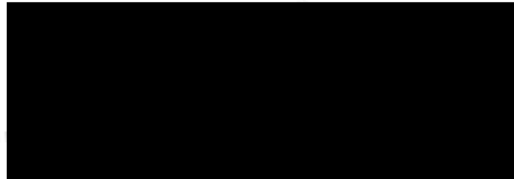
4. No person shall cause or permit any vehicle proceeding in any road or length of road specified in an item in column (2) of the table in Schedule 2 to this Order to enter the length of road specified in column (3) of that item.

5. Nothing in Article 3 or 4 of this Order shall apply to:-

(a) anything done with the permission or at the direction of a police constable in uniform or a traffic warden; or

- (b) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to section 66 or 67 of the Road Traffic Regulation Act 1984.

SCHEDULE 1

(One-way streets)

(1) Item No.	(2) Length of road	(3) Direction
1.	Electric Lane from its junction with Rushcroft Road to the southern kerb-line of Coldharbour Lane.	from south to north
2.	Rushcroft Road from its junction with Coldharbour Lane to the eastern kerb-line of Electric Lane.	in a direction towards the junction of Rushcroft Road with Electric Lane

SCHEDULE 2

(No entry to all vehicles)

(1) Item No.	(2) Road or length of road in which the vehicle is proceeding	(3) Length of road the vehicle shall not enter
1.	Coldharbour Lane	Electric Lane that length which lies south of the southern kerb-line of Coldharbour Lane.
2.	Electric Lane that length which lies north of the northern kerb-line of Coldharbour Lane.	Electric Lane that length which lies south of the southern kerb-line of Coldharbour Lane.
3.	Rushcroft Road that length which lies west of the eastern kerb-line of Electric Lane.	Rushcroft Road that length which lies east of the eastern kerb-line of Electric Lane.
