

LONDON BOROUGH OF LAMBETH

CHANGES TO PARKING PLACES, WAITING AND LOADING RESTRICTIONS IN LOUGHBOROUGH ROAD AND MINET ROAD; INTRODUCTION OF MANDATORY CYCLE LANES IN LILFORD ROAD AND LOUGHBOROUGH ROAD. A BAN ON VEHICLES ENTERING OR EXITING FIVEWAYS ROAD AT ITS JUNCTION WITH LOUGHBOROUGH ROAD.

[NOTE: This Notice is about proposals to make changes to the existing parking places and waiting and loading restrictions in Minet Road and Loughborough Road and to introduce mandatory cycle lanes in Lilford Road and Loughborough Road and to ban vehicles entering or exiting Fiveways Road at its junction with Loughborough Road.

1. NOTICE IS GIVEN that the Council of the London Borough of Lambeth made the Lambeth (Cycle Lanes) (No.3) Traffic Order 2023, the Lambeth (Charged-For Parking Places) (Amendment No. 28) Order 2023, the Lambeth (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. 31) Order 2023 and the Lambeth (Prescribed Routes) (No. 13) Traffic Order 2023.
2. The general effect of the Orders is to:
 - (1) provide mandatory cycle lanes in Lilford Road and, Loughborough Road.
 - (2) revoke the existing ban on motor vehicles entering that part of Fiveways Road which lies between its junction with Akerman Road, Lilford Road and Loughborough Road and impose a ban on motor vehicles entering or exiting Fiveways Road at the south-western kerb-line of Loughborough Road.
 - (3) adjust the location of disabled parking places in Loughborough Road near Horle Walk.
 - (4) adjust the location and use of parking places on Loughborough Road and Minet Road.
 - (5) introduce no waiting and no loading at any time junction protection restrictions at various junctions with Loughborough Road.
3. The proposals are necessary to reduce the conflict between pedal cyclists and other moving vehicles including buses stopping at bus stops; to reduce vehicle speeds and the potential for road traffic accidents and to provide safer road crossing facilities for both pedestrians and cyclists, to improve safety for all road users and accessibility for pedestrians and cyclists.

6. If any person wishes to question the validity of the Orders or of any of their provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Orders are made, apply for the purpose to the High Court.
