The Lambeth (Charged-For Parking Places) (Amendment No. **) Order 202*

The Council of the London Borough of Lambeth, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended), and of all other powers thereunto enabling, hereby make the following Order:-

Citation and commencement

1. This Order may be cited as the Lambeth (Charged-For Parking Places) (Amendment No. **) Order 202* and shall come into force on dd/mm/yyyy.

Amendments to the Order of 2023

2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2023 shall have effect as though in Schedule 3 there were added: -

EXPLANATORY NOTE

(This is not part of the Order but used to help explain its purpose)

The Lambeth (Charged-For Parking Places) (Amendment No. **) Order 202*

The general effect of the Order is to amend the existing structure for parking charges for the use of the on- street parking places, in the London Borough of Lambeth. The Order extends the emissions charging structure to other permits and applies a diesel surcharge and surcharge for multiple resident permits in a single household.
