

## LONDON BOROUGH OF LAMBETH

### PROPOSAL TO INTRODUCE ELECTRIC VEHICLE CHARGING BAYS AND ENFORCE PARKING RESTRICTIONS ON COUNCIL HOUSING ESTATES BY THE ISSUE OF PENALTY CHARGE NOTICES

*(NOTE: This notice is about proposals to enforce waiting, loading, and parking restrictions on additional Council housing by the issue of Penalty Charge Notices (PCNs) and the introduction of electric vehicle charging parking places on housing estates. There would be no changes to the parking restrictions that currently operate. Objections may be made – see paragraph 7.)*

1. **NOTICE IS GIVEN** that the Council of the London Borough of Lambeth propose to make the Lambeth (Housing Estates) (Off-Street Parking Places) (No. \*) Order 202\*, and the Lambeth (Housing Estates) (On-Street Parking Places) (No. \*) Order 202\* under the Road Traffic Regulation Act 1984 (as amended).
2. The general effect of the Orders would be to enable waiting, loading, and parking restrictions on the roads and car parking areas of the Council housing estates to be enforced under the provisions of the Traffic Management Act 2004. Penalty Charge Notices could be issued for vehicles parked in contravention and vehicles may be removed (towed away) or immobilised (clamped) in certain cases. The right to appeal to an independent adjudicator would also apply.
3. The parking restrictions that currently operate on the housing estates remain unchanged except where there are proposals to install an electric vehicle parking place where only a permit holder's electric or hybrid vehicle whilst charging may be left in that parking bay.
4. The proposed Orders would provide lawful authority for the enforcement of restrictions on certain Council housing estates to ensure that parking facilities are maintained for the use of eligible residents of the estates, their visitors, and any essential contractors/staff only, and to also prevent parking where it could cause an obstruction particularly to emergency services and refuse collection vehicles.
