The Council of the London Borough of Lambeth, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a), and of all other powers thereunto enabling, hereby make the following Order:-

## Citation and commencement

1. This Order may be cited as the Lambeth (Charged-For Parking Places) (Amendment No. \*\*) Order 2024 and shall come into force on \*\*\* \*\*\*\*\* 2024.

## Interpretation

2. (1) In this Order:

“the Order of 2023” means The Lambeth (Charged-For Parking Places) Order 2023(b).

“map-based schedule” means the map attached to and to be read in conjunction with this Order, which depicts the parking places designated by this Order, and in conjunction with the map schedule legend, identifies the type of each particular parking place and, if appropriate, certain of its governing provisions:

Provided that the Council does not accept responsibility for any inaccuracies contained in the Ordnance Survey data relied upon to create the map-based schedule and where a parking place is depicted on the map-based schedule, that parking place will continue to apply irrespective of any subsequent changes that have been made to the underlying Ordnance Survey data.

“map schedule legend” means the map schedule legend presented with the map based schedule which, when used in conjunction with the map based schedule, the Articles of this Order, and the following table of disambiguations (where applicable):

identifies the specific type of parking places designated by this Order, and, where appropriate, certain of their governing provisions;

“parking place” means an area on a highway designated as a parking place by this Order, being either: a residents permit holders parking place, or a residents permit holders parking place reserved for electric vehicles, or a permit holders parking place, a permit holders parking place reserved for electric vehicles, or a shared-use permit holders and pay parking place, or a ‘cross-borough’ residents permit holders and pay parking place, or a ‘cross-borough’ permit holders parking place, or a shared-use ‘cross-borough’ permit holders and pay parking place, or a pay parking place, or a business permit holders parking place, or a doctors parking place or, a car club parking place, and in each case being identified as such type in the map-based schedule by reference to the map schedule legend;

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2023 shall have the same meaning as in that Order.

### Amendments to the Order of 2023

3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2023 is hereby varied as identified in the map-based schedule.

### Designation of parking places and application of the Order of 2023 thereto

4. (1) Each area on a highway identified in the map-based schedule as a parking place and by way of the map schedule legend as an area signed or marked out, or both, for the use therein of specified classes of vehicles following the conditions specified in this Order in relation to that parking place, is a designated parking place.

(2) Unless otherwise so identified, a parking place shall be either:-

- (a) in the case of a parking place identified in the map-based schedule or by way of the map schedule legend, or both, as being a parking place indicated on-street by way of a 'permit parking area' sign in accordance with Item 5 of Schedule 5, Part 3 to the Traffic Signs Regulations and General Directions 2016, comprising the length, and unless otherwise so specified, the full width of the carriageway of a street so identified in the map-based schedule; or
- (b) in the case of any other parking place, bounded on one side of its length by the edge of the carriageway and be an area marked out to a road marking and indicated by a regulatory sign, either in accordance with the Traffic Signs Regulations and General Directions 2016 or, if applicable, by virtue of any special authorisation given by the Department for Transport.

(3) The provisions of the Order of 2023 (other than Articles 4 and 17) shall apply to each area designated as a parking place by this Order as if in those provisions any reference to a parking place included a reference to each area designated as a parking place by this Order and as if any reference to the map-based schedule to the Order of 2023 included a reference to the map-based schedule.

### Placing of traffic signs at parking places, including signs indicating availability of the electronic payment system

5. The Council shall:

- (a) place and maintain road markings indicating the limits of each parking place, other than a parking place of the type described in Article 4(2)(a);
- (b) place and maintain in or in the vicinity of each parking place, traffic signs indicating that such parking place may be used during the permitted hours for the leaving only of the vehicles specified in Article 5;
- (c) place and maintain in or in the vicinity of each shared-use permit holders and pay parking place, shared-use 'cross-borough' permit holders and pay parking place, and pay parking place, a traffic sign indicating, that such parking place may be used by vehicles making payment of the parking charge by way of the electronic payment system; and the location identification number of such parking place or part thereof; and
- (d) carry out such other work as is reasonably required for the purposes of the satisfactory operation of a parking place.

## EXPLANATORY NOTE

(This is not part of the Order but used to help explain its purpose)

### The Lambeth (Charged-For Parking Places) (Amendment No. \*\*\*) Order 2024

The general effect of the Order, in conjunction with the Lambeth (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. \*\*) Order 2024, is:

(a) to remove the disabled persons' parking places from the following locations:

**Berridge Road**, outside Nos. 36/38; **Cavendish Road**, outside No. 113; **Crown Dale**, outside Nos. 75/77; **Downton Avenue**, outside No. 57; **Rathmell Drive**, outside and adjacent to No. 28; **Englewood Road**, (i) outside No. 47 and (ii) outside No. 56; **Edithna Street, outside No. 44**; **Ferndene Road**, outside Nos. 66/68; **Finch Avenue**, outside No. 7; **Gauden Road**, outside Nos. 2/4; **Harpenden Road**, outside Nos. 7/9; **Holmewood Road**, outside Nos. 46/48; **Hubert Grove**, outside No. 12; **Normanhurst Road**, outside No. 6; **Pentney Road, outside No. 58**; **Vauxhall Grove, opposite No. 65 and outside Nos. 71a/71b**; and **Sherwood Avenue**, outside No. 168.

(b) to introduce new disabled persons' parking places at the following locations (these parking places will operate at any time and be for the use of vehicles displaying a disabled person's "blue badge" only):

**Brangton Road**, opposite Nos 6/18; **Brook Drive**, outside Nos. 90/92; **Cottington Street**, outside Nos. 52/54; **Dalkeith Road**, outside Nos. 18/20; **Effra Parade**, outside Nos. 58/60; **Fentiman Road**, outside Nos. 3/4 Noel Caron Houses; **Flodden Road**, outside No. 20; **Honeybrook Road**, outside Nos. 12/14; **Kingswood Road**, outside Nos. 18//20; **Lowden Road**, outside Nos. 82/84; **Milkwood Road**, outside Nos. 49/51; **Mount Nod Road**, outside Nos. 41/42/43/44; **Palace Road**, opposite Nos. 12/13 Baly House, Palace Road; **Pentney Road**, outside Nos. 11/13; **Sandmere Road**, outside Nos. 74/76; **Sherwood Avenue**, opposite Nos. 176/178; **South Croxted Road**, outside No. 75; **Thorncroft Street**, at the side of Nos. 1 to 40 Temple Court, Thorncroft Street; **Trelawn Road**, outside No. 22; and **Valley Road**, outside No. 25.
