Streatham Hill East

Controlled Parking Zone extension





27 September – 18 October 2024

The purpose of this leaflet is let you know the outcome of the public engagement carried out in June 2023 on proposals for an extension of the Controlled Parking Zone (CPZ) in the Streatham Hill East area.

What were the findings?

Thank you to all who responded.

Feedback from the public engagement has helped us to refine and improve the proposals. A number of design changes have been identified and these have been integrated into the plans.

The Council published a decision earlier this month authorising the revised proposals for the proposed CPZ extension to move to the next stage. It was also decided to introduce a Streatham Wells CPZ. What are we proposing?

We invited properties within the boundary of the potential CPZ extension, to complete an on-line questionnaire on the introduction of parking controls.

In addition to the public engagement, on-street parking occupancy surveys and on-street site assessments have been carried out to assess the current level of parking stress in the area and any current issues with road safety and accessibility caused by on-street parking.


Overall, across the area, occupancy levels of over 57% were recorded with about 13% of streets having levels in excess of 80% - 85%, indicating high levels of parking "stress". Giving consideration to the future introduction of measures in the Council's Kerbside Strategy programme, that will use 25% of the kerbside for more sustainable uses instead of vehicle parking, this would increase average occupancy in the areas to 70% in the area, with 25% of streets experiencing high levels of parking stress.

Following consideration of the above and feedback received, the initial design has been amended as follows:-

 The provision of four cycle hangars and three electric vehicle charging points have been integrated with the plans.

How can I give my views?

We are carrying out a statutory consultation on the introduction of permanent Traffic Orders for the proposed Streatham Hill East CPZ extension. Notices of the Council's intentions to introduce these measures will be published in a local newspaper (South London Weekly), in the London Gazette and posted on lamp columns in the area.

Representations for and against the proposals described in these Notices must be made in writing and must specify the grounds on which they are made, and can be made using our consultation portal at https://streets.appyway.com/lambeth or sent by post to Parking and Enforcement Group (Resident Services), London Borough of Lambeth, PO Box 80771, London, SW2 9QQ quoting reference **Streatham Hill East CPZ** by no later than **18 October 2024**.
