The purpose of this leaflet is let you know the outcome of the public engagement carried out in June 2023 on proposals for a Controlled Parking Zone (CPZ) in the Streatham Wells area.

What were the findings?

Thank you to all who responded.

Feedback from the public engagement has helped us to refine and improve the proposals. A number of design changes have been identified and these have been integrated into the plans.

The Council published a decision earlier this month authorising the revised proposals for the proposed CPZ to move to the next stage. It was also decided to extend the nearby Streatham Hill East CPZ to include additional roads. What are we proposing?

We invited properties within the boundary of the potential CPZ, to complete an on-line questionnaire on the introduction of parking controls.

In addition to the public engagement, on-street parking occupancy surveys and on-street site assessments have been carried out to assess the current level of parking stress in the area and any current issues with road safety and accessibility caused by on-street parking.


Overall, across the area, occupancy levels of over 74% were recorded with about 24% of streets having levels in excess of 80% - 85%, indicating high levels of parking "stress". Giving consideration to the future introduction of measures in the Council's Kerbside Strategy programme, that will use 25% of the kerbside for more sustainable uses instead of vehicle parking, this would increase average occupancy in the areas to 93% in the area, with over 70% of streets experiencing high levels of parking stress.

Following consideration of the above and feedback received, the initial design has been amended as follows:-

- The proposed CPZ will operate between 10am 4pm Monday to Friday;
- The provision of seven cycle hangars and 11 electric vehicle charging points have been integrated with the plans.

We are carrying out a statutory consultation on the introduction of permanent Traffic Orders for the proposed Streatham Wells CPZ.
