Reduced Operational Hours Statutory Consultation 10 January – 9 February 2025

Dear Resident/Business

The purpose of this leaflet is let you know the outcome of the statutory consultation carried out in August/September 2024 on proposals for a Controlled Parking Zone (CPZ) in the West Dulwich area.

What were the findings?

All representations received along with officers' recommendations were presented in a report which was considered by the Council. We would like to thank you for your participation in the consultation and for your feedback.

What are we proposing?

In light of representations received to the statutory consultation, a decision has been made to abandon the previous proposal and reconsult on a reduced hours CPZ, operational 12noon – 2pm Monday for Friday, for this area. The re-consultation with also take into account minor amendments to the scheme design as per feedback received. The amended proposals are:-

- Proposed operational hours 12noon 2pm Monday to Friday
- Maximum stay Pay by Phone period will be one hour
- Proposed shared-use resident and Pay by Phone bays outside Nos. 147 and 153 Rosendale Road will be replaced by single yellow line waiting restriction to enable residents of these properties access to their off-street parking areas via existing dropped kerbs;
- The proposed cycle hangar outside No. 66 Robson Road will be relocated to other side of the road opposite No. 69 Robson Road and the proposed cycle hangar outside No. 57 Tulsemere Road will be relocated into Towton Road along the side wall of No. 43 Hexham Road so that they are no longer directly outside residential properties;
- Proposed shared-use resident, business and Pay by Phone bays in Dalton Road will be converted to 'free' time limited bays (max stay one hour) to compensate for the loss of existing 'free' time limited bays in Chestnut Road,
- Proposed shared-use resident and Pay by Phone bays in Lancaster Avenue outside Lancaster Court will be converted to proposed shared-use resident, business and Pay by Phone bays; and
- The proposed disabled bay outside No. 9 Hexham Road has been removed to reflect that it is no longer in use and the supporting Traffic Order has been revoked.

Please note:

The proposed 'free' time limited parking bays adjacent to the shops on both Rosendale Road and Croxted Road, and the proposed loading on Rosendale Road, will remain at their original operational hours of 7am - 7pm Monday to Saturday. This is to ensure a turnaround of parking space for passing trade and align to existing 'free' parking shopper parking bays already in operation in Norwood Town Centre.

How can I give my views on the West Dulwich CPZ proposal?

We are carrying out a second statutory consultation on the introduction of permanent Traffic Orders for the CPZ. Notices of the Council's intentions to introduce these measures will be published in a local newspaper (South London Press), in the London Gazette and posted on lamp columns in the area.

The Council is required to give weight to the nature and content of your representations. Your reasons are therefore important to us.
