Dear Resident/Business

The purpose of this leaflet is to inform you of the Council's proposals to introduce healthy streets improvements and parking controls in your surrounding area and to seek your view on Probyn Road specifically.

What are we proposing?

We are proposing to introduce parking controls in your surrounding area.

This would take the form of parking controls as follows:

- A new Tulse Hill West 'J' Controlled Parking Zone (CPZ)
- An extension to the Brixton Hill 'F' CPZ
- An extension to the Tulse Hill 'H' CPZ

A consultation with properties in the affected areas is currently taking place.

As you may be aware Probyn Road falls within the Tulse Hill 'H' CPZ operational 8.30am to 6.30pm, Monday to Friday.

Probyn Road was included in the Tulse Hill 'H' CPZ in November 2020. At that time, those living and operating in neighbouring streets indicated that they did not support introduction of parking controls and these roads remained generally unrestricted,

Should the current consultation result in a decision to proceed with parking controls are in the wider Tulse Hill West area, we would like to give you, as a Zone H resident/business, the opportunity to tell us if you would like to either:

- remain part of the Tulse Hill 'H' CPZ; or
- be included within the new Tulse Hill West 'J' CPZ if it were to go ahead n.b. it is possible that a new CPZ would have different operational hours.

A benefit in moving into any new Tulse Hill West 'J' CPZ would be that if there were insufficient on-street spaces available to park in Probyn Road, your new 'J' permit would enable you to park in any street within the new Tulse Hill West 'J' CPZ, which are closer in proximity than other Tulse Hill 'H' CPZ roads.

Please give us your views by responding to the online survey. The responses will help us to determine whether Probyn Road should be part of any new Tulse Hill West 'J' CPZ or remain in the Tulse Hill 'H' CPZ.


