SEA Screening Assessment Addendum

1. Introduction

- 1.1 This is an addendum to the Strategic Environmental Assessment Screening Report for the Regulation 14 Pre-Submission, Kennington, Oval and Vauxhall Neighbourhood Plan (SEA Screening Report).
- 1.2 The Kennington, Oval and Vauxhall Neighbourhood Forum (the Forum) has now submitted an updated Kennington, Oval and Vauxhall (KOV) draft Neighbourhood Plan (the draft Plan) and supporting documents to the council in line with Regulation 15 of the Neighbourhood Planning (General) Regulations 2012.
- 1.3 This addendum assesses the changes made in the latest Reg 15 version of the draft Kennington, Oval and Vauxhall Neighbourhood Plan (the draft Plan), considering whether the conclusions in the previous SEA Screening Report remain. This addendum report confirms that the KOV NP is unlikely to lead to any 'significant effects on the environment', and that no further SEA is required.
- 1.4 The full version of the Strategic Environmental Assessment Screening report was previously consulted on with the necessary statutory bodies (Environment Agency, Natural England, and Historic England). This addedndum report will be consulted on alongside the submission version of the neighbourhood plan during the Regulation 16 consultation.

2. Background to the SEA

- 2.1 A draft Strategic Environmental Assessment SEA Screening Report was prepared for the Regulation 14 Pre-Submission, Kennington, Oval and Vauxhall Neighbourhood Plan by the London Borough of Lambeth (LBL) in April 2024.
- 2.2 The statutory bodies for the Environmental Assessment of Plans and Programmes (Environment Agency, Natural England and Historic England) were consulted on this draft screening report, to seek their view on whether an SEA would be required for the Regulation 14 Pre-Submission KOV NP.
- 2.3 All three bodies responded to the consultation, a copy of the responses are available in Appendix 1 of the Reg 14 SEA. Having reviewed the above advice, LB Lambeth concluded the Reg 14 KOV NP is unlikely to give rise to significant environmental effects, and no SEA is required.

2.4 The final Strategic Environmental Assessment (SEA) Screening Report incorporated the responses from the Statutory Bodies. This underwent public consultation between 31 March 2024 - 13 May 2024.

3. Assessment of changes

3.1 Table 1 (below) provides an assessment of the main changes to draft Plan between the Reg 14 and Reg 15 submission versions. This provides a description of the changes made, considering whether the change would result in a different conclusion to the previous SEA scoping assessment, and whether this would lead to any significant effects on the environment.

4. Conclusion

4.1 The assessment of the changes to the draft Plan are set out in Table 1. This finds that most changes are relatively minor in nature. These changes to the draft Plan are not considered to lead to any substantial different conclusions to those reached in the previous SEA screening Assessment for the Regulation 14 Pre-Submission, Kennington, Oval and Vauxhall Neighbourhood Plan by the London Borough of Lambeth. It is therefore concluded that the draft Plan is unlikely to result in any significant effects on the environment, therefore no further SEA is required.
