

**TARGETED HMO ARTICLE 4 DIRECTION 2024**

**LONDON BOROUGH OF LAMBETH**

**TOWN AND COUNTRY PLANNING (GENERAL PERMITTED DEVELOPMENT)  
(ENGLAND) ORDER 2015 (AS AMENDED)**

**A NON-IMMEDIATE DIRECTION MADE UNDER ARTICLE 4(1) TO WITHDRAW  
CERTAIN PERMITTED DEVELOPMENT RIGHTS RELATING TO CHANGE OF USE  
FROM DWELLINGHOUSES TO SMALL HOUSES IN MULTIPLE OCCUPATION IN  
STREATHAM COMMON AND VALE WARD AND STREATHAM ST LEONARD'S WARD**

WHEREAS the Council of the London Borough of Lambeth (the 'Council'), being the appropriate local planning authority within the meaning of article 4(5) of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended) (the 'Order'), is satisfied that it is expedient that development of the description set out in Schedule 1 hereto should not be carried out on the land shown edged and shaded in red (for identification purposes only) on the maps as listed and attached hereto in Schedule 2 (being land within Streatham Common and Vale Ward and Streatham St Leonard's Ward within the London Borough of Lambeth)(the 'Land'), unless planning permission for it is granted on an application made under Part III of the Town and Country Planning Act 1990 (as amended).

NOW THEREFORE the said Council in pursuance of the power conferred on it by article 4(1) of the Order hereby directs that the permission granted by article 3 of the said Order shall not apply to development of the description specified in Schedule 1 hereto in respect of the Land.


