

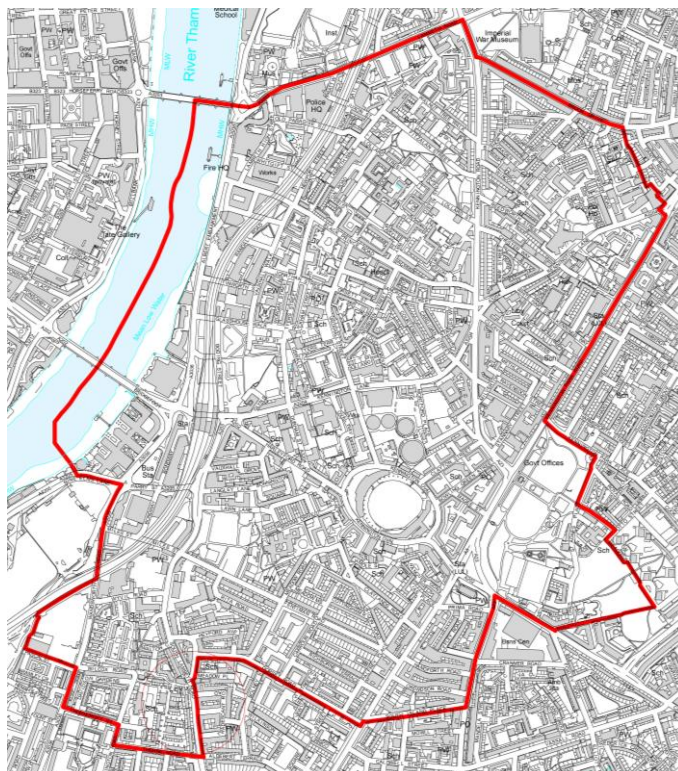
Kennington, Oval and Vauxhall Neighbourhood Plan – Referendum Information Statement

This information statement is published to accompany the referendum on the Kennington, Oval and Vauxhall (KOV) Neighbourhood Plan, which will take place on Thursday 11 December 2025. The information statement has been prepared to meet the requirements of Regulation 4 of the Neighbourhood Planning (Referendums) Regulations 2012, clause 3(a), as amended.

- (i) A referendum will be held to determine whether the Kennington, Oval and Vauxhall Neighbourhood Plan should be used to determine planning applications within the relevant neighbourhood planning area.
- (ii) The referendum will be held on Thursday 11 December 2025.
- (iii) The question to be asked in the referendum is as follows:

“Do you want the London Borough of Lambeth to use the neighbourhood plan for Kennington, Oval and Vauxhall to help it decide planning applications in the neighbourhood area?”

- (iv) A map of the referendum area can be seen below:



- (v) The referendum area is identical to the neighbourhood planning area.
- (vi) The following persons are entitled to vote in the referendum: all people who live within the boundaries of the neighbourhood planning area and are registered and eligible to vote in local elections.
- (vii) The referendum expenses limit for campaign organisers promoting a particular outcome is a total of £2,362 plus an additional 5.9 pence for each entry in the relevant local government electoral register applying to the referendum area on the day on which the referendum period begins. The number of registered electors within the referendum area on this date was 25,047. The total expenses limit is therefore **£3,839.77**.
- (viii) The referendum will be conducted in accordance with procedures similar to those used at local government elections.
- (ix) A set of 'specified documents' must also be published and made available for inspection alongside this information statement, in line with clause 3(b) of Regulation 4 of the Neighbourhood Planning (Referendums) Regulations 2012. These specified documents are:
 - The draft neighbourhood plan
 - The report made by the independent examiner
 - A summary of representations submitted to the independent examiner as part of the examination process
 - A statement that the local authority are satisfied that the draft neighbourhood plan meets the basic conditions of neighbourhood plans and other provisions contained in the legislation
 - A statement that sets out general information as to town and country planning (including neighbourhood planning) and the referendum
