Against Controlled Parking in Kingsmead Road and Streatham Hill

We the undersigned petition the Council to Suspend or cancel the proposal for a controlled parking zone in the Streatham Hill area, particularly on Kingsmead Road

The undersigned residents of Kingsmead Road strongly oppose the uncalled for imposition of a controlled parking zone on our road in particular and in the Streatham Hill area in general.

We do not feel that our road significantly suffers from problems caused by non-residential parking and, as such, we object strongly to any suggested requirement that residents and their guests should be required to pay for parking.

Residents who own cars object strongly to the proposal that they should be required to pay a significant amount simply for parking their cars outside their own property, particularly given that some residents have been refused permission for the installation of driveways and so are denied any other option.

Those of us without our own cars frequently rely on available parking in order that friends and relatives can park to assist us in situations where a car is required and, also, simply to visit socially. Some residents have friends and relatives who rely on cars as transport due to disability and, while we would not wish to lessen the amount of freely available parking on the road by insisting on the installation of disabled bays for non residents, it is outrageous that disabled friends and relatives should be required to plan ahead and to pay simply to visit as guests.

While these complaints are specific to Kingsmead Road, we would also ask that parking restrictions are not imposed in the surrounding area, as this creates the risk of existing parking being displaced onto our road, creating a parking shortage where none was previously in existence. I am 67 years old. I live with my husband and my daughter. I have worked for 16 years at the Job Centre dealing with unemployed people. I do care about people in need, and want to help them. I am interested in helping old people. I practice Music everyday for relaxation. Music therapy cures many illnesses and helps to maintain good health. It helps to forget the problems of old age. About 14 people meet at my house for Music practice Monday to Thursday from 1pm to 4pm. It gives them a great joy in Music practice. It also gives pleasure to me to see them cheerful and happy. Their age-range is from 62 to 75 years. They need parking space which is always there on this road. Putting a meter on this road will place a great burden on these people and they will be unable to come to the music practice sessions. The music sessions are free of charge for these old people.

The music group, like anybody else, also wants to take care of their own health. They want to be self-reliant in this respect and therefore there will be less pressure on the NHS. They do not want to depend upon medicine. The music helps them to a large extent. Their health may be affected by putting restrictions on parking. The controlled parking will create tension and worry on their minds. They are very passionate about their Music sessions, and they will be completely heart-broken.

I shall be thankful to you if you could look into the problem with compassion. Compassion is one of the great values of Great Britain.
