Thank you for your enquiry regarding breach modelling for Lambeth.

There are some known errors with the breach modelling as it currently stands in the Lambeth area. These primarily relate to some missing flow routes under the railway embankment providing some levels that we perhaps do not have full confidence in, along with the possibility of some missing extents. We are looking at updating our breach modelling this financial year using TE2100 in-channel levels. At the same time, we will re-evaluate these problems. In the meantime, this modelling is considered 'best available' that we are continuing to provide with some caveats.
