Will be employing additional volunteer staff for the days of the events for organisation matter. Will also be hiring security staff & fencing the gardens for safety at certain events.  
No supply of alcohol will be made on the premises to under aged people at a time when there is no designated premises supervisor.  
provision of alcohol will only be sold and supplied on the premises during authorised periods by this license and during planned festival as agreed and booked with Lambeth events.

b) The prevention of crime and disorder

It is agreed with the local police and private security firms on the night will be working from the Vauxhall One BID. Noise levels are going to be dealt with by the use of campaign to let all neighbors know about the shows taking place, which are unamplified.

Security staff will wear and display the correct identifications at all times when carrying out security activities at the premises. Female staff will be employed at the premises if body searches are to be carried out on female customers. We will have volunteer staff in charge of removing all bottles and glasses from public areas on a regular basis. All beverages will be served in plastic, paper or toughened glasses.

Any person appearing to be under the age of 25 years will be required to provide photographic proof of their age before being sold or supplied alcohol.

In the absence of adequate daylight, the lighting in any area accessible to the public and guests will be fully in operation when they are present.

**c) Public safety**

We will have access for emergency vehicles on the streets surrounding the park free from obstruction, and adequate & appropriate supply of first aid equipment and material will be available.

In the absence of adequate daylight, the lighting in area accessible to the public and guests will be fully in operation when they are present. The park has its own lighting system and people will be encouraged to use the main pathways in and out of the park.

**d) The prevention of public nuisance**

It will all be live music in order to not disturb nearby neighbours, even though they have all be addressed so as to be aware of the festivals and what will be going on.

There will be a proper and adequate control of litter generated by the premises and will be stored securely in a designated area.

Any amplified music will be sound checked so that it doesn't affect residential premises.

**e) The protection of children from harm**

This will be a family friendly event and will be contacting local schools to encourage kids to take part and participate.

There will be no nudity involved in the events.

All plays, shows and events going on are kid-friendly and suitable for children.

The license holder will ensure that no alcohol is sold to people under the age of 18.
