(AS AMENDED)*Designation of Conservation Areas*

Notice is hereby given that the Council of the London Borough of Lambeth, in pursuance of powers under section 69 of the Planning (Listed Buildings and Conservation Areas) Act 1990 (as amended), has designated 3 extensions to the following Conservation Areas: No. 1 (Clapham), No. 8 (Kennington) and No. 46 (Ferdale Road) on 21st July 1997, within the London Borough of Lambeth.

The extension to Clapham Conservation Area (No. 1) includes UCW House, Henry Twining Court and 177 Abbeyville Road.

The extension to Kennington Conservation Area (No. 8) includes the former Gaiu Bingo Hall (previously the Regal Cinema), Kennington Road, and the Black Prince Public House, Black Prince Road.

The extension to Ferdale Conservation Area (No. 46) includes the Ferdale Centre (Brixton College) and Nos. 118a, 120a, 122-128 Ferdale Road, and Nos. 148-164 Ferdale Road.

The objective of designation is to preserve or enhance the character or appearance of areas of special or historic interest, as distinct from individual buildings, to control developments in such areas and to stimulate and encourage measures to improve the environment.

Plans showing the areas are available for public inspection during opening hours (9.30 a.m. to 4.30 p.m.) at the Town Planning Advice Centre, Courtenay House, 9-15 New Park Road, Brixton Hill, London SW2 4DU. (495)

The Carmarthenshire County Council hereby gives notice that it has made and submitted to the Secretary of State for Wales for confirmation, an Order under section 14 of the Highways Act 1980, authorising the Council to carry out the improvement of highway; to stop up highway; and to construct new highway.
