Chaperones - We require information on the adults who will be taking care of the children. All those acting as 'chaperone' will be permitted to take care of a maximum of 12 children each. Applicants cannot act as chaperone even if they are licenced. The types of 'chaperone' you can use without supervision, would ONLY be the child's parent/legal guardian, staff directly from the child's main school, or a licenced chaperone. "Teachers" from other provisions will be classified as 'DBS checked staff' if declared as such by the applicant. The ratio of child to chaperone must not exceed 12:1.If DBS checked staff are being used, there are some conditions that apply; You (the applicant) will declare that a clear DBS disclosure for each member of staff listed as 'DBS checked staff' has been seen. It will remain the applicant's legal duty to ensure all declarations are valid and all persons used in this capacity are safe to be in contact with children. At least 1 licenced chaperone per 10 'DBS checked members of staff must be hired. The licenced chaperone will be there in a supervisory and advisory role only (unless for emergency).
