**PROPOSALS TO CONVERT PEDESTRIAN CROSSINGS SITUATED IN LARKHALL LANE AND THE PAVEMENT INTO PARALLEL PEDESTRIAN AND CYCLE CROSSINGS**

*[NOTE: This Notice is about proposals to convert an existing zebra pedestrian crossing situated in The Pavement and another situated in Larkhall Lane, into parallel zebra pedestrian and cycle crossings. Comments are invited – see paragraph 5.]*

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth proposes, under section 23 of the Road Traffic Regulation Act 1984, to convert the existing zebra pedestrian crossings into parallel zebra pedestrian and cycle crossings at the following locations:-

(a) in Larkhall Lane by Gaskell Street; and

(b) in The Pavement by Bromell's Road.

The zig-zag markings on either side of the existing crossings (on which vehicles are banned from stopping at any time) would be modified to accommodate the new crossings.

2. The proposal to convert the existing crossing in The Pavement by Bromell's Road into a parallel zebra pedestrian and cycle crossing is necessary because of an anticipated increase in the number of pedal cyclists travelling between the existing cycle track around Clapham Common and the Cycleway 5 route which runs along Bromell's Road. Lambeth's Cycleway 5 route is being upgraded at various locations, as part of the council's emergency Covid-19 transport response programme. The overall aims of the programme are to: reduce road danger and help residents to socially distance safely, boost safe and sustainable transport to support the borough's economic recovery, and improve air quality. Converting the existing crossing on The Pavement will improve safety for all road users by providing separate areas for cyclists and pedestrians to cross the road. The proposal to convert the existing crossing on Larkhall Lane by Gaskell Street into a parallel zebra pedestrian and cycle crossing is necessary to enable more local cycling in the area off the Cycleway 5 route. This improvement is being delivered as part of our Healthy Route Network improvements programme.
