

As part of Vauxhall One's work to create a safer Vauxhall the BID works extremely closely with all local policing groups, including counter terror officers, as well as Lambeth Council's licensing, events and regeneration teams, the BID also co-funds three additional full time met police officers for vauxhall, 6 cctv cameras and promotes the Business Crime Prevention Radio service to it's members. At all Vauxhall One events there will be a team of professional stewards, who are in contact with each other and also have access to the phone numbers of local police officers, all events will only ever feature a small bar which will be closed by 10pm, with no glass bottles, etc. being used. All Vauxhall One staff have undergone project Griffin and Agrus training. First Aid kits, including acid attack response kits will be on hand at every event.

Importantly all events held by Vauxhall One will be of a small, free and community focused nature, aimed not at attracting the highest number of people or making money from the sale of alcohol, but rather at benefiting the local economy, improving perceptions of the area, and animating the park in the early evening.

b) The prevention of crime and disorder

Continued from previous page...

Vauxhall One pay for additional CCTV cameras that cover the Pleasure Gardens, as well as equipment for local policing teams to monitor these cameras on the go.

All events will include a professional steward team who wear easily identifiable hi-vis vest and Security Industry Authority badges clearly displayed at all times. The stewards are briefed before each event on timings, lay out, emergency procedure etc. Vauxhall One's S92 Police Officers will be contactable at all times.

c) Public safety

Full risk assessments will be submitted before each event, and all staff will be made aware of the assessment and precautionary measures, a copy of the risk assessment will be available at all events.

First-aid kits with sufficient in date stock will be kept at all events as well as at least one member of staff with a recognised qualification in first aid attending each event. No glass will be allowed to be sold at any event on Vauxhall Pleasure Gardens. Acid Attack medical response kits will be kept at each event, including but not limited to :

6x Bottles of Water - 500ml

1 x Roll of Burn Kling (Cling Film)

1 x EN14126 Compliant Disposable White Coverall (Size Large)

1 x FFP3 Valved Face Mask

1 x Safety Goggles (EN166)

1 x Tuf Cut Heavy Duty Shears - Red

1 x Pair of Heavy Duty Nitrile Gloves with Extended Cuffs

2 x Clinical Waste Bags (Size Medium)

1 x Litmus pH Test Paper with pH Chart

1 x Guidance Card on First Aid for Burns

2 x Sterile Eye Pads

Vauxhall One are in regular contact with Counter Terror policing teams and are updated on local and national issues. All team members have undergone project Griffin and Argus training, as well as Run, Hide, Tell.

Evacuation roles and responsibilities will be clearly communicated to staff before each event. A number of fire extinguisher will be on site at all events. A zero tolerance policy to the use of drugs will be in place. Drunk people will not be served at any bars.

d) The prevention of public nuisance

A noise management policy will be in place for all events. Where possible any speakers will be directed away from residential blocks towards the railway tracks. All events will be finished by 10:30pm with the site cleared by 11pm latest and no event will start earlier than 11am. A contact number will be made available to local residents and businesses which they can use to report a noise disturbance. At the end of events, attendees will be asked to leave quietly and directed away from the park by stewards.

e) The protection of children from harm

A strict No ID - No Sale policy and challenge 25 scheme will be in place bars at all events. Only driving licenses, passports and PASS cards will be accepted as ID and the scheme will be prominently advertised. All children must be supervised by adults at all times at any event. Any event that children would want to attend, would be family focused community events that are small in scale and end early.

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this by providing with this application copies or scanned copies of the following documents (which do not need to be certified).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is a British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A **full** birth or adoption certificate issued in the UK which includes the name(s) of at least one of the holder's parents or adoptive parents, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.

- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 17(3) or 18A (2) of the Immigration (European Economic Area) Regulations 2006, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
