#### OFFICE USE - SUMMARY OF ACTION

**Part 1 Poisons List:** No action required.

**Part 2 Poisons List:** Send forms, poisons list and info sheet.

Upon receipt of forms check that they have been completed correctly and the fee has been paid. Check that the poisons are solely Part 2 Poisons. Check that any quantities of Schedule 1 Poisons allowable under Part 2 are not exceeded. A premises inspection is only necessary for Part 2 Poisons if Schedule 1 poisons are included. If they are not and the foregoing is satisfactory, the licence can be issued.

POISONS ACT RULES 1982

Poisons are divided into three categories

<u>Part 1 of the Poisons List</u>	<u>Part 2 of the Poisons List</u>	<u>Schedule 1 of the Poison Rules</u>
	The public is more likely to require access to these. They also have more retail outlets	Almost all of these are pesticides. Also included are substances from both Part 1 and Part 2 of the Poisons List.

In order to be entered onto the list a person/retailer must:

- 1) Complete an official form and
  - 2) Pay a prescribed fee.
- Ensure that the poisons to be sold are solely Part 2 poisons.
  - Where applicable, ensure that the quantities of Schedule 1 poisons allowed under Part 2 are not exceeded. See attached list of quantities.

Under section s.3 (2) of the Act it is not lawful to sell a poison listed in Schedule 1 of the Poisons Rules unless one of the following conditions has been met:

- 1) The buyer has been certified by an authorised person OR
- 2) The buyer is known by the seller (or by a pharmacist on the premises) to be a person to whom the poison may properly be sold

Record Keeping of Schedule 1 Poisons

The retailer or pharmacist must enter each sale of a **Schedule 1 Poison** in a poison book.

The following information must be included:

- 1) the date of the sale
- 2) the name and address of the purchaser
- 3) the name and address of the person issuing a certificate (if applicable)
- 4) the name of the poison and the purpose for which it is required
- 5) the purchaser must sign the entry.

If the poison is to be used for trade or business purposes and the purchaser gives a signed order stating their name, address, business and the quantity and proposed use of the poison, the entry in the Poisons Book need only read "signed order" with a reference number

The book must be kept for 2 years after the date of the last entry.

### Storage of Schedule 1 Poisons

In shops, **Schedule 1** poisons must be stored either:

- 1) in a specially reserved cupboard or drawer, or
- 2) in a partitioned or separate area of the premises to which customers do not have access, or
- 3) on a shelf reserved for poisons

All poisons must be kept well away from food.

### Containers

The Poisons Rules contained a number of requirements relating to packing and labelling, which have now been replaced by the provisions of the appropriate Classification, Packaging and Labelling Regulation.

There are now only 2 remaining provisions specific to "POISONS":

- 1) Compressed hydrogen cyanide must be sold in a container labelled with the words "Warning. This container holds poisonous gas and should be opened and used by persons having expert knowledge of the precautions to be taken in this use."
- 2) Bottles containing 1.14 litres or less of any poison must be fluted vertically with ribs or grooves recognisable by touch. This does not apply to sales for export or for the purpose of scientific education, research or analysis.
