

1. Introduction

1.1 Lambeth is a varied and dynamic borough comprising Waterloo in the north, home to the capital's cultural hub on the Southbank, Brixton with its vibrant markets at the centre; and the leafy suburbs of Streatham and West Norwood in the south. The borough's historic environment adds richness and there is a duty to preserve or enhance the setting of the boroughs 62 conservation areas and protect over 2,000 statutory listed buildings. At the same time Lambeth offers great opportunity development across the borough, particularly in respect to Waterloo Opportunity Area and Vauxhall, Nine Elms and Battersea (VNEB) Opportunity Area. The delivery of jobs and housing growth through the creation of sustainable new places and buildings that positively respond to Lambeth's character is central to the borough's design aspirations.

1.2 The Quality of the Built Environment (Q) policies within the Lambeth Local Plan (2015) set out the expectation for design excellence. As part of Lambeth's commitment to design excellence the Design Review Panel (DRP) provides an additional service as an integral part of the planning process in line with the National Planning Framework (NPPF) and London Plan.

1.3 The DRP is not a substitute for the established and effective internal capacity within the Council's Conservation and Design team. Instead the expertise of DRP members provides supplementary expert advice.

2. Role of the Panel

2.1 The DRP is made up of a pool of independent built environment professionals who provide design advice on new development and public realm proposals. The pool has twenty-nine members (including three Chairs) with expertise in urban design, architecture, landscape architecture and engineering. Each review panel will normally comprise four members and a Chair drawn from the pool.

2.2 It is important that development schemes are reviewed at an early stage so that the panel input can influence the evolution of the scheme. For that reason schemes should go to review whilst at pre-application stage. However, where necessary, planning applications can also be reviewed but applicants must approach review with an understanding that design amendments may be required.

2.3 The types of schemes that may be referred to the DRP include:

- Large/Small/Minor Major (10 units plus) schemes
- Infrastructure projects
- Large public realm proposals
- Site specific masterplans, design codes and design guidance
- Schemes being developed through Planning Performance Agreements (PPAs)

2.4 It should be noted that PPA schemes will normally be presented to the Council's Strategic Panel prior to going to the DRP. Small schemes may be referred to the panel where the Council thinks they might benefit from review.



Design Review in the Planning Process


3. Membership

3.1 The DRP pool comprises twenty-nine members including three Chairs. The multidisciplinary members (representatives from the fields of architecture, urban design, town planning, landscape, built heritage, engineering, sustainability and building surveying) were recruited through online advertisements.

3.2 In selecting from approximately 140 submissions the Council is confident that the panel members have shown experience in and a passion for their chosen field. The Council has also endeavoured to draw representation of those from ethnic minorities, to ensure a spectrum of ages including younger professionals, and a gender balance.

3.3 The DRP pool will be refreshed every two years when applicants will be invited through advertisements in relevant architectural and design publications. Applicants will be required to submit a CV and a covering letter explaining their experience and setting out how they are able to contribute positively to the role. They will also be required to specify whether they wish to be considered for a Chair position. Existing panel members who wish to be considered again will be required to apply afresh. Selection of panel members will be undertaken by Lambeth Council officers. Selection of panel chairs will be undertaken by Lambeth Council officers with input from the Council's Design Champion and the Chair of the Planning Committee.

3.4 Upon recruitment all members will be invited to attend an induction event and asked to sign the declaration at the end of this document. The Council reserves the right to terminate the contract of any DRP member should it consider that their contribution is no longer required.

4. Chair & Panel Responsibilities

Chair Responsibilities


4.1 The Chairs will lead the reviews by structuring the session, mediating the discussion (ensuring that each panel member is given an opportunity to express their impartial view), and agreeing the constructive summary of the session that captures the view of the panel as a whole. The Chair's letter will form the written record of the review.

Member Responsibilities

4.2 All members (including Chairs), must provide impartial and expert oral advice during review sessions.

4.3 Two weeks prior to review day the relevant members will receive notification that their attendance is required. One week prior to the meeting a briefing note with scheme information and proposal for each scheme will be circulated for scrutiny in advance.

4.4 Panel members commit to attending the entirety of a review day including the site visits. If a member is unable to attend a review day, a minimum of one week's notice should be given to allow a substitute to be found.



6.1 The effectiveness of the DRP will be monitored for:

- Impartiality, relationship with the Council
- Quality of the advice
- How advice has influenced design outcomes
- Developer perceptions

6.2 The AGM will provide an opportunity for evaluation and the celebration of its contribution to the quality of new development.

7. Presentation Material

7.1 In most instances, the material submitted as part of the pre-application submission will be sufficient for the presentation to the panel. If a scheme is reviewed at a very early stage it is acknowledged that fully rendered views and detailed designs may not be available. In these cases applicants are strongly encouraged to bring illustrative materials and physical models are encouraged to help explain their thought processes to date.

7.2 The following topics should be touched upon in the presentation:

Essential

- Brief and project context what is the purpose of the project?
- Contextual analysis information showing an understanding of the wider context, in architectural, townscape, socio-economic and cultural terms, ownerships, proximities to heritage assets or open spaces and any relevant policy context (masterplans, opportunity areas, adjoining development sites)
- Connectivity– urban grain, street patterns, pedestrian and vehicle movements in and around the site.
- Design principles what is the concept?
- Design development this can be shown using diagrams and sketches.
- Building mass clearly shown in context.
- Plans, sections and elevations depending on the project, these drawings will vary in scale. Applicants may also wish to have a particular areas of focus.
- Views and panoramas depending on the stage of the project views can vary from sketches to full rendered images. Applicants should consider which views to show carefully, particularly if there are any potential heritage impacts.

• Energy efficiency / Sustainability – where applicable and including wind, sun, and microclimate modelling where applicable.

We suggest including preliminary microclimate studies for developments where outdoor spaces and public realm are considered key to the design strategy and concept. This should include Sun/Shade diagrams and Sun exposure (hrs) as well as wind studies. In some cases the following may be required

- Detail drawings these drawings will be relevant if there is a specific technical focus to the project such as in the area of sustainability or if there are any key material treatments that form part of the proposal.
- Physical models especially where the scheme has not been worked up in detail or where master planning is being undertaken.
- · Material samples where a scheme is worked up in detail.
- Public realm strategy including material approach
- Landscape strategy in some cases where landscape forms a key
 part of the project comprehensive detail on species, number and size
 will be important in order for the panel to assess the scheme.
- Heritage or Habitat Assessments depending on context.

We strongly advise the use of electronic presentations. Large screens will be available on the day for developers and design teams to present. Whilst presentation boards can be useful paper copies of presentations should be kept to a minimum in order to reduce waste.

8. Review Types

8.1 There are three types of Design Review:

(i) Full Review, (ii) Follow-Up Review

8.2 A full is the first time a scheme has been to DRP. A follow-up review is when a scheme returns for further panel assessment. Both reviews will be undertaken by one Chair and four panel members. The session will typically be $1 \frac{1}{2}$ hours long:

- Applicant presentation (20 minutes)
- Panel questions and discussion (up to 50 minutes)
- Chair summary of the issues (20 minutes)
- 8.3 Full and follow up reviews cost £4,500 plus VAT.

(iii) Chair Review

8.4 A Chair review comprises one chair and one panel member and as a result will normally be shorter:

- Applicant presentation (15 minutes)
- Panel questions and discussion (30 minutes)
- Chair summary (10 minutes).

8.5 A Chair review costs £2,500 plus VAT.

8.6 Fees must be paid prior to the review session taking place. Reviews can be tailored to meet specific requirements of a project. Please contact LambethDRP@Lambeth.gov.uk DRP or your assigned Planning Officer if a tailored approach is required.

How to Apply To Have Your Scheme Reviewed

8.7 To apply to have your scheme reviewed by The Panel you will need to <u>apply</u> on the Lambeth website.


8.8 Once your application for review has been processed and your scheme has been reserved a DRP slot by the Conservation and Urban Design Team, you can pay for your review.

8.9 Your slot will be confirmed upon payment.

8.9 Please be aware that if you cancel your Design Review within 14 days of your review date you will be charged a cancellation fee for the full Design Review amount.

Payment

8.10 We accept <u>payment by card online</u>. Payment can also be made by way of an invoice – if you wish to pay in this way, you must advise invoicing details at least 28 days in advance of your planned review date – an invoice will be issued within 7 days and payment must be made immediately upon issue of the invoice (see 8.9 above). 9. Review

9.1 Design Review is normally held once a month with up to three schemes being assessed. Whilst the meeting dates for the year are agreed in advanced additional reviews can be accommodated should demand require it.

9.2 The review day will comprise:

Morning

Panel members undertake a site visit accompanied by Council officers. The applicant is not present.

Lunch

The panel have the opportunity to review the officer briefing notes following the site visit.

Afternoon

Applicants, relevant planning and design officers will be present during the review. The design officers will take note of the panel discussion to inform the content of the Chair's advice letter.








The final presentation should expand on the summary presentation and not present a substantially different scheme.

10. Principles of Design Review

10.1 Lambeth's DRP will follow the ten principles of design review from the Design Council CABE:

Independent - It is conducted by people who are unconnected with the scheme's promoters and decision makers, and it ensures that conflicts of interest do not arise.

Expert - The advice is delivered by suitably trained people who are experienced in design, who know how to criticise constructively and whose standing and expertise is widely acknowledged.

Multidisciplinary - The advice combines the different perspectives of architects, urban designers, town planners, landscape architects, engineers and other specialist experts to provide a complete, rounded assessment.

Accountable - The Design Review Panel and its advice must be clearly seen to work for the benefit of the public. This should be ingrained within the panel's terms of reference.

Impartial - The advice is informed by independent experts, people who are unconnected with the scheme's promoters and decision makers, and it ensures that any potential conflicts of interest are managed in an open and transparent way.

Transparent - The panel's remit, membership, governance processes and funding should always be in the public domain.

Proportionate - It is used on projects whose significance either at a local or national level, warrants the investment needed to provide the service.

Timely - The advice is conveyed as early as possible in the design process, because this can avoid a great deal of wasted time. It also costs less to make changes at an early stage.

Advisory - The Design Review Panel does not make decisions, but it offers impartial advice for the people who do.

Objective - It appraises schemes according to reasoned, objective criteria rather than the stylistic tastes of individual panel members.

Accessible - Its findings and advice are clearly expressed in terms that design teams, decision makers and clients can all understand and make use of.


11. Feedback Letter

11.1 Following a review, a draft advice letter will be provided to the panel Chair for review and agreement. The letter will contain a summary of the discussion, comments and recommendations made by the DRP. We aim to issue the advice letter to applicants within 10 working days of the review.

11.2 Panel advice (verbal or written) is independent, impartial and non-statutory. Before responding to panel feedback, applicants are advised to discuss feedback panel with relevant Council officers as part of arranged PPA meeting or as a follow-up pre-app meeting.

11.3 Should applicants not take on board the advice of the DRP they must robustly justify their chosen approach in the Design and Access Statement accompanying their subsequent planning application.

11.4 In keeping with established pre-application and PPA processes the DRP letter is confidential and will not be made publically available until after the submission of a planning application. DRP letters for schemes that do not require planning permission will be made available when any other statutory approvals or formal decisions are made. DRP advice will be summarized in planning reports.

13. Conflicts of Interest

13.1 Panel members are expected to act in the public interest and adhere to the seven Nolan Principles of Public Life

13.2 Members are notified in advance of the schemes coming before the panel. Panel members who have a financial, commercial or professional interest in a project, its client and/or the site; or a personal relationship with an individual or group involved with the project (where that relationship prevents the panel member from being objective) have a prejudicial interest in the proposal. In such cases members should contact LambethDRP@lambeth.gov.uk and withdraw from that particular review.

13.3 If a prejudicial interest is identified on the day of the review the member should declare it and should not take part in the review.

13.4 Where a conflict of interest is personal, but not prejudicial, the panel member may be allowed to participate in the review. However, it is essential that interest is declared at the beginning of the review and recorded in the final advice letter.

13.5 If a panel member is approached to become involved in sites that have been presented to the panel which they sat on, they should not do so for a period of at least 24 months after the council has determined the scheme.

14. Confidentiality

14.1 Confidentiality is essential in order for Lambeth's Design Review Panel to provide a constructive and reliable forum for developers. All members must sign the declaration below, agreeing to abide by these terms of reference including the confidentiality requirements as set out below.

14.2 As the majority of schemes reviewed will be at pre-application stage confidentiality is required. For that reason the DRP panels are not public meetings. Reviews are only to be attended by panel members, Lambeth Council officers and officers from statutory bodies involved in the project if they are invited by the Council (e.g. Design for London, Historic England, the GLA, etc.), as well as the developer and their design team. Additional attendees must be agreed in advance by Conservation & Urban Design Team Manager and the scheme applicant.

14.3 The panel's advice will be provided in the form of a confidential letter containing a summary of the deliberations and the key points arrived at in discussion by the panel. Panel members shall keep confidential all information provided to them and shall not use that information for their own benefit, nor disclose it to any third party unless they have the agreement in writing of the applicant and the council.

14.4 If any developer, architect or agent approaches a panel member for advice on a scheme that is subject to design review (before, during or after), they must decline to comment and refer the applicant to lambethdrp@lambeth.gov.uk

15. Declaration
