Newly signed S106 agreements

In addition to the 23 S106 agreements that were signed during the first six months of 2012/13, there were 40 S106 agreements signed between October 2012 and March 2013. Nine of these agreements involved financial contributions over £100k. These are:

- **Becket House and York House:** £7,935,063 for affordable housing, public transport, streetscape, parks and open spaces, libraries, employment and training, and local labour in construction.
- **199 Westminster Bridge Road:** £2,239,828 for parks and open spaces, streetscape, public transport, local labour in construction, employment and training, libraries, and travel plan.
- **30-60 South Lambeth Road:** £964,615.45 towards development infrastructure for the Vauxhall Nine Elms Battersea area, streetscape,




parks and open spaces, public transport, employment and training, local labour in construction, and travel plan.

- **Eastbury House:** £792,003.60 towards development infrastructure for the Vauxhall Nine Elms Battersea area, streetscape, playspace for children and young people, employment and training, local labour in construction, and travel plan.
- Land bound by Ardwell Blairderry and Barhill Road: £386,508 for education, parks and open spaces, streetscape, traffic and highway, car club, travel plan, libraries, local labour in construction, and employment and training.
- **34-36 Bedford Road:** £296,181.17 for education, parks and open spaces, libraries, health, sport and leisure, revenue maintenance, local labour in construction, and travel plan.
- Land Opposite 251-275 Milkwood Road: £216,067.79 for education, parks and open spaces, health, sport and leisure, libraries, revenue maintenance, local labour in construction, car club, and travel plan.
- **604-610 Streatham High Road:** £166,418 for education, parks and open spaces, libraries, health, sport and leisure, public art, local labour in construction, revenue maintenance, and travel plan.
- Wayland House, 48 Robsart Street: £124,111 for parks and open spaces, education, health, children and young people play space, sport and leisure, libraries, revenue maintenance, and travel plan.

Record Growth

The value of S106 agreements negotiated has increased significantly in 2012/13 in comparison to previous years since the economic downturn. The trend is likely to continue in the next few years.





For the first three months of 2013/14 alone, the Council has already negotiated 11 S106 agreements with financial contributions totalling £5m and also received over £3m in S106 receipts.

Balance at Year End

At the end of 2012/13, there was a balance of \pounds 12.2m in S106 funds available for the Council to spend on development mitigation measures. This has been profiled for the next three financial years as set out below.
