

Lambeth Housing Estates

Housing estate/private roads remain unaffected by these proposals. However, in the event that a CPZ is introduced, residents who live in housing estates or private roads in a CPZ can buy parking permits to park on the public highway roads within their specific zone.

In anticipation of possible vehicle displacement onto Housing Estates in the vicinity, Lambeth Housing Services will be contacting Housing residents on the potential introduction of parking controls on their Estates.

How can I give my views?

A Notice of the council's intentions to introduce these measures will be published in a local newspaper (Lambeth Weekender), London Gazette and posted on lamp columns in the area.

Representations for and against the proposals described in this Notice must be made in writing to: **Parking Design, Capital Programmes, P.O. Box 734, Winchester, S023 5DG** or email cpzconsultation@lambeth.gov.uk quoting reference **STREATHAM HILL EAST CPZ** by no later than **29 November 2019**.

Objections must relate only to the elements of the scheme that are subject to this statutory consultation. All representations along with Officers' comments and recommendations will be presented in a final report to be considered by the council. This report will set out whether the council will introduce a CPZ in the area, and if so, which roads will be subject to such controls. The council is required to give weight to the nature and content of your representations and not necessarily the quantity. Your reasons are therefore important to us.

A copy of the proposed Traffic Management Order, breakdown of the consultation results, detailed plans of the proposals and the council's Statement of Reasons relating to the scheme can be inspected at Brixton Library and Tate Streatham Library. Statutory Consultation

1 November – 29 November 2019



Dear Resident/Business

The purpose of this leaflet is to let you know the outcome of the Stage 1 Consultation carried out from 2 August 2019 to 30 August 2019 on proposals to introduce a controlled parking zone (CPZ) in your area and to explain the next stage of the process.

The results of the consultation along with your views and officers' recommendations were presented in a report that was approved by the council on 30 September 2019. The report is available online at www.lambeth.gov.uk/shcpz. The council agreed to proceed with a statutory consultation to include Faygate Road, Hailsham Avenue and Lydhurst Avenue as an extension to the proposed new Streatham Hill East 'M' CPZ to be operational Monday to Friday between 10am and 12noon. Keymer Road and Mount Nod Road are excluded from this Statutory Consultation.

The consultation results for the area are summarised as follows;

- The consultation resulted in 54 replies from this area, representing a response rate of 19.2%;
- Overall a majority 53.7% consider that they currently do not have parking problems in their road;
- There was a 50/50 split between support and opposition for a CPZ; however, a majority of 55.6% support controls if a CPZ were to be introduced in neighbouring roads;

The majority of respondents from Keymer Road and Mount Nod Road were not in support of parking controls. Therefore, controlled parking measures are NOT being proposed for these roads. However, double yellow line waiting restrictions are proposed at junctions to prevent parking obstruction and safety issues.

In line with the decision to include the Hailsham Avenue Area into the proposed Streatham Hill East CPZ the plan overleaf indicates a visual representation of the consultation results and shows the boundary of the proposed Streatham Hill East CPZ which include roads within the Hailsham Avenue Area.

The results of the consultation along with officers' recommendations will be presented in a report to the Deputy Leader of the Council (Environment and Clean Air). Once a decision is made you will be informed accordingly.

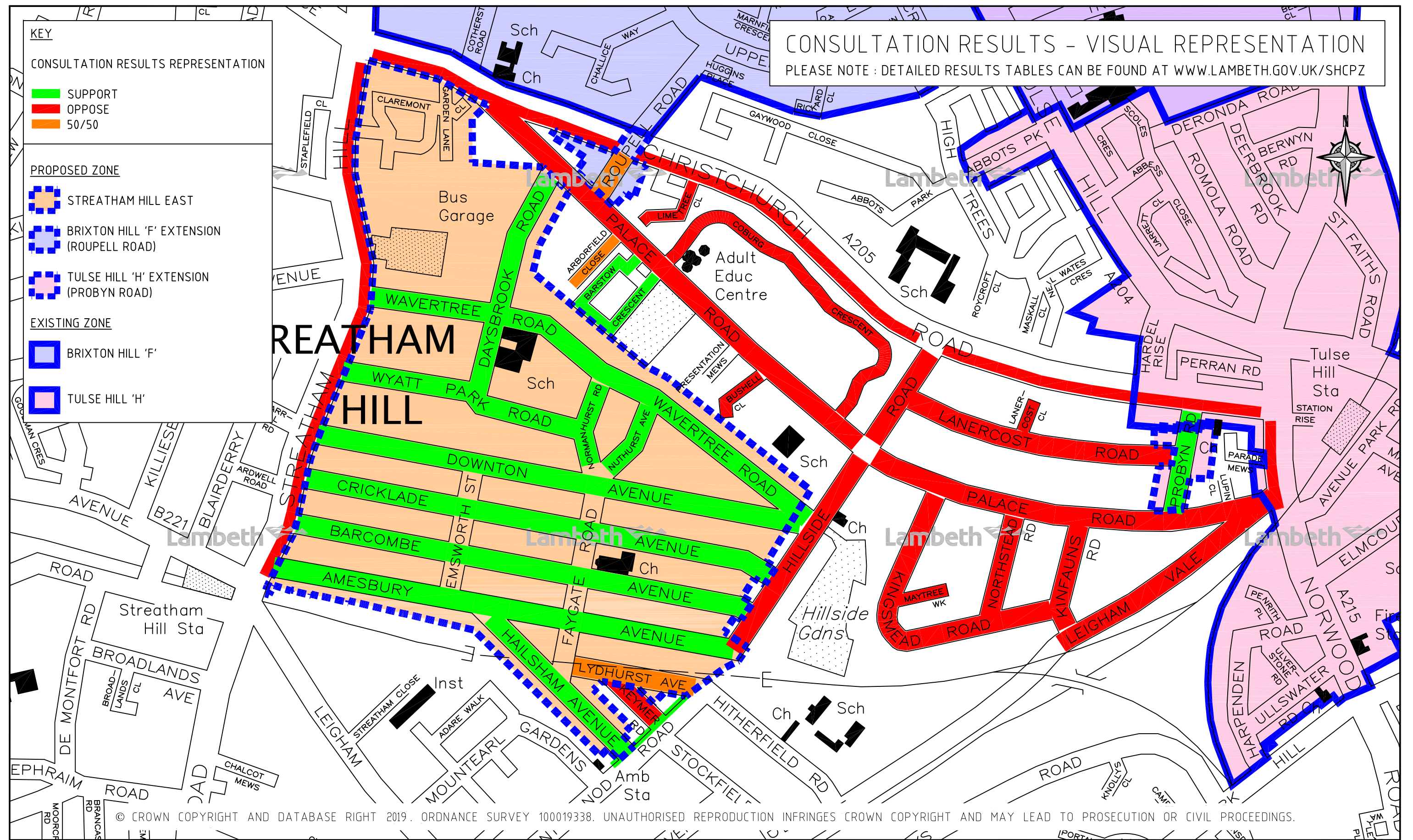
