ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14

TEMPORARY TRAFFIC AND PARKING RESTRICTIONS FOR CARRIAGEWAY RESURFACING, PLANNED MAINTENANCE AND TRAFFIC CALMING WORKS

1. NOTICE IS HEREBY GIVEN that, to enable carriageway resurfacing, planned maintenance and traffic calming works to be carried out, the Council of the London Borough of Lambeth, subject to the agreement of Transport for London and Southwark Council, intend to make an order the effect of which would be to temporarily ban vehicles from entering or waiting (including waiting for the purpose of loading or unloading a vehicle) in the streets and parts of streets specified in the Schedule to this notice.

2. Whenever the bans referred to in paragraph 1 above apply in relation to **(a)** Brixton Station Road, between Popes Road and Barrington Road; **(b)** Caldecot Road; **(c)** Carlisle Lane; **(d)** Concert Hall Approach; **(e)** Cosser Street; **(f)** Cowthorpe Road; **(g)** Cutcombe Road; **(h)** Flaxman Road; **(i)** Fount Street; **(j)** Frazier Street; **(k)** Harborough Road; **(l)** Killyon Road; **(m)** Lowden Road; **(n)** Murphy Street; **(o)** Pensbury Place; **(p)** Popes Road; **(q)** Royal Street; **(r)** Rozel Road; **(s)** Sandell Street; **(t)** St Faiths Road; **(u)** Stanthorpe Road; **(v)** Upper Marsh; and **(w)** Western Road, the Orders that impose the one-way systems or no entry into those roads would be suspended.

3. Alternative routes would be available for vehicles affected by the bans described in paragraph 1 above, via adjacent streets as indicated by traffic signs.

4. The bans and suspensions would only apply at such times and to such extent as shall be indicated by the placing and covering of the appropriate traffic signs.

5. The order would come into force on 1st August 2020 and would continue for a maximum duration of 18 months or until the works have been completed whichever is the earlier.
