London Borough of Lambeth Childcare Sufficiency Assessment (Updated 2008)

Introduction

Local Authorities have a legal duty under the Childcare Act 2006 to undertake a study of the local childcare market every 3 years. London Borough of Lambeth undertook this process in 2007 and produced a Childcare Sufficiency Assessment (CSA).

The Childcare Sufficiency Assessment (CSA) aims to assist the Local Authority to better understand and manage the local childcare market to enable parents to work or undertake education and training. It does this by mapping the demand of childcare against what is currently available. The focus of the report is the private, voluntary and independent childcare providers for children aged 0-14 years, and up to 18 year for children with a disability, as well as nursery education provision for 3 and 4 year olds, where local authorities have the duty to provide 15 hours free nursery education.

This Childcare Sufficiency Assessment (CSA) Report 2008 provides updated information about childcare sufficiency in Lambeth. It uses updated sources of information obtained from the Families Information Service, 2001 Census, and the Office for National Statistics to provide information about supply and demand of childcare in 2008, and compares the information found in 2007 to draw conclusions about gaps that have been met, gaps that remain and new gaps that have emerged.

The report also links findings to the CSA Action Plan 2007-2008 that was developed as an outcome to the CSA 2007 to ensure the actions prioritised are effective in addressing identified gaps in the childcare market.

Section 1: Key Messages

About Lambeth

- Lambeth has 51,594 children and young people aged 0-14 years, representing 18% of all Lambeth residents (285, 580)
- There are large numbers of children and young people in the south west and south east localities of the Borough
- Lambeth has a higher overall level of deprivation than in 2004, and is now the 5th most deprived borough in London, with clusters of affluence and severe deprivation throughout the wards
- The population is ethnically diverse with large concentrations of Black Minority Ethic (BME), Asian and European residents in some wards

About Lambeth's Childcare Provision

- The borough has wide provision of childcare for all age groups
- In 2008 there are 13% more childcare places for the 0-4 age group than in 2007
- The spread of places is uneven across the Borough, and in particular an undersupply of places for 0-2 year olds in the South West and South East of the borough
- Overall there are more vacancies in 2008 than in 2007, from 1,336 vacancies in 2007 to 1,566 in 2008, an increase of 15%
- Costs of childcare are unevenly spread across the borough. The South West locality has some of the most expensive PVI childcare costs, particularly in Clapham Common and Thornton wards. Yet the most expensive costs in the childminder sector are found in Thurlow Park and Prince's wards, which are located in the South East and North localities respectively)

It is clear that there is scope to improve childcare sufficiency across the Borough including:

- Ensuring better allocation of places to areas of highest demand, particularly for 0-2 year old places
- Exploring reasons for high vacancy rates in comparison to relative availability of places in the 0-4 year old provision, to ensure parents needs in accessing childcare are met
- Further examination of the population and needs of children with disabilities, and the current available provision for children with disabilities
- Ensuring equitable childcare costs across the Borough
- Increasing access by families on low incomes, lone parents and those on benefits to financial initiatives that will assist them to access childcare such as the free entitlement for 2, 3 and 4 years olds and the child care element of working tax credit for working parents
- Further examination of childcare provision for children over 5 years, to ensure demand for this sector is being addressed

Section 2: Indicators of Childcare Demand

Population

- Lambeth's population of adults and children has increased by 12331 people from 2007, with a total of 285,580 people in 2008
- Coldharbour ward has the largest number of adults and children of all Lambeth wards and Bishop's ward the smallest number

GLA 2007 Round ward population projections for 2008

Overall population 0-4 years:

- There are 20,545 0-4 year olds in Lambeth , representing 8% of the total Lambeth population
- Largest numbers of 0-4's are found in Coldharbour, Stockwell, Knights Hill and Larkhall wards in this order. This data matches population data of 2007 except Prince's ward no longer has one of the largest 0-4 populations
- Smallest numbers of 0-4's are in Bishop's, Thurlow Park and St Leonard's wards in this order

Population 0-2 years:

- There 12,887 0-2 year olds in Lambeth, representing 63% of the total 0-4 population
- Largest numbers of 0-2's are found in Coldharbour, Larkhall, Stockwell and Knights Hill wards, in this order
- Smallest numbers of 0-2's are found in Bishop's, Thurlow Park and St Leonard's wards, in this order

Population 3-4 years:

- There are 7,658 3-4 year olds in Lambeth, which represents 38% of the total 0-4 population
- Largest numbers of 3-4 year olds are found in Coldharbour, Knights Hill, Stockwell and Vassall wards, in this order
- Smallest numbers of 3-4 year olds are found in Bishop's, Thurlow Park, and St Leonard's wards, in this order

GLA 2007 Round ward population projections for 2008

Population 5-9 years:

- There are 16,829 children 5-9 years in Lambeth
- Largest numbers of 5-9 year olds are found in Coldharbour, Stockwell, Knight's Hill and Vassall wards, in this order
- Smallest numbers of 5-9 year olds are found in St Leonard's, Bishop's and Thurlow Park wards, in this order

Population 10-14 years:

- There are 14,220 10-14 year olds in Lambeth
- Largest numbers of 10-14 year olds are found in Coldharbour, Stockwell, Knight's Hill and Gipsy Hill wards, in this order
- Smallest numbers of 10-14 year olds are found in St Leonard's, Bishop's, Streatham Wells and Thurlow Park wards, in this order

What does this tell us about demand for childcare?

- The spread of children aged 0-14 years across the borough is similar from 2007 to 2008, indicating demand for childcare in each ward in 2008 will be similar to demand for childcare in each ward from 2007
- Demand for childcare provision for 0-14 year olds is likely to be highest in the south east of the Borough where there are the largest numbers of children 0-14 years
- Some wards have high numbers of children in certain age groups. For example Vassall ward has one of the highest number of 3 and 4 year old children, but not a high number of children 0-4 years compared to other wards. This indicates some wards may have higher demand for places for certain age groups

Children with Disabilities (0-18 years)

Key facts:

- There is currently no comprehensive data available in Lambeth to gauge accurate numbers of children with disabilities in Lambeth.
- ICOUNT Register of Disabled Children 2008 shows there are currently 658 children 0-18 years on the ICOUNT register. This is an increase of 57 children from 2007
- Largest numbers of children with disabilities 0-18 years are found in Coldharbour, Gipsy Hill, Larkhall, Streatham South, Tulse Hill and Vassall wards, in this order
- Brixton Hill, Coldharbour, Gipsy Hill, Streatham South and Tulse Hill wards have the largest percentage of children with disabilities in proportion to all children 0-18 in those wards
- Examining prevalence of children with disabilities across age groups we find that the largest number of children with disabilities were in the 15-19 year age group, followed by the 10-14 year age group
- The most prevalent types of disability registered on the ICOUNT register were moderate/severe learning disability, communication difficulties and moderate/severe physical disability.

What does the data tell us about demand for childcare?

- 2008 and 2007 data show similar results in terms of wards with the largest number of children with a disability
- ICOUNT findings indicate the demand for childcare suitable for children with a disability is likely to be higher in the south east and south west of the borough, where more children on the ICOUNT Disability Register currently live
- Predominance of 10-19 year age group of children on ICOUNT register suggest out of school hours care is the most likely type of childcare in need for children with a disability
- Childcare provision needs to be able to cater for all types of disability, particularly for those with moderate/severe learning disability, communication difficulties and moderate/severe physical disability.
- There is limited data available, therefore the population of children with a disability in Lambeth is likely much higher and demand much stronger.

Ethnicity

Key facts:

- Ethnicity data from 2007 to 2008 show consistency in terms of the spread of diverse population groups across the borough
- ONS 2001 census data of all Lambeth population and Schools census data 2008 of all Lambeth school students show the largest ethnic population groups are White British, Black African and Black Caribbean.

2001 Census data shows:

- The largest numbers of White British residents are located in Clapham Common, Clapham Town and Thurlow Park wards
- Coldharbour, Stockwell, Vassall, Larkhall and St Leonard's wards have the largest numbers of residents from a Black African background
- Coldharbour, Vassall, Brixton Hill, Ferndale and Tulse Hill wards have the largest number of Black Caribbean residents
- There are above Lambeth average numbers of Indian ethnic backgrounds in Streatham South and St Leonard's wards

2008 PCT Live Birth data shows:

- Herne Hill ward has the largest numbers of White British children aged 0-14 years, followed by Thurlow Park ward
- The largest number of children 0-14 years from a Black African and Black Caribbean background are in Coldharbour ward
- There is a large number of 0-14 year olds from a white European background in Stockwell, Ferndale and Oval wards, with the majority of these children from a Portuguese background
- The wards with the largest number of children 0-14 years from a Bangladeshi background are Bishop's, Larkhall and Oval wards

What does the data tell us about demand for childcare?

- Uptake of childcare is likely to be affected by the clusters of ethnic groups across the Borough
- Ethnically diverse populations exist across the Borough therefore childcare provision borough wide needs to cater for these population groups

Family Structure

Census 2001 facts:

- Lambeth has a smaller number of married couples with dependent children households than the London average (11% and 17% respectively)
- Lambeth has a larger number of lone parents with dependent children households than the London average (12% and 9% respectively)
- The wards with the largest numbers of married couples with dependent children are Streatham South, Clapham Common and Thurlow Park wards, in this order
- The wards with the largest numbers of cohabiting couples with dependent children are Gipsy Hill, Coldharbour, Tulse Hill and Herne Hill wards, in this order
- The wards with the largest numbers of lone parent households with dependent children are Coldharbour, Stockwell, Vassall and Tulse Hill wards. Thornton, Larkhall, Knights Hill and Gipsy Hill wards are also all above the Lambeth average
- Nineteen of Lambeth's 21 wards have numbers above the London average of lone parent households with dependent children

What does this tell us about demand for childcare?

- Wards with large number of families with dependent children will likely have a higher demand for childcare provision, particularly in the south of the borough
- The large number of lone parent households with dependent children may be an indicator for both affordable childcare and childcare that is flexible to meet their needs as a lone parent

Economic activity

Nomis Labour Market Profile 2008 data shows:

- The number of people participating in economic activity in Lambeth is above the London average (78.1% and 75.2% respectively)
- Of those people that did work, the largest number of full time employees were found in Clapham Common, Clapham Town, St Leonard's, Streatham Wells and Thornton wards, in that order
- The wards with the largest number of part time workers were Coldharbour, Gipsy Hill, Knight's Hill, Streatham South, Vassall and Prince's wards, in that order

Benefits claimants (ONS Jobcentre and GLA estimates 2008) data shows:

- The number of benefits claimants in Lambeth is higher than the Inner London and London averages (5.5%, 5.5% and 4.4% respectively)
- The largest numbers unemployment related benefit claimants are in Coldharbour ward with almost double the Lambeth average (10.4% and 5.5% respectively)
- Wards with higher than the Lambeth average persons on benefits claimants are Coldharbour, Vassall, Tulse Hill, Herne Hill, Stockwell, Prince's, Ferndale and Brixton Hill wards, in that order
- Clapham Common ward had the least number of benefit claimant counts, followed by Thurlow Park ward

What does this tell us about demand for childcare?

- 2008 and 2007 data shows a similar spread of benefit claimants across the borough
- Wards in the south west of the borough may require greater provision of full time childcare places to cater for a larger number of full time workers
- The large numbers of part time workers in the south east and north localities indicates demand for more part time and flexible provision to cater for parents who work for shorter periods of the day or work irregular hours
- The south east of the borough may require more flexible childcare provision to cater to parents who may wish to attend training or education opportunities, or who need irregular childcare to attend interviews or other appointments to help them access work

Working Tax Credit

HMRC 2006 data shows:

- The take up of the childcare element of Working Tax Credit is high in Lambeth (25%) compared to the national average (14%)
- The take up rate in all wards is at least equivalent to or exceeds the national average
- Coldharbour, Vassall, Knight's Hill, Brixton Hill and Tulse Hill wards had the largest numbers of families benefiting from the child care element of Working Tax Credit, in this order
- Clapham Common, Bishop's and St Leonard's wards had the least numbers of families benefiting from the child care element of working tax credit, in this order

Household Income

Paycheck Income data 2008 shows:

- The distribution of household income in Lambeth is similar to London as whole (i.e. there are pockets of affluence and pockets of poverty)
- The wards with the highest household median income are Clapham Common (£41077), Clapham Town (£37,517), St Leonard's (£39,469), Streatham Hill (£37,856), Thurlow Park (£36,968) and Streatham Wells (£36564) wards
- The wards that have the lowest median income are Coldharbour (£27,571), Stockwell (£28,929), Vassall (£30,166), Prince's (£30,969) and Tulse Hill (£31775) wards

What does this tell us about demand for childcare?

Parents living in the south east and north localities of the borough are likely to have greater financial barriers in accessing childcare. These areas are likely to have a higher demand for more affordable childcare provision, and a higher demand for financial benefits available to assist parents in paying for childcare

Index of Multiple Deprivation (IMD)

The latest 2007 IMD data shows:

- Lambeth is more deprived than in 2004
- The IMD 2007 places Lambeth as the 5th most deprived borough in London and 19th most deprived overall in England
- Lambeth as a whole comprises of areas of affluence and poverty, and this is also reflected within wards in the Borough
- The wards that show the most significant deprivation overall are Coldharbour, Vassall, Stockwell, Oval, Tulse Hill, Prince's, Larkhall and Ferndale, in this order
- The wards that ranked as the least deprived overall were Thurlow Park and Clapham Common, in this order
- The main areas of deprivation for all wards were living environment, and access to housing and barriers to service.

What does this tell us about demand for childcare?

- Ability to afford childcare is likely to be lowest in the south east and north localities, indicating a higher demand for affordable childcare provision and financial benefits available to assist parents in paying for childcare
- There are pockets of areas across the borough that show high levels of poverty, indicating demand for affordable childcare is not limited to just one area, affordable childcare needs to be available across the borough
- The need for affordable childcare is more apparent than ever, with the IMD showing Lambeth is more deprived than in 2004

Registered places in the PVI sector (including Children's Centres)

- In 2008 there are 5,272 registered PVI places for 0-4 year olds, an increase of 679 places from 2007, or 13%
- The greatest number of registered PVI setting places are in Thurlow Park (664 places), Bishop's (397), Stockwell (391), St Leonard's (353) and Coldharbour (352) respectively
- Thurlow Park comprises 13% of all PVI places in Lambeth
- Bishop's ward has the second largest number of PVI places (397) yet has the least number of children 0-4 (454)
- In 2008 the wards with largest numbers of PVI places for 0-4 year olds were the same as in 2007, except for Coldharbour which now has one of the largest numbers of places
- The wards with the smallest number of registered PVI places were Brixton Hill (79), Ferndale (106), Oval (120) and Larkhall (121) respectively

- Larkhall has one of the smallest number of PVI places (121) yet one of the largest populations of 0-4 year olds (1233)
- Brixton Hill has just 2% of all PVI registered places in Lambeth
- In comparison to 2007 the wards with smallest number of places were Brixton Hill (86), Ferndale (88), Streatham Wells (111) and Vassall (126)
- The number of places in Streatham Wells and Vassall has increased significantly (by 30% and 51% respectively), whilst Oval and Larkhall have had a reduction in the number of PVI places (by 15% and 27% respectively) and hence replaces Streatham Wells and Vassall as wards with smallest numbers of PVI places

Registered places in the Childminder sector

- In 2008 the total number of registered childminder places for 0-4 year olds is 945 places, a decrease of 334 places from 2007, or a one quarter reduction in childminder places
- Wards with the largest numbers of childminder places are Knight's Hill (94), Streatham South (92), Vassall (81) and Brixton Hill (78) wards respectively
- Knight's Hill ward has the largest numbers of childminder places, representing 10% of all childminder places in Lambeth
- Wards with the largest numbers of childminders have remained the same from 2007 to 2008, except for Vassall which has replaced Coldharbour as a ward with one of the largest numbers of childminder places
- Whilst places in Vassall ward have increased by only 5 places, places in other wards have decreased hence placing Vassall ward comparatively as one of the wards with the largest place numbers
- Since 2007 Coldharbour has had a sharp decrease in childminder places (71%) however it must be noted that due to data discrepancies in 2007 data sets, this may be because some childminders may have been incorrectly placed in Coldharbour ward
- Prince's ward has the least number of childminder places (9 places) representing just 1% of all places across the Borough
- Wards with the least number of childminder places in 2008 include Bishop's (16), Thurlow Park (17), Ferndale (22) and Streatham Hill (23) respectively
- In 2007 the wards with the smallest numbers of childminder places were Bishop's (14), Prince's (26), Oval (28) and Streatham Hill (34) wards. In 2008 Oval has had an increase of only 4 places, Thurlow Park and Ferndale wards have had significant decreases (63% and 47% respectively) and hence places shows they now comprise the smallest number of childminder places
- Two of the five wards that had the largest numbers of PVI places (Thurlow Park and Bishop's wards) also had one of the smallest numbers of childminder places.
- Brixton Hill ward has one of the largest numbers of childminder places, and the smallest number of PVI setting places

Registered places and vacancies in the PVI sector for 0-2 year olds

- There are 2,328 registered PVI places for 0-2 year olds, which is nearly half of all 0-4 places in the PVI sector, yet 0-2 years old make up nearly two thirds of the 0-4 year old population
- Bishop's had the largest number of PVI sector places for 0-2 year olds (250 places or 11% of all 0-2 year old places) but the smallest number of 0-2 year olds (274)
- Coldharbour, Stockwell, Streatham Hill and Thurlow Park wards also have large numbers of 0-2 year old places
- Coldharbour and Stockwell wards have both large numbers of 0-2 years olds and the largest numbers of PVI registered places for 0-2 year olds
- Brixton Hill, Ferndale, Larkhall and Oval wards have the smallest numbers of registered PVI places for 0-2 year olds
- There are a large numbers of vacancies in the PVI sector Tulse Hill, Bishop's and Stockwell wards for 0-2 year old places compared to other wards
- There are no vacancies in the PVI sector for 0-2 year olds in Brixton Hill, Knight's Hill and Streatham Hill wards

- Over two thirds of free entitlement places were accessed by 3 year olds, one third by 4 year olds
- Thurlow Park and St Leonard's wards have the largest numbers of free entitlement places in the PVI sector and the largest numbers of 3 year olds and 4 year olds accessing free entitlement places
- Bishops' ward has a large number of free entitlement places, the majority of which are accessed by 3 year olds

- Children per place data shows Lambeth wide there are 3.3 children per PVI and childminder places in 2008, compared to 3.5 in 2007, showing there is more childcare available per child in 2008 than there was in 2007
- The wards with the greatest ratio of children per place are Brixton Hill, Ferndale, Larkhall and Oval, showing these wards have the least number of places available per children in that ward
- The wards with the smallest ratio of children per place are Bishop's, Clapham Town, St Leonard's, Thurlow Park and Streatham Hill, showing these wards have the largest number of places per children in that ward

Vacancies 0-4 year olds

Overall PVI and childminder sector vacancies 0-4 years

- Overall there were more vacancies in 2008 than in 2007, from 1,336 vacancies in 2007 to 1,566 in 2008, an increase of 15%
- The increase in vacancies was found only in the PVI sector, were there was a 225 increase in PVI place vacancies in Lambeth from 2007 to 2008.
- Vacancies in childminder places fell by 7 places from 2007 to 2008, or 2%
- In 2008 approximately one in four places in the PVI and Childminder sectors are vacant

PVI vacancies

- The wards with the greatest number of PVI vacancies were Stockwell (163), Thurlow Park (153), and St Leonard's (104)
- In comparison to 2007, Stockwell and St Leonard's remain as greatest number of vacancies, whilst Coldharbour and Tulse Hill no longer have large numbers of vacancies (decrease of 25% and 48% respectively)
- Thurlow Park ward had a large increase in vacancies of 77% from 2007 to 2008.
- In comparing 2008 registered places to 2008 vacancies, Stockwell, Thurlow Park and St Leonard's wards had the greatest numbers of registered places and the greatest number of vacancies.
- The wards with the least number of PVI vacancies in 2008 are Brixton Hill (4), Knight's Hill (4), Ferndale (14) and Herne Hill (18).
- Clapham Common ward has seen an increase in vacancies of 91% from 2007 to 2008; Prince's ward an increase of 86% and Streatham Hill ward an increase of 61%.

Childminder vacancies

- Overall there was a decrease in childminder vacancies from 487 in 2007 to 480 in 2008
- The wards with the largest number of childminder vacancies in 2008 are Vassall (45), Streatham South (37), Tulse Hill (35), Stockwell (35) and Knights Hill (35) respectively
- From 2007 to 2008 Stockwell and Vassall wards remain as wards with largest numbers of childminder place vacancies. These two wards, as well as Knights Hill and Streatham South wards also have the largest number of registered childminder places
- Tulse Hill ward has seen an increase of 32% in childminder place vacancies from 2007 to 2008, whilst Coldharbour and Streatham Wells have shown decreases of 68% and 31% respectively
- The wards with the least number of vacancies in 2008 are Prince's (6), Bishop's (7), Clapham Town (11) and Thurlow Park (12). Prince's, Bishop's and Thurlow Park wards also have the least number of registered childminder places

- The fees per hour of childcare in the PVI sector ranged from £1.60 per hour to £8.76 per hour depending on age range, location and type of setting
- Larkhall, Prince's, St Leonard's and Vassall wards had the lowest starting range cost (between £1.60 £2 per hour) showing these wards had some of the most affordable childcare in Lambeth
- Clapham Common, Clapham Town, Streatham South and Thornton wards had the most expensive fees (between £6.70 £8.76 per hour for some settings) showing these wards had some of the most expensive childcare in Lambeth
- In the childminder sector the average cost across Lambeth was £5.27 per hour
- The lowest average childminder fees per hour were found in St Leonard's (£4.25), Knight's Hill (£4.57), Streatham South (£4.66) and Streatham Wells (£4.72) wards
- Wards with the most expensive average childminder cost per hour were Tulse Hill (£6.85), Prince's (£6.84), Larkhall (£5.91) and Thornton (£5.82) wards

Opening Times and Flexibility

PVI providers

- The most common opening times for PVI providers were between the hours of 8am 6pm
- The earliest opening time in the PVI sector across Lambeth was 7am, with at least one PVI provider in Bishop's, Herne Hill, Knight's Hill and St Leonard's wards opening by 7am
- Clapham Common ward has the least flexible opening times in the PVI sector, where the earliest opening time is 8.20am
- Stockwell, Bishop's, Ferndale, Gipsy Hill and Knight's Hill wards all have at least one PVI provider that remains open until 7pm
- All wards apart from Oval have at least one PVI provider open until 6pm.

Childminders

- The earliest opening time in the childminder sector across Lambeth was 6am, with at least one childminder opening by 6am in Streatham South, Knight's Hill and Herne Hill wards

- All childminders with available data (30%) were open by 8am across Lambeth
- The majority of childminders across Lambeth remain open until at least 7pm
- Wards that had at least one childminder open after 7pm were Stockwell, Streatham Hill, Thornton, Vassall, Herne Hill, Knight's Hill, Oval and St Leonard's
- Of all childminders that had available data, 16% (26 childminders) stated flexible hours and/ or weekend care was available
- With the exception of Prince's ward, all wards had at least one childminder that offered flexible hours or weekend care

Childcare Provision for Over 5's

Key Facts:

- There is currently no reliable data available to make a comprehensive assessment of supply for over 5 childcare provision in Lambeth
- Results from the 2007 CSA show there are currently 1,325 breakfast club places, 1,908 after school club places and 1238 childminder places for over 5 year olds
- Places for over 5 childcare provision were unevenly spread across the Borough in terms of number of places, vacancies and costs
- As a result of the need for out of school provision identified in the CSA 2007, a mapping exercise of over 5 childcare provision has been commissioned by the London Borough of Lambeth in 2008. Results from this assessment will provide an analysis of the demand and supply for over 5 childcare provision in 2008 and the results will be updated in this report

Section 4: Overall Gap Analysis

This section provides an overview of gaps based on the heading provided by the Statutory Childcare Sufficiency Assessment Guidance. The gaps identified below provide an overview of the whole Borough. Specific analysis of gaps and needs are located in Section 5 at a locality level, and in Section 6 at a ward level.

Geographical Gaps:

The local authority has a duty to secure sufficient childcare to enable parents to work or access education and training leading to work. By looking at supply and demand data across the borough it is evident that a range of childcare exists, varying in type and for different age groups. Supply of childcare is unevenly spread across the Borough with largest supply in the south east and south west of the borough. Likewise the largest population of children and young people are also found in the south east and south west of the borough. However the analysis of demand indicates that there are particular wards across the borough where factors affecting demand such as parents' income, type of employment, ethnicity and lone parent status clearly affect access to childcare. The locality summary provided in Section 5 of this report provides a detailed analysis of the gaps across the borough.

Gaps in Type of Provision:

Supply shows there is a variety of childcare provision provided for all age groups. For childcare provision for the 0-4 age group there is an uneven spread of the types of provision across the borough, including uneven spread of PVI, childminder and maintained sector provision, as well as an uneven spread of full time and part time places available. This may have an affect on vacancy rates across the borough as demand for one type of childcare may be affected by parents needs.

There is a clear lack of reliable information about childcare for the over 5 age group and as such the analysis of over 5 childcare provision provided in the 2007 CSA provides the most reliable needs assessment to date. There is clear need for an updated assessment of need, and this has been identified by Lambeth and is currently being undertaken.

Gaps for children with additional needs:

Findings from the 2007 and 2008 analysis shows there is limited data available on accurate and reliable number of children with a disability in Lambeth, limiting an analysis of assessing whether improvement have been made for this population in accessing appropriate childcare. There needs to be a greater emphasis on gathering data on the number of disabled children and their needs to assess demand for childcare, as well as an audit of childcare that is currently available for children with a disability, ensuring childcare providers are meeting the obligations under the Disability Discrimination Act (DDA) and their Ofsted registration requirement for provision of services to disabled children.

There is an uneven spread of ethnically diverse populations across the Borough. Cultural barriers may affect the uptake of childcare by ethnically diverse groups. Analysis indicates there is little available information about how cultural barriers affect uptake of childcare in Lambeth and this is an area that needs to be further explored

Income Gaps:

The ability to afford childcare is a major barrier to access childcare, and dependent on a number of factors including cost of childcare, parents' income levels, lone parent status, benefit claimant status and access to financial benefits. Analysis of these factors clearly identifies that families require support to access childcare are likely to be those with higher level of deprivation. 2007 and 2008 data showed similar results in relation to analysis of deprivation across the borough. In Lambeth the south east and north of the borough show there are larger numbers of families that may require support in accessing childcare. Analysis also indicates there is an uneven spread across the borough of the cost of costs of childcare, and varying levels of families accessing financial initiatives such as free entitlement places and the childcare element of working tax credit. Support to access these initiatives will assist parents to access childcare to allow them to work or undertake training or education loading to work.

Gaps in Opening Times available:

Both 2007 and 2008 indicate that provision is available for parents during 'typical' working hours, i.e. 8am – 6pm. More flexible hours are available across the ward, but this is unevenly spread. Childminders tend to be able to provide more flexibility in hours of care. 2007 data on the out of school care sector indicates more flexibility is needed to cater for working parents needs. Results show more thorough investigation is need of childcare provision across all age groups and type to ensure parent's needs in accessing childcare are met.

Gaps in provision of childcare for particular age groups:

2007 data shows there is gap for children over 5 in childcare provision and a need for a greater understanding in this area. As previously stated Lambeth has identified this need and has commissioned an audit of out of school care provision which is currently underway. For provision of childcare for under 5's there is an uneven spread of provision across the borough. In some areas there is an increased demand for 0-2 year old provision, particularly in Clapham Common. Places in the maintained nursery sector and free entitlement places for 3 and 4 years olds are also unevenly spread across the Borough, creating higher demand for places in some areas.

Section 5: Identifying next steps

In general Lambeth is well supplied by childcare across all age groups and types of provision. However the childcare available does not always meet the needs and expectation of families who wish to access childcare provision. This is influenced by a number of factors relating to parents ability to pay, their individual needs and circumstances, and the needs of their children, particularly children with disabilities.

Meeting childcare sufficiency in Lambeth is dependent on 3 areas of improvement:


- 1. Supporting parents and carers to help them access information about childcare in the area, costs of childcare and financial initiatives that help parents pay for childcare
- 2. Supporting providers to help them better understand the childcare market, parents needs and expectations, and help them to deliver provision based on identified need
- 3. Undertake further research that will allow a better understanding of what is happening in the childcare market and clearly identify where improvement have been made.

Needs of parents and the childcare market are always changing. To ensure these changes are identified and monitored, Lambeth will provide an update of its Childcare Sufficiency Assessment in 2009, and will undertake a full review and deliver a new Childcare Sufficiency Assessment in 2010.

- Contains concentrations of ethnically diverse populations, with a significant number of Portuguese residents living in Stockwell and Oval wards, and a significant number of Bangladeshi residents living in Larkhall and Oval wards
- Has a small number of married and co-habiting couples with dependent children compared to the rest of the Borough
- Has small numbers of lone parents with dependent children, with pockets of large numbers in Stockwell ward
- Has an uneven spread of people looking after the home or family, with large numbers in Stockwell and Larkhall wards and small numbers in Bishop's ward
- Has similar numbers of full time and part time workers to the rest of the Borough, with a large concentration of part time workers in Prince's ward
- Has large numbers of benefits claimants with large concentrations in Larkhall, Prince's and Stockwell wards
- Has an uneven spread of parents benefiting from the childcare element of working tax credit, with a small number of parents benefiting in Stockwell and Oval wards, and large numbers in the rest of the locality
- Has a lower average weekly household income overall in comparison to the Lambeth average (£610 compared to £664 Lambeth average), with pockets of low income in Prince's and Stockwell wards
- Overall has a high level of multiple deprivation with four of the five wards placed in the second highest rank of deprivation
- The children per place ratio for 0-4 year olds shows the North locality has a high child per place ratio compared to the Lambeth average (4.67 compared to 3.3) and this is unevenly spread across the locality. The North locality comprises the wards with both the lowest and highest children per place ratios across the Borough. Bishop's ward has one of the lowest ratios, indicating there are sufficient places for each child in this ward, yet Larkhall ward shows the highest ratio of all wards, indicating there are not enough places available for children in this ward
- The North locality comprises 24% of the 0-4 population and 22% of 0-4 registered places. Of the places available 1 in 5 of them are vacant, indicating that while there may be a demand for places, the places currently available are not meeting the needs of all parents in this locality
- There is an uneven spread of registered PVI places for 0-4 year olds. Bishop's ward has the largest numbers of PVI sector places but a small number of children 0-4 years. Larkhall ward has a small number of PVI places and a large number of children 0-4 years
- Bishop's ward has a large number of 0-4 PVI places, which consequently also means there are a large number of 3 and 4 year olds accessing a free entitlement place in the PVI sector in Bishop's ward
- The North locality has a 28% vacancy rate for both PVI and childminder vacancies, the lowest vacancy rate of all localities. It also has the smallest number of registered places for 0-4's and the smallest numbers of 0-4's in the Borough
- The largest numbers of PVI and childminder sector vacancies are in Stockwell ward which also has a large number of places in the PVI and childminder sectors
- Larkhall had a large number of vacancies but a small number of 0-4 registered places in the PVI sector, indicating demand factors in uptake of places in this ward need to be investigated to ensure childcare in this ward is meeting needs of all parents who need to access childcare
- 20% of all 0-2 year olds in Lambeth are in this locality and 28% of all 0-2 PVI registered places. Of these places one in three are vacant. This shows there is a large number of PVI

places for the number of 0-2 year olds in this locality, and hence a large number of vacancies. This may indicate there is an oversupply of PVI registered places for 0-2 year olds in this locality overall

- Stockwell and Bishop's wards have the largest number of PVI registered places for 0-2's and the largest number of vacancies
- The North locality has the least number of places in the maintained sector, but also the least number of 2, 3 and 4 year olds. There are more full time places than part time places and large pockets of places in Oval and Prince's wards
- Costs for PVI and childminder places in the North locality were similar to the Lambeth average, with pockets of low PVI costs per hour in Larkhall and Prince's wards and high costs per hour for childminder places in Prince's and Larkhall wards
- Opening times in the North locality were similar to the rest of the Borough for both PVI and childminder settings. There was a large number of childminders in the North locality stating flexible and weekend care, particularly in Bishop's, Stockwell and Oval wards.

Priorities for North Locality:

- Closing the gap of uneven spread of places across the locality
- Exploring reasons for high vacancy rates in comparisons to relative availability of places, to ensure parents needs in accessing childcare are met
- Ensuring a mix of full time and part time places available to cater for a mix of full time and part time working parents, and parents who may want to return to work, training or education and require flexibility in childcare to meet their needs
- Monitoring the indicated oversupply of places and high vacancies for 0-2 year olds
- Ensuring equitable childminder costs across the locality and in comparison to the rest of the borough
- Ensuring families on low incomes, lone parents and those on benefits are aware of financial initiatives to assist them to access childcare such as the free entitlement for 2, 3 and 4 years olds and the child care element of working tax credit for working parents
- Identifying current needs of disabled children and their parents in the locality, to ensure current provision is meeting demand
- Ensuring parents and children from ethnically diverse backgrounds are able to access culturally appropriate information about childcare and related benefits to assist them in accessing childcare

The South East Locality:

- This locality has the largest number of adults and children in the Borough, as well as the largest populations for all age groups 0-14 years
- There are large numbers of lone parents, married couples and co-habiting couples with dependent children, and large numbers of people looking after the home or family
- There are large numbers of Black, Minority Ethic (BME) groups, with large clusters in Coldharbour, Brixton Hill, Vassall and Tulse Hill wards. There are also a significant number of people from a Portuguese background in Ferndale ward
- There are large numbers of benefit claimants, particularly in Coldharbour ward with almost double the Lambeth average
- Six of the nine wards in this locality have an average weekly household income that is lower than the Lambeth average (£664)
- Levels of multiple deprivation are high across the locality, with four of the nine wards placed in the second highest rank of deprivation, and four wards in the third highest rank of deprivation
- There are 46% of all 0-4 year olds in this locality but only 44% of all 0-4 year old places. This shows there are a small number of places available to children in the locality. This locality has 42% of all vacancies in the Borough, showing there are a small number of total vacancies in comparison to the total number of places available

- Children per place data for the PVI and childminders sectors shows this locality has a large number of children to places available, and that the places are unevenly spread across the locality. Brixton Hill and Ferndale wards have high children per place ratios indicating there are not enough places available for children in those wards. However in Thurlow Park ratios show there are more places available than children who need them
- There are a large number of PVI registered places in this locality but this is unevenly spread. Coldharbour, Thurlow Park and Vassall wards have the largest number of PVI places. Coldharbour and Vassall wards also have a large number of 0-4 year olds
- Thurlow Park ward has a large number of places but a small number of 0-4 year olds. In contrast Brixton Hill ward has a small number of PVI places but a large number of 0-4 year olds
- There are a large number of childminder places in this locality with Brixton Hill, Knight's Hill and Vassall wards comprising the largest number of places. Thurlow Park and Ferndale wards have a small number of childminder places, matched by a small number of 0-4 year olds in those wards
- There is an uneven spread of vacancies for both PVI and childminders places. The least number of vacancies in the PVI sector are in Brixton Hill and Ferndale wards, which match a small number of 0-4 year olds in those wards. Herne Hill and Knight's Hill wards have a small number of vacancies and large numbers of 0-4 year olds. Thurlow Park ward has a large number of vacancies, but a small number of children 0-4 years. This indicates for some wards in this locality there is a shortage of places, and for other wards there is an over supply of places, or places that currently do not meet the needs of all parents
- In the childminder sector the largest numbers of vacancies are in Vassall, Tulse Hill and Knights Hill wards where there are also large numbers of children. This may indicate the childminder sector in these wards is not meeting the needs of parents who need to access them
- The South East locality comprises 45% of all 0-2 year olds but only 41% of all 0-2 year old places. There are less vacancies overall (38%) than places overall (41%) showing there are less places available per children in the locality, and as a result a smaller number of vacancies to places available. This indicates an undersupply of sufficiency for 0-2 year old places in this locality
- There are a large number of maintained sector places in this locality, with almost half of all the full time equivalent (FTE) places in Lambeth. Brixton Hill and Vassall wards have a large number of places overall particularly for 3 year olds, however Brixton Hill ward has more part time places and Vassall ward has more full time places
- This locality had a small number of free entitlement places in the PVI sector, particularly in Knights Hill, Tulse Hill and Ferndale wards for both 3 and 4 year olds
- Costs of PVI and childminder places are similar to the rest of the Borough, however costs are spread unevenly across the locality. Knight's Hill ward had one of the least expensive average childminder costs, while Tulse Hill ward had one of the most expensive average childminder costs
- Most wards in this locality had a broad range of opening times indicating flexible access for parents. Herne Hill, Knight's Hill, Ferndale and Gipsy Hill wards all have providers with the most flexibility in opening and closing times in the PVI sector. In the childminder sector, Knight's Hill, Herne Hill, Tulse Hill and Vassall wards had the greatest number of childminders with flexible opening and closing times, and availability on weekends

Priorities for South East Locality:

- Options to increase the overall number of places available
- Options to address the indicated undersupply of 0-2 year old places
- Closing the gap of uneven spread of places across the locality in comparison to the number of children 0-4 years in each ward
- Ensuring families on low incomes, lone parents and those on benefits are aware of financial initiatives to assist them to access childcare such as the free entitlement for 2, 3 and 4 years olds and the child care element of working tax credit for working parents
- Exploring options to ensure parents on benefits claimants who want to access training, education or work opportunities are able to access childcare that is flexible to their needs
- Identifying current needs of disabled children and their parents in the locality, to ensure provision is meeting demand
- Ensuring parents and children from ethnically diverse backgrounds are able to access culturally appropriate information about childcare and related benefits to assist them in accessing childcare
- Ensuring equitable childminder costs across the locality and in comparison to the rest of the Borough

The South West Locality:

- Comprises 34% of the Lambeth adult and child population, less than the south east locality, but more than the north locality
- Comprises almost one third of all 0-4 year olds, more than one quarter of 5-9 year olds and almost one third of 10-14 year old children in the borough
- Is the most affluent part of the borough overall, with clusters of deprivation in some wards
- Has a large number of White British residents as well as a higher than Lambeth average numbers of residents from an Indian background, with clusters in St Leonard's and Streatham South wards
- Has large numbers of married and cohabiting couples with dependent children, particularly in Clapham Common and Streatham South wards
- Has a small number of lone parent households with dependent children, with a cluster of high numbers in Thornton ward
- Has a high economic activity rate, with large numbers of people in full time employment and large numbers of people looking after the home in Thornton and Streatham South wards
- Has a high average weekly income compared to the rest of the Borough (£750 compared to £664 Lambeth average)
- Contains most of the wards with the least level of deprivation in Lambeth, with clusters of deprived areas throughout the locality
- Children per place data shows there is low number of children per place for all wards except Streatham Wells ward, indicating a sufficient number of places per children in this locality
- This locality comprises 31% of the 0-4 population and 35% of all 0-4 registered PVI and childminder places. This shows there are a higher number of places per children in this locality. This locality also has 31% of all vacancies across the Borough which compared to the total number of places is a low figure. This shows there is a higher number of places available per number of children, yet vacancies are low and hence indicate a high demand for places in this locality
- In the PVI sector there are a large numbers of places in Clapham Common, Clapham Town and St Leonard's wards and the least number of places in Streatham South and Streatham Wells wards
- The largest number of childminder places is in Streatham South ward
- There are 32% of the total 0-2 age group in this locality, as well as 32% of PVI and childminder places for 0-2's and 28% of vacancies. This data shows the same percentage of children to places for 0-2's, and a small number of vacancies compared to the total number of places, indicating a high demand for places for 0-2 year olds

- Large numbers of 0-2 places are found in Streatham Hill, Thornton and Clapham Town wards where there are also large numbers of 0-2 year olds
- In the maintained sector Clapham Town and Thornton wards have large numbers of full time equivalent places, whilst Clapham Common, Streatham Hill and St Leonard's wards have the least number of full time equivalent places
- There is more than double the number of part time places than full time places in the maintained sector across the locality. The largest number of part time places are in Clapham Common, Clapham Town and Thornton wards, and the largest number of full time places in Thornton ward
- This locality has a high range of PVI costs compared to other localities, particularly in Clapham Common, Clapham Town, Streatham South and Thornton wards
- Childminder costs in the locality were similar to the Lambeth average, with pockets of higher average costs in Thornton ward, and lower than average costs in Clapham Town and Streatham South wards
- Opening hours in this locality are similar to that of other localities for the PVI sector. The childminder sector indicates good flexibility across the locality and in comparison to other localities

Priorities for South West Locality:

- Further assessment of demand to determine need for additional places, particularly for the 0-2 year old age group
- Closing the gap of uneven spread of places across the locality
- Ensuring availability of full time places to cater for high numbers of full time workers, and flexible places to cater for parents with varying needs
- Ensure equity of PVI childcare costs in comparison to the whole borough
- Ensure equity of childminder costs across the locality and in comparison to the whole borough



Key Facts:

- 3% of all Lambeth children under 5 live in Bishop's ward. Compared to other wards in Lambeth, Bishop's ward has the lowest percentage of children under 5
- From 2007 to 2008 the number of children under 5 in Bishop's ward has remained the same (455 in 2007 to 454 in 2008)
- From 2007 to 2008 the number of 5-9 year olds and 10-14 year olds have increased slightly (472 to 474) and (412 to 441) respectively. Bishop's ward has the smallest number of 5-9 year olds and 10-14 year olds across the borough
- The majority of children aged 0-14 in Bishops are from White British, White other background, Black African, Black Caribbean and Black other backgrounds. There is also a small population of children from Bangladeshi background
- There are between 20-29 children with a disability 0-18 years on the ICOUNT Disability register in Bishop's ward (1.01% 1.25% of all 0-18 yr olds)
- Bishop's ward has a lower than average household income compared to other wards (£600 compared to £664 average of all Lambeth wards)
- There are a small number of people who work part time in comparison to the rest of the borough (6.6% compared to Lambeth 7%)
- 10% of all households are lone parent households with dependent children; this is lower than the Lambeth average (12%)
- There are a small number of couples with dependent children compared to the rest of the borough (7.7% compared to Lambeth 12%)
- Bishop's ward has one of the smallest number of job seeker claimants across the borough (4% compared to 4.8% average of all Lambeth wards)
- One in five families in work in Bishop's ward benefit from the child care element of Working Tax Credit (WTC), including 32% of lone parents. Bishop's ward has an average take up rate in comparison to other Lambeth wards



Key Facts:

- Comparison of 2007 to 2008 data shows the number of PVI places remained stable, and there was a slight increase of childminder places. Overall there are more registered places in 2008, and decrease in the number of actual children per place.
- The data shows that there is sufficiency, and possibly an oversupply of places in Bishop's ward. This ward has the smallest child per place ratio across Lambeth showing the demand for places may be low compared to other wards
- There are 58 full time equivalent places for 3-4 year olds in the maintained sector.
- In the PVI sector there are 110 children accessing a free entitlement place. Over three quarters of these children are 3 years old, and one quarter 4 years old

- Approximately 1 in 6 places are vacant in the PVI and childminder sectors in Bishop's ward
- There was a slight increase in vacancies for PVI and childminder places
- Overall the number of registered places has remained the same, and there has been a small number of vacancy increases
- Children per place data indicates that the reason for vacancies may be due to an oversupply of places

- Nearly two thirds of all registered places in the PVI sector are 0-2 year old places
- Just over one half of all vacancies are 0-2 year old vacancies. This may indicate that there is an oversupply of places for 0-2 year olds
- Almost all PVI providers and all childminders cater for the 0 -5 age group
- The earliest opening times for the PVI sector was 7am, and the latest closing time was 7pm. Most providers are open from 8am 6pm
- All childminders are open between 8am 6pm. Two childminders stated flexible evening and weekend care
- Cost of childcare in the PVI sector ranged from £3 £4.50 per hour. Based on data for other wards, cost per hour in Bishop's ward is on average with most other wards and less expensive than some wards
- For the childminder sector costs ranged from £3.50 £6, with an average of £4.90 per hour. The average cost per hour in Bishop's ward for childminders is slightly lower than the average cost of all Lambeth wards (£5.27)
- Assisting families, particularly those on low incomes and those who are unemployed to access the childcare element of working tax credit will assist parents to access affordable childcare

Summary:

- There appears to be an oversupply of places in this ward for 0-4 year olds. This ward has 1.1 children per place (PVI and Childminders only) and 1.0 child per place overall. This is lower than the overall children per place in Lambeth (2.4).
- The population of 0-4 has remained the same from 2007 to 2008 indicating no need for an increase in registered places
- Analysis of childcare for over 5's is needed to address the supply and demand of childcare for this age group
- Bishop's ward has a lower than Lambeth average of household income. In addition the cost of childcare is similar or less expensive to most other wards and an average take up of the childcare element of working tax credit is similar to the average rates across Lambeth. Parents on low incomes may benefit from an increased awareness of the childcare element of working tax credit to assist them to access affordable childcare. This may assist in reducing vacancy rates
- For 0-4 year olds, PVI and childminder opening times show that most providers are open 'typical' working hours and there is limited flexibility in both sectors for flexible hours. This may be contributing factor to vacancy rates in this ward
- Further analysis of the need for flexible opening times may assist in understanding parents needs in accessing childcare and assist in reducing vacancy rates

- 5% of all Lambeth children under 5 live in Prince's ward. Compared to other wards in Lambeth, the number of children under 5 in Prince's ward is not significantly higher or lower
- The number of children under 5 in Prince's ward has decreased from 941 in 2007 to 934 in 2008
- The number of children aged 5-9 years and 10-14 years have increased, from 727 in 2007 to 759 in 2008, and from 617 in 2007 to 641 in 2008 respectively
- Prince's ward has one of the lowest average household incomes compared to other wards (£590 compared to £664 Lambeth average)
- There are a high number of part time workers in comparison to other wards (12% compared to Lambeth average of 10%)
- 11% of all households are lone parent households. This is lower than the Lambeth average of 12%
- There are a low number of couples with dependent children (9.8% compared to 12%)
- Nearly 1 in 5 families in work in Prince's ward benefit from the child care element of Working Tax Credit (WTC), including one third of lone parents. This is an average number across the borough



Overall there are a less registered places than in 2007, and an increase in the number of actual children per place. The child per place ratio is higher than the Lambeth average (3.3) indicating there are insufficient places in the PVI and childminders sectors for 0-4 year olds in this ward
- There are 70 children accessing their free entitlement in the PVI sector. 47 of these children are 3 years old, and 23 are 4 years old
- There are 119 full time equivalent places for 3-4 year olds in the maintained sector.

- There was an increase of vacancies in the PVI sector from 2007 to 2008 and a decrease in childminder sector vacancies. One third of all places are currently vacant in the PVI and childminders sectors
- Overall there has been a decrease in the number of registered places in Prince's ward, but a higher number of vacancies. This indicates that there is demand for childcare for 0-4 year olds but that current places available are not meeting needs of all parents

- Over half of all places in the PVI sector are for 0-2 year olds and one in five vacancies for 0-2 places. This is a small figure in comparison to other wards and may indicate that there could be demand for 0-2 places in the future
- Only 2 out of 6 PVI providers cater for 0-2's, and all childminders with available information catered for the 0-5 age group
- Based on available data, the earliest opening time in the PVI sector was 8am, and the latest closing time was 6pm. Only 2 out of 6 PVI providers remain open until 6pm
- Based on available information from childminders, all opened between 7am 8.30am. Closing times varied between 4pm – 6.30pm. No childminders stated flexibility in opening /closing times or weekend availability
- Based on available information from PVI providers, cost range per week was £120 £180 per week. Only 2 PVI providers had cost per hour data available, which ranged from £2 £3 per hour. Cost per hour in Prince's ward is equivalent to most other wards, and is less expensive that some wards
- Costs for childminders ranged from £5 £10 per hour, with an average of £6.84 per hour. In comparison to other wards, the average cost per hour in Prince's ward for childminders is higher than the Lambeth average (£5.27)

- There are currently insufficient places in the PVI and childminder sector (5.4 children per place) .Overall there is 3.2 children per place which is higher than the Lambeth children per place (2.4). The increase in vacancies suggests the current places available do not meet the needs of parents who wish to access them. 



- Half of all registered places in the PVI sector are for 0-2 year olds and nearly one third of all vacancies are for 0-2 year old places. This indicates the current places available for 0-2 year olds are not meeting the needs of all parents
- Of the available data, only one PVI provider caters for 0-5 year olds. The majority of childminders cater for the 0-5 year age group

- Investigating ways in which the PVI and childminder sectors can better accommodate flexible hours may be one way of meeting parents childcare needs, particularly for the high number of part time employees





- Half of all places in the PVI sector are for 0-2 year olds, and one in five of all vacancies are for 0-2 year old places. The low number of vacancies indicate there may be an ongoing demand for 0-2 places in the future
- In terms of age range two PVI providers cater for the 0-5 age group, and three cater for the 2-5 age group
- In the childminder sector 23 childminders cater for the 0-5 age group, and two cater for the 1-5 age group
- In the PVI sector only one PVI provider is open by 8am, the other three open at 9.30am. The latest closing time was 6.00pm, with only one provider open until 6pm. The other PVI providers closed at 3pm and 5.30pm
- In the childminder sector opening times varied between 6.30am 9.00am. 19 childminders were open by 8am. Closing times varied between 5.00pm 9.00pm, with 18 open until at least 6pm. Four childminders stated weekend care was available
- In the PVI sector cost per hour ranged from £2 £6.80. This is average with most wards and more expensive than some wards
- In the childminder sector cost ranged from £4 £7 per hour, with an average of £5.50 per hour. The average cost per hour in Vassall ward for childminders is similar to the average cost for all Lambeth wards (£5.27).

- There are particularly high numbers of 0-4 year olds (1,070) in this ward. There seems to be sufficient number of places in the PVI and Childminder sectors (3.2 children per place). Overall the child per place ratio falls significantly to 1.9, which is lower than the Lambeth average (2.4).
- The low number of vacancies for 0-2 year olds may indicate an increase in demand for this age group
- A large number of job claimants and part time workers suggest flexibility of opening hours may be an important demand factor. Further analysis of parents needs should be undertaken to better understand demand for childcare, including the need for more flexible opening times
- There is a significant level of deprivation in Vassall ward. This indicates that cost of childcare may be a reason parents do not access childcare. Parents on low incomes may benefit from an increased awareness of the childcare element of working tax credit to assist them to access affordable childcare
- From 2007 to 2008 there has been an increase in the number of children aged 5-14 years. Analysis of childcare for over 5's is needed to address supply and demand of childcare for this age group

- 7% of all Lambeth children under 5 live in Coldharbour ward. Coldharbour has the largest number of 0-2's, 3-4's and overall 0-4 population across Lambeth
- The number of children under 5 in Coldharbour ward has increased from 1452 in 2007 to 1459 in 2008
- In the 5-9 year age group there has been an increase from 1152 to 1197 children, and a decrease of 10-14 year olds from 1141 in 2007 to 1105 in 2008. This indicates there may be an increase in demand for childcare for 5-9 year olds
- There are between 50-59 children with a disability 0-18 yrs on the ICOUNT Disability Register in Coldharbour ward (1.26% 1.5% of all 0-18 yr olds)
- Coldharbour ward has the lowest average household income of all wards in Lambeth (£520 compared to £664 Lambeth average)
- There are a high number of part time employees in comparison to other wards (8.2% compared to Lambeth 7%)
- Coldharbour ward has the largest number of lone parent households across the Borough (19% compared to 12% average all Lambeth wards)
- There is a large number of Black Caribbean residents (21% compared to 10.5% whole Lambeth) and Black African residents (21% compared to 10.8% whole Lambeth) and a significantly lower number of White British residents (33% compared to 52% whole Lambeth)
- There is a low economic activity rate (66% compared to Lambeth 70.9%) and Coldharbour ward also has the largest number of job seeker claimants across the Borough (7% compared to 4.8% average of all Lambeth wards)
- One in five families in work in Coldharbour ward benefit from the child care element of Working Tax Credit (WTC), including 31% of lone parents. Coldharbour ward has a higher number of working families claiming the childcare element of working tax credit in comparison to other wards



Key Facts:

- Comparison of 2007 to 2008 data shows an increase in the number of PVI places and a significant decrease in childminder places. Overall there are slightly less registered places than in 2007, and a minor increase in the number of actual children per place. The children per place ratio is slightly higher than the Lambeth average (3.3) indicating there are sufficient places, or only a minor number of places needed
- It should be noted that data from 2007 and 2008 shows discrepancies in the division of ward data. This may mean that providers stated to be in Coldharbour ward in 2008 analysis may not have been in this ward in 2007 data analysis. Therefore the data cannot be used to form an accurate comparison of 2007 and 2008 data
- There are 70 children accessing their free entitlement in the PVI sector, with just under half taken up by 3 year olds, and just over half by 4 year olds
- There are 85 full time equivalent places for 3-4 year olds in the maintained sector.

- There is a significant decrease in vacancies in the PVI and childminder sectors from 2007 to 2008
- Overall there has been a small decrease in the number of registered places in Coldharbour ward, and a large decrease in vacancies. Currently 1 in 5 places are vacant in the PVI and childminders sectors for 0-4 year olds. This may indicate demand for places in the future.

- Just under half of all PVI and childminder places are for 0-2 year olds, and only one third of all vacancies are for the 0-2 year olds. This may indicate that there may be a demand for 0-2 year old places in the future
- Only 3 of the PVI providers cater for the 0-2 age group, whilst all childminders in the ward cater for the 0-5 age group
- The earliest opening time in the PVI sector is 7.30am, with 6 providers opening between 7.30am 8.30am. The latest closing time was 6pm
- In the childminder sector opening times varied between 7am 8.30am, and closing times varied between 5.00pm 6.30pm. Five childminders stated flexible times and/or Saturday care was available
- Costs of childcare provision in the PVI sector ranged from £2.30 £4 per hour. Based on costs of other wards, cost per hour in Coldharbour ward is average to most wards, and less expensive than some wards
- For childminder provision the cost ranged from £2.60 £7 per hour, with an average of £5.13 per hour. The average cost per hour in Coldharbour ward for childminders is slightly lower than the average cost of all Lambeth wards.

- Coldharbour has the highest number of 0-4 year olds in Lambeth (1,459). Demand for places is expected to remain high as there are 3.8 children per place in the PVI and Childminder sectors and 3.1 children per place overall. This compares the Lambeth average at 3.3 and 2.4 respectively.
- From 2007 to 2008 there has been an increase in the number of children aged 5-9 years. Analysis of childcare for over 5's is needed to address supply and demand of childcare for this age group
- Investigating the needs of different ethnic groups, particularly the Black Caribbean and Black African populations may help marginalised groups to access childcare appropriate to their needs
- Although PVI and childminder costs for 0-4 year old provision is lower than other wards, there is also a significant level of deprivation in Coldharbour ward. This indicates that cost of childcare may be a reason parents do not access childcare. Parents on low incomes may benefit from an increased awareness of the childcare element of working tax credit to assist them to access affordable childcare
- Investigating ways in which the PVI and childminder sectors can better accommodate flexible hours may be one way of meeting parents childcare needs, particularly for the large numbers of part time employees and people who are not in work, to help them access employment or training leading to employment


- The number of children under 5 in Ferndale ward has increased from 845 in 2007 to 864 in 2008
- Ferndale has a relatively low number of 3-4 year olds and overall 0-4 year olds in comparison to most other Lambeth wards.
- The number of 5-9 year olds has increased from 607 in 2007 to 610 in 2008. The number of 10-14 year olds has decreased from 540 in 2007 to 529 in 2008. This may indicate demand for childcare for over 5's is not as significant as in other wards
- There are between 20-29 children 0-18 years with a disability on the ICOUNT Disability Register in Ferndale ward (0.76% 1% of all 0-18 yr olds)
- The majority of children in Ferndale are from White British, White Other, Black African, Black Caribbean and Black other backgrounds. Ferndale has the second largest number of children from a White other background, and this number is higher than the number of children from a White British background in Ferndale (165 White Other background compared to 135 White British). The majority of these children are from Portugal
- Ferndale has as a slightly higher than Lambeth average household income (£690 compared to £664)
- The number of part time employees, lone parent households and job seeker claimants in Ferndale is the same as the Lambeth average (7%, 12% and 5% respectively)
- 1 in 6 families in work in Ferndale ward benefit from the child care element of Working Tax Credit (WTC), including one quarter of lone parents (HMRC Child Tax Credit Statistics 2006-07). Ferndale ward has one of the smallest numbers of working families claiming the childcare element of working tax credit in comparison to other wards.

- There are 76 full time equivalent places for 3-4 year olds in the maintained sector.

- Vacancies in the PVI sector and childminder sector in 2007 and 2008 remain the same. One quarter of all places are vacant
- Overall the number of registered places and the number of vacancies have remained the same. With an increase in the 0-4 population this indicates there may be a future increase in demand. The children per place ratio is higher than the Lambeth average (6.75 compared to 3.31) indicating there are less places available per child in Ferndale ward that there is across the borough

- Half of all PVI providers cater for 0-2's. One third of all registered places in the PVI sector are for 0-2 years olds. Over one third of all vacancies are for 0-2 year old places. This may indicate that there are sufficient places for 0-2 year olds in Ferndale ward
- All childminders in Ferndale ward cater for the 0-5 age group
- The earliest opening time in the PVI sector is at 7.30am, with one provider opening at 8.00am and a preschool provider opening at 9am. The latest closing time was 7pm
- In the childminder sector opening times varied between 7am 9.00am. 7 childminders were open by 8am. Closing times varied between 5.00pm – 7.00pm. Two childminders stated flexible times and one provider stated weekend care was available
- In the PVI sector costs per ranged from £2.60 £3 per hour. Based on costs of other wards, cost per hour in Ferndale ward is average, and less expensive than most other wards

- The number of registered places for 0-4 year olds has remained the same, whilst the population has grown. The high children per place ratio indicates there may be insufficient places in this ward for 0-4 year olds
- The stable vacancy rates may indicates that current places available are not meeting needs of parents in this ward. Further analysis of parents needs should be undertaken to better understand demand for childcare in this ward
- Investigating the needs of different ethnic groups, particularly the Black Caribbean, Black African, Black Other and Portuguese populations may help marginalised groups to access childcare appropriate to their needs
- Ferndale ward has a low uptake of families accessing the childcare element of working tax credit. Parents may benefit from an increased awareness of the childcare element of working tax credit to assist them to access affordable childcare. It is also important that the information is accessible to parents with diverse cultural needs given the large diversity of ethnic population groups in Ferndale ward. This may assist in reducing vacancy rates and hence lower demand
- Analysis of childcare for over 5's is needed to address supply and demand of childcare for this age group

- In the PVI sector there are 32 children accessing their free entitlement. 29 of these children are 3 years old and 3 children are 4 years old
- There are 202 full time equivalent places for 3-4 year olds in the maintained sector.
- It should be noted that data from 2007 and 2008 shows discrepancies in the division of ward data. This may mean that providers stated to be in Brixton Hill ward in 2008 analysis may not have been in this ward in 2007 data analysis. Therefore the data cannot be used to form an accurate comparison of 2007 and 2008 data in terms of sufficiency.

- Approximately 1 in 10 registered places in the PVI sector are for 0-2 year olds. There are currently no vacancies for 0-2 year old places in the PVI sector. This may indicate a demand for 0-2 year old places
- It should be noted that an accurate breakdown of 0-2 year old places in the childminder sector was not available, but a high number of childminder places may indicate there is a larger supply for 0-2 year olds in the childminder sector



- Three quarters of all places in the PVI sector are for 0-2 year olds, and four out of five of all vacancies are for 0-2 year old places. This may indicate an oversupply of places for 0-2 years or that places available are currently not meeting the needs of all parents
- In terms of age range, five PVI providers cater for the 0-2 age group, two cater for the 2-5 age group
- Of the 13 childminders with data available, 12 cater for the 0-5 age group, one caters for the 2-5 age group
- Opening times for PVI providers range mostly from 8am 6pm
- In the childminder sector opening times varied between 6.30 8.30am. 11 childminders were open by 8am. Closing times varied between 5.00pm 6.30pm. Three childminders stated flexible, evening or weekend care was available
- Costs in the PVI sector ranged from £2.60 £6.50 per hour. This is on average with most wards and more expensive than some wards
- In the childminder sector costs range from £5 £10.50 per hour, with an average of £6.85 per hour. The average cost per hour in Tulse Hill ward for childminders is higher than the average cost for all Lambeth wards (£5.27), and the most expensive average per hour cost of all Lambeth wards.

- The number of children per place (4.6) in Tulse Hill indicates there may be insufficient places for 0-4 year olds. Overall the ratio (4.2) is significantly higher than the Lambeth average (2.4).
- Vacancy rates indicate current places available may not be meeting the needs of parents. Further analysis of parents needs should be undertaken to better understand demand for childcare, and reduce vacancy rates in this ward
- Further analysis of the needs of parents with 0-2 year olds is needed to look at demand for places and needs of this particular group
- High costs of childcare, as well as a low average household income and a large number of people receiving benefits may be impacting on parents access to childcare. Parents on low incomes may benefit from an increased awareness of the childcare element of working tax credit to assist them to access affordable childcare. This may assist in reducing vacancy rates
- Limited flexibility in opening hours may also be contributing to vacancy rates. Further investigation of parents needs in regard to opening hours may assist in meeting parent's need, particularly for parents who need flexible hours to access work opportunities or training leading to work.



- Nearly two thirds of all PVI places are for 0-2 year olds and just over one quarter of all vacancies are 0-2 year old places. This is a low number compared to other wards, and with one of the largest 0-2 populations across the borough there may be an increase in the demand for 0-2 places in the future
- Half of the PVI providers and almost all the childminder providers in Herne Hill ward cater for 0-2 year olds
- In the PVI sector opening times varied from 7am 9.30am. The latest closing time is 6pm
- All Childminders open between 6.00am 9.00am. Two childminders opened between 6am 6.30am, and 20 providers open by 8am. Closing times varied between 5.00pm 10.00pm, with six childminders remaining open until at least 6pm 10pm. One childminder stated flexible times on Saturdays

- Costs for childminder care ranged from £3.75 £7 per hour, with an average of £5.09 per hour. The average cost per hour in Herne Hill ward for childminders is close to the average cost of all Lambeth wards (£5.27)

- The high number of children per place for 0-4 year olds indicates there may be insufficient places in the PVI and Childminder sectors which is higher the Lambeth average (3.3). However overall there are 2.6 children per place which is similar to the Lambeth average (2.4). There are 390 (3-4 year olds) in this ward and the maintained sector provides just over 40% of places for this age group.
- An increase of vacancies suggests the current available places are not meeting the needs of all parents. Further investigation is needed to ensure exiting places meet the needs of parents, particularly for 0-2 year olds
- Herne Hill ward has a slightly higher than Lambeth average of household income. In addition the cost of childcare is similar to most other wards and the take up of the childcare element of working tax credit is similar to the average rates across Lambeth. Parents on low incomes may benefit from an increased awareness of the childcare element of working tax credit to assist them to access affordable childcare. This may assist in reducing vacancy rates
- From 2007 to 2008 there has been an increase in the number of children aged 5-14 years. Analysis of childcare for over 5's is needed to address supply and demand of childcare for this age group



- There are 661 children in this ward for the 0-4 age group and there is 1 child per place in the PVI and Childminder sector. This suggests over supply of places. Overall the number of places available drops further to 0.9 compared to the Lambeth average (2.4)
- The low number of vacancies suggests that there is a demand for childcare in this ward, particularly for 0-2 year olds. Further analysis of parents needs should be undertaken to better understand demand for childcare for parents who reside in this ward and outside



- Although PVI and childminder costs for 0-4 year old provision is similar to or lower than other wards, there is also a significant level of deprivation in Gipsy Hill ward. This indicates that cost of childcare may be a reason parents do not access childcare. Parents on low incomes may benefit from an increased awareness of the childcare element of working tax credit to assist them to access affordable childcare
- Investigating ways in which the PVI and childminder sector can better accommodate flexible hours may be one way of meeting parents childcare needs, particularly for the large number of part time employees and people who are not in work, to help them access employment or training leading to employment
- Investigating the needs of different ethnic groups, particularly the Black Caribbean and Black African populations may help marginalised groups to access childcare appropriate to their needs
- From 2007 to 2008 there has been an increase in the number of children aged 10-14 years. Analysis of childcare for over 5's is needed to address supply and demand of childcare for this age group



- Nearly a half of all PVI registered places are for 0-2 year olds. Of these, there are no current vacancies. This may indicate a demand for 0-2 places in this ward
- In addition to the PVI sector, almost all childminders cater for 0-5 year olds
- Based on available PVI data, the earliest opening time was 7am, and the latest closing time is 7pm
- Of the 26 childminders with available information, the earliest opening time was 6am, and all childminders are open by 8am. Closing times varied between 5pm 9pm. 22 childminders were open until 6pm or later. Six childminders state flexible hours or weekend care were available
- In the PVI sector costs ranged from £2.60 £3 per hour. Cost per hour in Knight's Hill ward is one of the least expensive in comparison to other wards

Overall the number of children per place (3.4) is higher than the Lambeth average (2.4). Low vacancy rates may indicate demand for places in the future may increase.
- There are currently no vacancies for 0-2 year olds indicating a gap in provision of 0-2 year old childcare
- Costs are the least expensive across the borough and the uptake of the childcare element of working tax credit is the highest across the borough. However Knight's Hill ward also has a lower than Lambeth average household income, and a large number of lone parents, indicating information should be available to parents about financial incentives to assist them with the costs of childcare
- From 2007 to 2008 there has been an increase in the number of children aged 5-14 years. Analysis of childcare for over 5's is needed to address supply and demand of childcare for this age group



- Over one third of all PVI registered places are for 0-2 year olds. However three quarters of all vacancies in the PVI sector are for 0-2 year old places. This suggests that while there may be an oversupply of 0-2 year old places or the current places available are not meeting parents needs
- Four out of seven PVI providers cater for 0-2 year olds, the other three PVI providers cater for the 2-5 age group
- In the childminder sector all childminders catered for 0-5 age group

- Clapham Town has a sufficient number of childcare places for 0-4 year olds
- Further analysis needs to be made as to whether the high number of vacancies of 0-2 year olds places is due to oversupply of places or that places currently available do not meet the needs of all parents who wish to access them
- The limited opening hours in comparison to other wards may indicate hours are not flexible to meet the needs of parents, particularly those that work full time. Options could be investigated to lengthen opening times, and increase the number of childminders who provide flexible hours and weekend care
- Although Clapham Town ward on average has a high weekly household income, childcare costs are also more than the Lambeth average and may restrict access for some parents. Information to help parents utilise the childcare element of working tax credit may assist parents to access childcare more affordably
- Analysis of childcare for over 5's is needed to address supply and demand of childcare for the 0-14 year age groups



- Over one quarter of all places in the PVI sector are for 0-2 year olds. Likewise one quarter of all vacancies are for 0-2 year old places. Because 0-2 year olds make up about two thirds of all 0-4 year olds in this ward the demand for places for 0-2 year olds is likely to increase. Vacancies for 0-2 year olds suggest that although there is demand, places available are not currently meeting needs of parents
- In the PVI sector the earliest opening time was 8.20 am, with three providers opening at 9am. The latest closing time was 6pm. Only one provider was open until 6pm
- The earliest opening times for childminders was 7.30am, with all childminders opening between 7.30 am 9am. Closing times varied between 5pm 7pm. Half of the childminders close by 6pm. One childminder stated weekend care was available
- The opening times of the PVI and childminder sectors may be a contributing factor to vacancies in this sector, particularly in consideration that there is a large number of full time employee, indicating parents may need childcare available for longer periods over the day



- Two thirds of all places in the PVI sector are for 0-2's and nearly half of all vacancies are for 0-2 year old places. This may indicate there is an oversupply of places for 0-2's or that the places available are currently not meeting the needs of all parents who need to access them
- Of the data available, all PVI providers cater for the 0-2 age group, and all childminders cater for the 0-2 age group

Parents on low incomes, such as the large number of lone parent families may benefit from an increased understanding of the childcare element of working tax credit to assist them to access affordable childcare. 

- The number of children 0-4 years has increased from 777 in 2007 to 796 in 2008
- The number of 5-9 year olds remains the same (471) from 2007 to 2008 and there is a decrease in 10-14 year olds from 372 in 2007 to 357 in 2008. This indicates demand for childcare for 5-14 year olds may not be as high as in other wards





- One third of all places in the PVI sector are for 0-2 year olds and one quarter of all vacancies are for 0-2 year old places. This indicates a high demand for 0-2 year old places in this ward



Streatham South has the second lowest average per hour cost for childminders across the borough

- The children per place ratio in Streatham South ward indicates there are sufficient places for 0-4 year olds
- An increase in vacancy rates indicates current places available may not be meeting the needs of parents, particularly for 0-2 year olds. Further analysis of parents needs should be undertaken to better understand demand for childcare, and reduce vacancy rates in this ward
- The low vacancy rates indicate there may be an increased demand for places in the future
- The take up rate of the childcare element of working tax credit is the lowest across the borough. Information to help parents utilise the childcare element of working tax credit may assist parents to access childcare more affordably, particularly in the PVI sector where costs are more expensive than some other wards. It is also important that the information is accessible to parents with diverse cultural needs given the large numbers of residents from an Indian background residing in this ward
- The large number of childminders in this ward suggest investigation of ways to introduce more flexible working times could assist parents to access childcare that suits their needs, particularly for the large number of parents who work part time

| PVI Provider (Private, Voluntary or Independent) Provider | Childcare in a group setting that is provided by a private, voluntary or independent childcare provider. For the purpose of this report, PVI providers also include Children's Centres |
| Registered Provision | Provision that operates Daycare for more than two hours a day for children aged 0-8 must be registered with OfSTED (q.v.) and is subject to regular inspections. |
| Sessional Daycare | Daycare for children under the age of 8 for 'sessions' that are less than a continuous period of four hours in any day. For example, Playgroups. |
| Setting | The premises in which childcare is delivered. May range from the provider's own home (e.g. Childminder), or in Schools or Children's Centres |
| Voluntary sector | An organisation or service that is run through voluntary support and funding and is 'not for profit' |
| Ward | A division of a City or Town, especially an electoral district, for administrative and representative purposes. It is useful to use ward Divisions for statistical analysis and comparison within the City, although Wards can vary in size and the boundaries are subject to periodic changes |
