Ward Summary



Ward summary

The Childcare Sufficiency Assessment (CSA) examines the demand for, and supply of, childcare in Lambeth. The research analysed views of childcare providers, parents and people with parental responsibility, and employers.

This document draws its information from the main report.

Note: **Rank** is when compared to other Lambeth wards (1 is highest-21 is lowest). There are **21** wards in Lambeth.

Bishop's

- 12.4% of population on key out of work benefits compared to 15.1% in Lambeth (May 2010)
- 36.5% of all children are living in workless households compared to 35.5% in Lambeth (Aug 2008).
- 1,405 children aged 0 to 14 (Rank 21), 475 children aged 0 to 4 (Rank 21) and 930 children aged 5 to 14 (Rank 20) living in this ward.
